

he Bombay High Court Thursday questioned the state government why it cannot adopt a policy to ensure political leaders do not put photographs of their faces on illegal hoardings. The bench reiterated it wanted to see the report on non-compliance of court orders regarding illegal hoardings and banners being put up across the state by political parties. The court questioned the state after its counsel submitted that there were difficulties in monitoring illegal hoardings and the government was trying to find alternative ways instead of a complete ban on hoardings or banners, including specific regularised

The bench reiterated that it wanted to see the report on noncompliance of court orders regarding illegal hoardings and banners being put up across the state by political parties. Terming it an "alarming situation", the bench on June 16 had asked the Maharashtra government to give an independent report within six weeks on steps taken against non-compliance of orders on illegal banners, hoardings, posters, arches and advertisements. The court had also asked the state government, civic bodies and petitioners to suggest what deterrent actions can be taken and directions

isle is an Indian teacher from Maharashtra who has been acknowledged for his outstanding contribution towards education but locals have objected to his status. He is the winner of the \$1 million annual Global Teacher Prize 2020 which was announced on 3 December 2020. The Global Teacher Prize, which has been referred to by journalists as the Nobel Prize for teaching, highlights and celebrates the profession while giving greater recognition to the work of teachers all over the world. Disale said in his winning speech that he would share with his nine fellow finalists half of the prize money, meaning they would receive \$55,000 each. He also works with the World Bank as Advisor for their educational programs.

Disale is well known for his innovative teaching works, including

demonstrating scientific experiments from the science lab built by him and adding QR codes to primary category books so that his students can get links to audio poems, video lectures, assignments and stories. His idea of incorporating QR codes into textbooks was adopted by the National Council of Educational Research and Training. In his village, he also campaigned to eliminate adolescent marriages and encourage the education of girls.

Disale guruji resigned chance to recover salary to get suspension from solapur zilla parishad school Published 24 hours ago on July 14, 2022. Disale was frustrated and his resignation had lot of repercussions. The case was mentioned in the investigation report that the assistant teacher

Illegal hoardings and banners across state is an alarming situation -Bombay HC

passed against members of political parties erecting such structures such that it will "nip the menace of illegal hoardings in its bud".

A division bench of Chief Justice Dipankar Datta and Justice Makarand S Karnik has been hearing pleas, including a contempt plea initiated by the High Court on its own, claiming non-compliance of its 2017 orders to pull down illegal hoardings and that political parties are flouting the order every day and defacing public places. On Thursday, Additional Government Pleader Bhupesh V Samant for the state sought more time to file a reply, after which the bench sought to know if there was any improvement or positive changes after the last order and how the government proposed to deal with the issue. Samant responded that instead of totally forbidding hoardings, the government can regularise them only in specific areas similar to parking

"Why do not you adopt a policy decision that political leaders do not have to show their faces on banners?" CJ Datta orally remarked. Samant responded that all those who put up hoardings are not from the government or political class and some of them may think that their freedom of speech is being suppressed in a democratic setup.

The court jibed, "Where is the question of right? Is it a right for people to have their faces shown on banners/hoardings? They will not be putting it up without the encouragement of leaders. Let at least one leader say we don't want these hoardings. How can you allow it? Do you mean to say the government is not ready for effective implementation?"

Ranjitsinh Disley who works at a school in Paritewadi (Ta Madha) of Solapur Zilla Parishad has been continuously absent for three years from 2017 to 2020. Even after 34 months of absence, the salary was taken by deceiving the government.

The Solapur district administration has gotten serious and is going to demand repayment of the full amount. The documents necessary for the leave have not been delivered. In January 2022, Ranjitsinh Disley is going to come to Solapur Zilla Parishad to do her PhD and has requested 6 months leave for that. The then Minister of Education, Varsha Gaikwad, took notice and approved the leave request. But the district administration had requested to submit all doctoral documents for the vacation.

Head of Education Kiran Lohar informed that Global Prize Laureate Ranjitsinh Disley has not submitted any proof of PhD admission so far. Ranjitsinh Disley received the American Fulbright Scholarship. In this regard, not a single solid proof has been given to the education department of Solapur district administration. Disley did not give details to the education department about receiving the global award.

Disley Guruji was appointed Assistant Professor at Solapur Zilla Parishad in 2008. His first post was at Paritewadi. In 2017, he was delegated to DIET at Jamapur in Malshiras. The period of deputation was from 2017 to 2020. However, at that time, he was not appearing in Diet Institute, Gharapur. After receiving an international award in 2020, he was again appointed to Paritewadi. A pupil of Kadam Vasti in Paritewadi used to come to school here. But since no teacher came to this school, the citizens of Kadam Vasti often complained that there was no teacher at the school.

Resigned, but action is inevitable, Disley will receive 34 months salary from Guruji. Disley Guruji, who was appointed to the Zilla Parishad school at Paritewadi in Madha taluka, has once again come under discussion due to his resignation. Global award winning teacher Ranjit Singh Disley has recently given a pre-resignation notice. Education Officer Kiran Lohar has prepared a report after inquiring about Disley Guruji. According to the report, Ranjit Singh Disley gave his resignation notice on July 7 before taking action. His resignation will be approved on August 8 and he will be fired. However, the district administration will take action against Disley Guruji. He has

been absent from work for almost 34 months. All these salaries will be recovered by the Solapur district administration. District Primary Education Officer Kiran Lohar informed about this.

Zilla Parishad's Primary Education Officer Kiran Lohar informed that the salary raised during this period will be recovered as he was absent for 34 months while on deputation to DIET. What did Ranjit Singh Disley, a sub-teacher working in Solapur Zilla Parishad, do between 2017 and 2020? This has been thoroughly investigated. A file has been created in this regard. The inquiry report has been submitted to the Zilla Parishad CEOs in confidence.

Global teacher Ranjit Singh Disley was awarded a scholarship by the Full Bright Institute of America to do his PhD. Accordingly, in August p. Disley Guruji was going to America to do HD. He had come to the Zilla Parishad in January to seek permission. Chief Executive Officer Dilip Swamy had advised him to meet Education Officer Kiran Lohar. At that time, the education officer Lohar had stated the rules for sanctioning leave.

Apply for leave to the Group Education Officer, from where he will come to me, without going directly to Zilla Parishad Chief Executive Dilip Swamy or coming to me, it is not a rule, he said. It was also said that the university in which the PhD will be done, submit all the information permitted by the American University to do the PhD, then the leave application will be approved. The group education officer was advised to apply for leave with all the documents.

The news that Ranjit Singh Disley was denied leave by the education department had created a stir in the state. The then Education Minister Varsha Gaikwad had ordered the Zilla Parishad administration to grant immediate leave to Disley Guruji. Disley had made serious allegations against his superiors in front of the media. Taking note of this, Zilla Parishad Chief Executive Officer Dilip Swamy had ordered an inquiry.

Doubts were raised about the degree obtained by Disley Guruji after the leave case and the work done while on deputation to the district training institute for the next three years. The then education officer Sanjay Rathore had earlier prepared an inquiry report. After inquiring about it, the present Education Officer Kiran Lohar prepared a report and submitted it to the Zilla Parishad CEO. Giving notice of resignation before taking action will not stop the action; he informed that the government will recover all the salary given to them.

picejet failed to establish safe, efficient and air services and that was evident when a number of flights returned to the base after observing a technical snag in the air. Fall in standard due to poor internal safety oversight and failure to carry out aircraft maintenance.

Moreover, failure to pay vendors on time led to a shortage of spares according to Financial assessment 2021. In implicit warning, the DGCA says airlines to operate commercial flights valid till May 2023.

A review of recent incidents shows airlines either forced to turnback aircraft on many occasions, or continue flight with degraded safety margins. Again, mass casual leave applied by the pilots looking for greener pastures in Air India paralysed regular services and upset passenger movement in a fixed time and as per the schedule. A bonafide passenger boards the plane only under the impression that the flight is fully airworthy to take the passenger to the intended destination and they are in safe hands. From what's happening in the recent past with the Spice Jet it is indeed quite unfortunate and despicable and every passenger is bound to feel that his precious life is at stake.

Therefore there can be no leniency shown either by DGCA or the ministry towards the flight operators who it may! The authorities should seriously think about the precious lives of the passengers twice over before just admonishing them or fining them to pay an amount of money. It is a matter of disgrace for the paid travellers.

Shinde govt says on renaming Aurangabad "The name of Sambhajinagar is already there"

aharashtra Chief Minister Eknath Shinde on Friday said the previous Maha Vikas Aghadi (MVA) government's decision to rename Aurangabad city when it had been reduced to a minority was illegal, and it will be ratified again in the next cabinet meeting.

The Uddhav Thackeray-led MVA government announced the renaming of Aurangabad in central Maharashtra as 'Sambhajinagar' — after Chhatrapati Shivaji Maharaj's elder son Chhatrapati Sambhaji — in its last cabinet meeting on June 29, hours before Thackeray resigned.

Shinde was sworn in as chief minister with the BJP's support the next day, having split the Thackeray-led Shiv Sena.

"The MVA government took the decision to rename Aurangabad as Sambhajinagar in its last cabinet meeting when it had been reduced to a minority government. Holding a cabinet meeting (in such a situation) was illegal," the chief minister claimed at an event



here.

Sena founder Bal Thackeray had announced that Aurangabad — which derives its name from Mughal emperor Aurangzeb — will be renamed as Sambhajinagar several decades ago, Shinde said. "The name Sambhajinagar is already there, we will ratify it in the next cabinet meeting," he said, adding that this will make the decision legally safe.

He also said that he rebelled against the Shiv Sena leadership to save the party and its workers. "We got nothing politically despite having our chief minister in the three-party dispensation.

We finished fourth in nagar panchayat elections," said Shinde, who was a senior minister in the Sena-NCP-Congress government headed by Thackeray. People of the state accepted his decision to rebel as it was in the party's interests, Shinde claimed. Meanwhile, Sena leader from Aurangabad and former MP Chandrakant Khaire, who has stayed loyal to Thackeray, warned that party workers would launch an agitation if the name of the city was not changed within a month.

The Shinde-led government stayed the renaming which was an insult to Chhatrapati Sambhaji, he said, speaking to PTI. "Why the BJP didn't carry out renaming when it was in power from 2014-19? The BJPled central government did not even pass the proposal to name the Aurangabad airport (for Chhatrapati Sambhaji)," said, demanding that the airport too be named within a month. Aurangabad district Shiv Sena chief Ambadas Danve too said that the "staying" of the decision to rename the city was "unacceptable."

Shiv Sena party is not expecting Murmu to visit 'Matoshree' in return while supporting as candidate

he Shiv Sena which has declared support for the National Democratic Alliance's presidential candidate Droupadi Murmu did not expect her to visit Uddhav Thackeray's residence 'Matoshree' here, the party said on Thursday.

Murmu arrived in Mumbai on Thursday evening to meet the MPs and MLAs of the BJP as well as MLAs of the rebel Shiv Sena faction led by Maharashtra Chief Minister Eknath Shinde.

Though Sena chief Thackeray too has declared support for her, she was not slated to meet him. Sena MP Vinayak Raut had said earlier in the day that party MPs and MLAs (from Thackeray's faction) would not be attending a meeting that Murmu was to address.

Asked about this, MP and Thackeray's confidante Sanjay Raut said the party's support of Murmu was not political. "We did not extend our support to her for visiting Matoshree. This is not political support, but it reflects our sentiments towards tribal communities," he said.



In the past, the Shiv Sena had supported Pratibha Patil and Pranab Mukherjee in the 2007 and 2012 presidential elections even though it was part of the BJP-led NDA then, Raut said. Patil and Mukherjee, both Congress leaders, had visited Matoshree, he said, adding that this time the party broke ranks again (with allies Congress and NCP).

As for the first time a tribal woman leader was set to occupy the highest office in the country, many Sena legislators who have tribal roots or work in tribal areas felt that the party should back Murmu, Raut added. The Opposition has fielded Yashwant Sinha against Murmu for the July 18 election.

HC grants bail to 72-year-old alleged Naxal operative accused in 2019 Gadchiroli blast case

he Bombay High Court on Friday granted bail to Sathyanarayana Rani, a 72-year-old alleged Naxal operative, who is accused in the 2019 Gadchiroli blast case.

Fifteen security personnel of the Quick Response Team (QRT) and one civilian were killed in an explosion on May 1, 2019 in Gadchiroli in Maharashtra's Vidarbha region.

A division bench of Justices Revati Mohite Dere and V G Bisht granted bail to Sathyanarayana. A detailed order with reasons and conditions imposed would be made available later.

Sathyanarayana is currently lodged in the Arthur Road prison in Mumbai. His late wife Niramala Uppuganti was also named as an accused in the case. The duo was arrested in 2019. Uppuganti died of cancer in April this year.

Jhanvi Kukreja murder: "Can't be released as circumstances point to his guilt, says HC"

new year brings a chance to create dreams and is like a chapter waiting to be written, but the new year of 2021 landed a young man into a quagmire, the Bombay High Court noted while refusing bail to Shree Jogdhankar, an accused in the murder of Jhanvi Kukreja, who was found dead in a building in Khar on New Year's Eve last year.

A single bench of Justice Bharati Dangre had on July 7 rejected Jogdhankar's bail plea. A copy of the detailed order assigning reasons was made available on Friday.

The court in its order said that the circumstances relied upon by the prosecution connects Jogdhankar (23) with the crime and that they "prima facie point to his quilt".

Kukreja (19) was found dead in the staircase of a residential building in suburban Khar on January 1, 2021. Her friends Jogdhankar and Diya Padalkar were later arrested by the police.

"A new year brings a chance to create dreams; A new year stands before us, like a chapter in a book, waiting to be written. However, the new year of 2021 landed the applicant – Shree Jogdhankar, a young boy of 21 years, into a quagmire," Justice Dangre said.

"He (Jogdhankar) is accused of murdering his close friend Jhanvi and in this act, it is alleged that he was assisted by another of his close friend Diya," the judge added.

The court order noted that the three youngsters (Kukreja, Jogdhankar and Padalkar) were to usher the new year with a big bang celebration with their friends.

NCP slams CM Shinde over clearances given to Mumbai-Ahmedabad bullet train project

he NCP on Friday criticised Maharashtra Chief Minister Eknath Shinde over the clearances given to the Ahmedabad-Mumbai bullet train project, saying he should focus more on issues concerning the state.

Deputy Chief Minister Devendra Fadnavis on Thursday said that Shinde had given all the clearances to expedite the project, which the previous Maha Vikas Aghadi government, of the Shiv Sena, NCP and Congress, had put on the back burner.

The NCP's chief spokesperson Mahesh Tapase said, "The illegal government of Eknath Shinde has expeditiously given clearances to the bullet train project".



Thane district, which Shinde represents, is the most urbanised district in the state, with the largest number or municipal corporations, he said.

"Shinde should focus more on issues concerning the state and Thane district to resolve the urban problems it faces, instead of bowing before neighbouring Gujarat," Tapase alleged. The estimated cost of the Mumbai-Ahmedabad bullet train project is Rs 1,10,000 crore, of which Rs 88,000 crore are being funded by the Japan International Cooperation Agency (JICA). Over 70 per cent land required in Maharashtra for the project has been acquired in Thane and Palghar districts.

Alt news co-founder Zubair has been granted bailby the Delhi court says "dissent necessary for healthy democracy"

elhi's Patiala House Court on Friday while granting bail to Alt News co-founder Mohammed Zubair in a case related to an allegedly objectionable tweet, observed that "the voice of dissent is necessary for a healthy democracy.

Therefore, merely for criticism of any political parties, it is not justified to invoke section 153A and 295A of IPC". Additional Sessions Judge Devender Kumar Jangla said, "Democracy is a government by the people via open discussion.

Democracy can neither work nor prosper unless people go out to share their views. Article 19(1)(a) of the Constitution of India gives freedom of speech and expression to its citizen. Undoubtedly free speech is the proper foundation of a democratic society.

A free exchange of ideas, dissemination of information without restraint, dissemination



of knowledge, airing of differing viewpoints, debating and forming one's own views and expressing them, are the basic indicator of a free society, the judge said. This freedom alone makes it possible for people to formulate their own views and opinions on a proper basis and to exercise their social, economic and political rights in a free society in an informed manner.

The court noted that the present case relates to the tweet of an image along with

two words "Before 2014" and "After 2014". It is stated by Delhi Police counsel for the state that the image tagged with a tweet has hurt the sentiments of the Hindu community and is sufficient to incite feelings of hatred among people which is punishable under Sections 153A and 295A Indian Penal Code(IPC).

It also noted the Special Additional Public Prosecutor for the state has also pointed out that the word "Before 2014" and "After 2014" is pointing toward the ruling political party to show the state of affairs in a prejudicial manner.

Monsoon session: KCR speaks to Opposition leaders

Two days before the announcement of the name of her presidential candidate, she went to my son Gaurav Garg's in-laws' house in Rairangpur, and while feeding the cows, asked the operators there to pray for me. Perhaps she had some hope and possibility that her name might be announced. Gaumata heard the call of her heart.

Today, the fire of communal hatred is being deliberately fuelled in the country. All kinds of crises are being created, it is a great irony of democracy that heads are counted here, not brains. Our democracy is suffering because of this, it has been suffering. More heads are coming, not the brain. There are more masks of caste, religion and class, less faces of humanity. By deceitful use of intelligence, they create a maze of equations, from which Abhimanyu did not learn to get out. In fact, the people who drive democracy need such training so that a new definition of democracy can be rewritten.

This vision made Draupadi Murmu's role not only important but decisive as well. Therefore, by placing this burden on Draupadi Murmu, the country wants to be sure that the rule of the constitution is from Arunachal Pradesh to the President. It will run uninterrupted till Bengal and the country's borders will be completely safe because the President is the supreme commander of the armies. This will be the first time in the history of India that the dignity of the office will be increased by placing a powerful tribal woman as the President.

Twitter following outage



witter was hit by a significant outage that lasted for around 40 minutes worldwide on Thursday evening. Many users reported seeing "over capacity' and "this page is unavailable" error messages. Some users are still facing this glitch on the micro-blogging site. However, Twitter support took to their official Twitter handle and stated that they are trying to fix the problem in the interim. They wrote, "Some of you are having issues accessing Twitter and we're working to get it back up and running for everyone. Thanks for sticking with us.

According to Reuters, the outage affected nearly 2,000 users as of 9 am ET, down from the peak of 50,000 incidents an hour earlier. Reuters further mentioned that this data is available on the outage tracking website Downdetector.com. Notably, the incident comes shortly after Twitter requested a Delaware court to force Tesla CEO Elon Musk to complete the purchase of the firm and sued . Musk for breaching his agreement to buy the company.

Twitter had suffered another widespread outage in February that it blamed on a software glitch. In the previous year, other social media firms have also experienced outages, with Meta Platforms' WhatsApp, Instagram, and Messenger being unavailable to billions of users for about six hours in October.

Windows 11 features, which does mean they might not ship, reported The Verge. After bringing back the Weather widget to the taskbar in Windows 11 recently, Microsoft is now testing adding notification badges.

The notifications are designed for content like breaking news and look similar to the badges you'd find in the Action Center on the righthand side of the taskbar. Apart from that, Windows Insiders in the Dev Channel will also be able to start testing a new Camera app for Windows 11. Apple iPad with OLED screen reportedly set to release in 2024

t is believed that Apple is working on an iPad with OLED screens. Realme Pad X set to launch in India soon

he Realme Pad X. which launched in China in May, will soon debut in India as the event page for the tablet has been released on the company's Indian website. As per GSM Arena, the Pad X is sold in three colours in China, with blue being one of them, which is confirmed for the Indian market. Realme will also sell the stylus in India, but it is unclear if it will come bundled with the tablet or will be sold separately. Chances are it will be the latter. Realme has also launched the keyboard



accessory for the Pad X in China, but the company has yet to tease it in India. We expect the Chinese brand to bring this to its biggest market.

Assuming the Indian model is the same as the one available in China, it will come with the Snapdragon 695 SoC. 11-inch screen, and an 8,340 mAh battery with 33W charging, as per GSM Arena. For photography, there will be a 13 megapixels rear camera and an 8 megapixels front camera. The Pad X in China runs Realme UI 3.0 and has two storage options: 4G/64GB and 6GB/128GB. It also features a microSD card slot for storage expansion up to 512GB and guad-speaker packages with support for Dolby Atmos and Hi-Res Audio.

New GDDR6 DRAM for GPUs introduced **by Samsung**

outh Korean tech conglomerate Samsung Electronics has revealed that it has started sampling the industry's first 16-gigabit Graphics Double Data Rate 6 DRAM with 24 Gbps processing speeds. According to GSM Arena, it is built on the 10 nm EUV process technology and is expected to boost the performance of laptop and console GPUs. The new DRAM chip will offer universal compatibility so it can have broad market adoption among graphics unit manufacturers. Engineers at Suwon, Samsung HQ, developed an innovative circuit design and a highly advanced insulating material called High-K Metal Gate or HKMG to minimize data leakage. This means the GDDR6 DRAM will provide 30 per cent higher speeds than the predecessor.

The company's new GDRR6 lineup will also offer some lowpower options for extended battery life on laptops. It utilizes dynamic voltage switching technology that adapts to the performance requirements. The company will launch versions with 20 Gbps and 16 Gbps processing speeds running at 1.1V instead of the 1.35V industry standard. As per GSM Arena, the company is currently sampling the new platform, meaning it is still being verified in real-life scenarios so it can hit the market in line with GPU platform launches.

irector Gautham Ramachandran's 'Gargi' is a fantastic courtroom drama that shines the light on several important issues plaguing society today, including the often sidelined topic of child sexual abuse and the humiliation that the families of those accused of heinous crimes like rape have to undergo in the society.

A reasonably good understanding of the working of the judicial system in India seems to have enabled director Gautham Ramachandran to come up with a refreshingly fresh script that makes several pertinent points on a number of topics ranging from rape, and child sexual abuse to transgender rights.

Gargi (Sai Pallavi) is a middleclass woman working in a school, who lives with her aged parents and younger sister. With her wedding on the verge of getting fixed, Gargi is concerned about dowry demands being made by the bridegroom's side.

Nevertheless, she is in a happy frame of mind until oneday news breaks out that the cops have arrested a fifth person in a sensational case pertaining to the gang rape of a girl child

Initially, Gargi pays little or no attention to the news but when

her dad doesn't return home that night and she gets to know that he, along with other employees at an apartment complex, has been taken in for questioning by the cops in connection with the gangrape case, her heart skips a beat.

It doesn't take long for her to be informed that her dad, a watchman at the victim's

Kaali Venkat as lawyer Indrans, in particular, is simply outstanding. Indrans's character is just admirable. As a man who has never been in the limelight, he is filled with fear at the prospective outcome of taking up a high-profile case like that of Gargi's dad.

But then, he also has the good sense to override his fears and in fact takes on not just his senior, but the entire bar association, to do what he thinks is right. In short, Kaali as Indrans delivers a thumping performance, stammering his way into the hearts of the audience.

Sudha, who plays the judge, is all class from the moment she appears on the screen. She doesn't ask for respect, her

behaviour commands it. The authority with which she delivers her dialogues makes her character stand out.

Sai Pallavi delivers yet another stunning performance in this film.

As a caring daughter, as a dutiful sister, as a woman who will not desert a loved one who is in trouble, and finally as a responsible citizen who is concerned about truth triumphing, Sai Pallavi scores on all counts.

Gautham scores not only because of the story and the hard-hitting dialogues of the film but also because of the visually powerful scenes that strongly communicate the message he is looking to convey.

Take for instance a scene in which Gargi is shown cleaning dung cakes hurled at her home's compound wall. The scene subtly conveys the message that she has managed to wash away some of the dirt that was hurled at the family.

The climax of the film, strangely though, appears forced and reduces the intensity of the story by a considerable margin. Other than that, the film makes for a gripping watch.
