Mumbai former CP Sanjay Pandey appear before ED for phone tapping case

ormer Mumbai Police Commissioner Sanjay Pandey appeared before the Enforcement Directorate (ED) in Delhi for the second day on Tuesday for questioning in a money laundering case linked to the alleged illegal phone tapping of NSE employees, officials said.

This is the second consecutive day that the retired Indian Police Service (IPS) officer is being questioned by the federal probe agency in this case.

Like Monday, the officer will continue to reply to questions on the business and operations of a firm floated by him for security audit of the National Stock Exchange (NSE) and his statement will be recorded under the Prevention of Money Laundering Act, they said.

Pandey, a 1986-batch officer, retired from service on June 30. Before his four-month stint as Mumbai's commissioner of police, he served as the acting Maharashtra director general of police.

CBI had said on Monday that it questioned Pandey and another former Mumbai police commissioner Param Bir Singh in connection with the Rs 100

crore extortion allegations against former minister Anil Deshmukh.

Pandey is facing two ED and Central Bureau of Investigation FIRs — illegal interception of phones of NSE employees by iSec Services Private Ltd, a company founded by him, and violation of Securities and Exchange Board of India guidelines in conducting NSE's system audit.

He has been questioned early this month by the ED in the alleged co-location scam at the

Restriction impose on Mumbai based Raigad Sahakari **Bank by RBI**

he Reserve Bank of India has issued several directions to Raigad Sahakari Bank, Mumbai, including an upper limit on withdrawal by depositors.

A sum not exceeding Rs 15,000 of the total balance across all savings bank or current accounts or any other account of a depositor, may be allowed to be withdrawn, the central bank said in a statement on Monday.

Reportedly, the Mumbaibased bank is going through financial stress.

Further, from the close of business on Monday, the bank shall not, without prior approval of the RBI, grant or renew any loans and advances, make any investment, incur any liability including borrowal of funds and acceptance of fresh deposits, disburse or agree to disburse any payment whether in the discharge of its liabilities and obligations or otherwise, enter into any compromise or arrangement and sell, transfer or otherwise dispose of any of its properties or assets.

However, it clarified that these directions by the RBI should not be construed as a cancellation of a banking license. "The bank will continue to undertake banking business with restrictions till its financial position improves. The Reserve Bank may consider modifications of these directions depending upon circumstances," it added.

Sharad Pawar breaking Shiv Sena, alleges ex-Maha minister Kadam



ormer Maharashtra minister Ramdas Kadam on Tuesday alleged that NCP chief Sharad Pawar was breaking the Shiv Sena and he had given a proof of this to Sena president Uddhav Thackeray.

The Sena was "systematically weakened" by Pawar. Some MLAs had expressed concern over it but Thackeray was not ready to part ways with Pawar. Kadam claimed while talking to a TV channel.

However, NCP's chief spokesperson Mahesh Tapase dismissed Kadam's remarks, claiming the BJP was behind the split in the Shiv Sena and that the rebel leaders were trying to divert the attention from it by targeting Pawar.

On Monday, Kadam in a letter to Thackeray tendered his resignation as "Shiv Sena leader"

Shiv Sena president and former state chief minister Uddhav Thackeray on Monday evening announced that Kadam was sacked for indulging in "anti-party" activities.

Kadam was later "reinstated" as leader by the rebel Sena faction led by Chief Minister Eknath Shinde.

The Thackeray-led Maha Vikas Aghadi (MVA) government, comprising the Sena, NCP and Congress, collapsed last month after Shinde and 39 other Sena MLAs revolted against the party.

Kadam on Tuesday said, "I have given ample proof to Uddhavji about how NCP chief Sharad Pawar is breaking the Shiv Sena." He (Pawar) has given good posts to members of the Kunabi community (in Konkan) and also strengthened them with funds, Kadam claimed.

"The chief minister was ours, funds came from government coffers, but the party (Sena) was systematically weakened by Pawar. Many MLAs expressed similar concerns before you (Uddhav Thackeray), but you were not ready to leave Pawar,' he further claimed.

Had (Sena founder) Balasaheb Thackeray been alive today, would he have allowed Uddhav Thackeray to become chief minister with the support of the NCP and Congress? Kadam wondered.

Maha CM Eknath Shine on a review of disqualification petition against 16 Mps

mid an impending split in the Shiv Sena Parliamentary Party, Maharashtra Chief Minister Eknath Shinde is in the national capital to review on Tuesday the legal strategy on the disqualification petition against 16 MLAs supporting him filed by the Uddhav Thackeray camp.

The plea will come up for hearing in the apex Court on Wednesday. Shinde is also likely to meet the breakaway faction of the Shiv Sena MPs here on Tuesday, a day after he was anointed as the 'chief leader' of the party at the national executive meeting.

I will definitely meet MPs. Why only 14, we have 18 members in the Lok Sabha. Shinde said when asked by reporters about his meeting with the breakaway group of Shiv Sena MPs in the national capital.

Asked about his visit to Delhi, the chief minister said he was here for discussions with the legal team on the disqualification petition against 16 MLAs supporting him filed by the Uddhay Thackeray camp.

SC has issued notice to NIA on seeking bail to P Varavara Rao

he Supreme Court on Tuesday issued notice to the National Investigation Authority (NIA) on a plea filed by activist and poet Dr P Varavara Rao, an accused in the 2018 Bhima Koregaon violence case, seeking bail on medical arounds.

A bench of Justices UU Lalit, S Ravindra Bhat and Sudhanshu Dhulia said that its order of extending the interim bail granted on medical grounds Rao will continue.

The apex court

posted the matter for final hearing now on August 10. "Interim protection granted earlier on medical grounds extended till further orders," said the bench in its order. Earlier, the top court had extended Rao's

Solicitor General Tushar Mehta appeared for NIA while senior advocate Anand Grover represented Rao. Rao has challenged an April 13 judgment of the Bombay High Court which had rejected his

interim bail till further orders.

The High Court, however, had extended the time for Rao to surrender before the Taloja prison authorities by three months, to enable him to undergo cataract surgery. It had also rejected Rao's application to stay in Hyderabad instead of Mumbai, while out on bail.

In his appeal, Rao has said that he has undergone over two years of incarceration as an under-trial, and is currently enlarged on bail on medical grounds by the Bombay High Court. Any further

incarceration would ring the death knell for him as advancing age and deteriorating health are a fatal combination," stated the plea.

Rao has challenged the High Court order as he was not granted an extension of bail, despite his advanced age and precarious and deteriorating health condition, and has been denied the prayer to shift to

He was arrested on August 28, 2018, from his home in Hyderabad and is an under-trial in the Bhima Koregaon case for which FIR was lodged by the Pune Police at Vishrambagh Police Station on January 8, 2018, under various sections of IPC and several provisions of Unlawful Activities (Prevention) Act (UAPA).

Rao, who was initially put under house arrest pursuant to the order of the top court, was ultimately taken into police custody on November 17, 2018 and later shifted to Taloja Jail.

Rao in his appeal said that in the totality of circumstances, the trial will take not less than ten years. In fact, one of the accused in the case, Father Stan Swamy, who was suffering from similar ailments as the Petitioner, passed away even before the trial could start, his appeal added. In February 2021, the Bombay High Court granted him interim bail on medical grounds and he was released from jail on March 6,



"It is pertinent to note that most of the members of the above-mentioned committee had extended their support to the three draconian farm laws which were later withdrawn by the Government. Also, some of them are active members of the ruling political party. Therefore, one cannot expect them to do justice to the cause of farmers," Chadha wrote.

The government on Monday formed a committee on Minimum Support Price (MSP), eight months after it promised to set up such a panel while withdrawing the three contentious farm laws. Former agriculture secretary Sanjay Agrawal will be the chairman of the committee.





ne world famous onemonth long Shravani Mela of Baidyanath Dham starts with the drizzle of Pavas (Rainy) season. The influx of saffron-dressed Kanwariyas, pouring water into an embellished Kanwar from Sultanganj's north-vahini Ganga, walk barefoot on a 111 km long invincible path with the deafening sound of "Bol Bam" towards the Baba Baidyanath Mandir in Deoghar. The chant of "Bol-Bam Ka Nara Hai, Baba Ek Sahara Hai' all the way fills this rugged

path with devotion to Shiva. Baidvanath Dham is one of the great pilgrimage sites of Bharatvarsha. One of the twelve Jyotirlingas of Bhagwan Shiva, "Kamana Linga" is located here. This Thirthsthan is famous not only in India, but all over the world. That is why every year lakhs of devotees from other countries like Burma, Bhutan, Nepal, Mauritius, Tibet, Bangladesh, Fiji, Pakistan etc come here to bow before Shiva. Shiva devotees fill water from the holy Ganges at Sultangani and travel to Baidyanath Dham on foot with a Kanwar on their shoulders and offer water to Baba Bholenath. As per mythological legends this Holy spiritual land has its own special importance since the Vedic times.

According to Shiva Puran, Sati sacrificed her life by jumping into the Yagyakund after her father Daksha Prajapati had humiliated her II Purvottare Prajawalika Nidhane, Sada Vasantam Girija Sametam II II Surasuraradhita Padyapadmam, Sri Baidyanatham Tamaham Namami II

husband Shiva. Enraged by the death of Sati, Bhagwan Shiva carried her body on his shoulder and started performing the Tandav Nritya. The yagya was destroyed and there was a catastrophe all around. Then on the advice of the Devtas, Bhagwan Vishnu sent his Sudarshan Chakra to cut off the body into parts so that Shiva's anger could be controlled. The limbs of Sati started falling off, which fell at total 52 places. The place, where the Hritpind i.e. heart part of Sati's body fell in Baidyanath Dham, was named "Hardyapeeth". It is also known as "Chittabhoomi" because of the cremation of the heart of Sati at the said place by

Bhagwan Shiva.
Another legend about
Baidyanath Dham is related to
Mahapandit and ShastraShiromani Lankesh Ravan.
Lankapati was such an ardent
devotee of Bhagwan Shiva that
many times he cut his head
instead of a flower and offered
it at the feet of his deity. Shiva
cured him as Vaidya (Doctor);
hence came to be known as
Baidyanath (Vaidyanath).

According to another mythology, once a thought came to Ravan's mind that he has to travel from the remote

region of Lanka to Kailash, situated at the extreme end of Uttaranchal of Bharat, to see his adoration again and again. So why not convince Bhagwan Shiva and ask him to stay in Lanka so that he can always get the benefit of his darshan. For this purpose, once Ravana did relentless penance in Kailash. While Shiva could not agree, Ravan said that his "Kamna Ling" would be a good substitute. Shiva accepted the offer on the condition that Ravan must not put down the Ling in the way, otherwise it would not proceed from there and that would be the site of the Ling. Ravan accepted Shiva's condition. This decision of Shiva caused a stir among the other Devtas, as it was expected to strengthen the demonic power of the mighty Ravan even more. So they made a move. When Ravan was going to Lanka with the "Kamna Linga" through the sky route, he felt uncontrollable urination at this place called Deoghar. Coming down from the sky, he started having a piss by handing over the Shiva-Linga to Lord Vishnu dressed as Baidyanath shepherd. But this was the illusion of the Lord. Hours passed, but Ravan's piss did not last.

The Shepherd Baidyanath, unable to bear the heavy burden of Shivling, installed it on the Chittabhoomi of Mahasati. After the piss, Ravan tried hard to lift the Shivling; but as per condition, he was not able to do so. Enraged, he pressed the Shivling with his thumb. Later on, Mahadev was named after shepherd Baidyanath and was worshiped by the local devotees. Ravan constructed a well near the Shivling and poured water of all the pilgrimages in it. He constructed a Kund (pool), which is today situated in the form of Shivaganga.

After the return of Ravan to Lanka, Vishwakarma built 21 other grand temples in this huge courtyard apart from Baidyanath Mandir with big stones. These temples are-Annapurna Mandir, Jagjanani Mandir, Parvati Mandir, Kaal Bhairav Mandir, Ganesh Mandir, Brahma Mandir, Sandhya Mandir, Mansa Mandir, Ganga Mandir, Hanuman Mandir, Surya Mandir, Saraswati Mandir, Ram Mandir, Bagala Mandir, Anand Bhairav Mandir, Narmadeshwar Mandir, Gaurishankar Mandir, Kali Mandir, Tara Mandir, Neelkanth Mandir and Laxminarayan Mandir.

The importance of Baidyanath Dham has also mentioned in our scriptures. Glorifying its importance in the Padma Puran, it is said —"Baidyanath Mahalingam,

Bhavarog Hare Shivam". According to Anand Ramayan, once Bhagwan Ramchandraji himself came to Baidyanath Dham after filling water from the Ganges and worshiped Shiva. Since then lakhs of devotees come here every day and get the desired results by worshiping the Kamana Linga. The importance of this month-long Shravani Mela, which takes place in the entire Shravan month, is not only on the national map, but it is also called the longest fair in the world. In any sense, the Shravani Mela of thirty continuous days is no less than the Kumbh Mela at Prayag, Haridwar, Nashik and Ujjain, Ganga Sagar Mela, Vaishno Devi Yatra, and other fairs of South India.

With the deafening slogans of "Bol Bam - Bol Bam" by groups of Shiv Bhakt Kanwariyas constantly moving like the waves of ocean, the spiritual atmosphere is bound everywhere. The devotees walking hundreds of miles get blisters on the feet and suffer pain. But as soon as the Ganges water is offered to Baba, all the pain vanishes and the devotees become self-confessed.

Economic Milestone and Poignant Anniversary

he nationalisation of banks in 1969 was a watershed moment in the history of Indian banking. From July 19 that year, 14 private banks were done with a future in mind and that was indeed a master stroke in Indian banking. Nationalised banks have helped India emerge as one of the largest developing economies, gain self-sufficiency in food grains production, and make significant strides in financial inclusion. This year marks the 53rd anniversary of bank nationalisation, arguably the biggest structural reform introduced in the financial sector during the post-Independence period.

It has become fashionable nowadays to deride the public sector banks and attribute all of their problems to government ownership. But bank nationalisation occurred not as a sudden, arbitrary policy decision by the government of the day but as a culmination of a long-standing popular demand emanating from the various stakeholders of the banking system — the bank employees and officers on the one hand

and the ordinary depositors and small borrowers on the other.

It was in this backdrop that new laws of banking regulation, capital adequacy, licensing and inspection were enacted followed by a phase of liquidation and

amalgamation, which brought down the number of scheduled banks to 71 and non-scheduled banks to 20, by 1967. Despite some growth in deposit mobilisation, several problems persisted. The private owners of the banks were more interested in cornering the finance mobilised through deposits rather than running the banks on sound commercial principles.

In 1969, only the five cities of Bombay, Calcutta, Delhi, Madras and Ahmedabad accounted for 44 per cent of all bank deposits and 60 per cent of total bank credit in the country. It had become clear by the end-1960s that without a structural break in the banking system, the goals of development planning would get undermined. Bank nationalisation aimed to attain three primary objectives. First was to break the nexus between the banks and the big businesses who were disproportionately cornering bank finance for their narrow, selfish ends and rapidly expand the banking network to the unbanked regions, especially rural areas and deliver institutional credit to the farmers, small businesses and other weaker sections of society, many of whom were caught in a vicious trap of usurv.

Second, to ensure the balanced flow of credit to all

the productive sectors, across various regions and social groups of the country. And, third, to provide stability to the banking system by preventing bank failures and speculative activities. The efficacy of bank nationalisation could be seen in

the increase in bank branches brought about by the 22 public sector banks in just five years. The share of agriculture in total credit went up correspondingly thanks to the priority sector lending norms.

Despite later day concerns regarding operational efficiency, customer services, profitability and asset quality, it is commendable that not a single nationalised bank has failed or faced

one of the largest developing economies in the world, becoming self-sufficient in foodgrains production and making significant strides in financial inclusion, including the recent Jan Dhan Yojana, cannot be denied on reasonable grounds.

With state policies shifting towards liberalisation and privatisation in the last three decades and the entry of new private sector banks, the dominance of the public sector banks (PSBs) has been on a decline. In the immediate aftermath of the global financial crisis in 2007-08, which had exposed the dubious financial practices of the private multinational banks, both deposit mobilisation and credit flow of the public sector banks in India had witnessed a phase of higher growth compared to the private sector banks.

With declining corporate profitability after 2011-12, loan defaults became the norm with the private corporations offloading their losses onto the PSBs. This phenomenon was termed as 'riskless capitalism' by a former Governor of the RBI. This was precisely the reason why the private sector could not be trusted to run the banking system. The previous

government and the RBI were also responsible for encouraging reckless lending practices.

PSB mergers, disinvestment or the FRDI Bill are non-solutions, which will further

weaken the PSBs.
What is required is a major coursecorrection. In a major reshuffle,
United Bank of India and Oriental Bank of Commerce

will be merged with Punjab National Bank;

Syndicate Bank will be merged with Canara Bank. But as in the past, the change was not accepted. We must face reality in the best sense of the word and that too in a Centralised Banking System the correction course of merger took place smoothly despite early hiccups causing early jitters to the merger procedure.

The fact that much of the growth of agricultural credit since 2001 has been cornered by "big agri-business farms and corporate houses located in urban and metropolitan centres" goes against the basic credo of nationalisation. Other points in the article highlight the need to expand the rural banking network and instructional credit. That privatisation of nationalised banks is a panacea for all the ills of the banking sector would spell disaster for the rural economy. It would be far more prudent to correct systemic faults that have crept in the sector in the course of the last 50 years than reversing a policy measure that has made financial inclusion a reality. Even a merger to create a few leviathans may prove to be counter productive.

None can dispute the beneficial impact of bank

nationalisation on the Indian economy but let us not forget that everything is transient in its time and place. There are obvious unwanted consequences and developments that call for change now. The recommendations of the Narasimham Committees on banking sector reforms in the 1990s deserve a closer look. The point of non-performing assets, the inherent deficiency of public sector banking in many areas and new issues require a holistic look. Other issues include mergers of banks, the structure of nonbanking financial companies and small- and mediumenterprises, holistic consolidation in banking and industrial structures. Change is of the essence.

Demonetisation exposed the infrastructural inadequacies in the banking system. Banks, to retain profits, started fleecing the customers with high service charges. Banks today are also increasingly facing trust issues with their customers. Today, banks do more non-banking business with hefty commissions. Overall, the infusion of additional capital by the government can temporarily help banks troubled by bad loans to extend loans more confidently without the fear of going bankrupt due to their precarious capital position. But most economic analysts believe that the merger does not really address the root structural causes behind the woes facing state-owned banks in the country.
