ndia on Thursday chose Draupadu Murmu as _15th President; she will succeed incumbent Ram Nath Kovind. Ruling NDA's Droupadi Murmu and Opposition's Yashwant Sinha were pitted against each other in the contest, with votes clearly stacked in favour of Murmu. She will be the first tribal woman to occupy the top constitutional post in the country. Kovind's tenure is ending on July 24 and the new President will take oath on July 25. PM Narendra Modi is hosting a farewell dinner for outgoing President Ram Nath Kovind tomorrow 5.30pm onwards at Hotel Ashoka in Delhi.

"Nation has created history, the daughter of a tribal family coming from a very ordinary house in Odisha, is elected as the President" Said Union Minister Dharmendra Pradhan.

"Not only tribals, but everyone in the country is going to have a sense of pride in having the 1st woman tribal President. I have learnt that all prominent tribal leaders will be coming to Delhi to greet the new likely to be President" said Union Minister Kiren Rijiju on Droupadi Murmu

On the other hand, the Congress president has to spend all her day in the ED office. The Enforcement Directorate (ED) recorded her statement for two hours in the National Herald money laundering case and ended the session for the day on her request as she is recovering from Covid, officials said. Upon reaching the ED's headquarters at around 12.10 p.m., Sonia was interrogated by a team of additional director Monika Sharma. During her interrogation, she was accompanied by her son Rahul Gandhi and daughter Priyanka Gandhi Vadra. A few minutes later, Rahul left the ED's headquarters while Priyanka stayed backed with her mother's medicine box. Sources say that she was asked the same set of questions which were asked to Rahul during his five-day questioning.

Bharatiya Janata Party leader Uma Bharti took to Twitter to warn Congress interim president Sonia Gandhi to stop Congress supporters from protesting over her summons by the Enforcement Directorate (ED) in connection with the National Herald case, or else she said people will not forget that Sonia is of Italian origin and that she does not respect the Indian Constitution and laws.

It was the day of two Presidents, Congress President Sonia and India's President Murmu



ll this started with Subramaniyam Swamy's alleged accusations against Congress President Sonia Gandhi and her Son Rahul Gandhi. Since 2013, Gandhi family has been on radar for alleged corruption charges, and so far nothing has been proven against them. Sonia Gandhi's questioning in the National Herald case today was led by Kuldeep Singh, an Assistant Director at the Enforcement Directorate, who had also questioned Rahul Gandhi. The Associated Journals Limited (AJL) closed printing National Herald in 2008. It was left with no money and owed a debt of ₹90 crore to the Congress. The debt was a sum of interest- free loans extended by the Congress to The Associated Journals Limited (AJL) from time to time so that the newspaper could pay its employees and continue its operations. The allegation here was that the Gandhis had no real interest in the newspaper, and they were actually eying AJL's real assets.

In November 2010, Gandhi family floated a company called Young Indian and bought the outstanding loan of ₹90 crore from AICC by merely paying ₹50 lakh. The debt that The Associated Journals Limited (AJL) owed to the Congress now stood transferred to Young Indian. A month later, in December 2010, The Associated Journals Limited (AJL) expanded its equity pool and allotted a large chunk of shares to Young Indian, making it a majority shareholder. Young Indian, too, had no funds. To acquire The Associated Journals Limited (AJL), it borrowed ₹1 crore from a Kolkata-based company called Dotex. Of this, ₹50 lakh was paid to the Congress to purchase the ₹90 crore debts.

In this above mentioned issue Sonia Gandhi, 75, was questioned for nearly three hours and was allowed to leave during lunchtime. The Congress president, who had missed summons in the past citing Covid, had appeared before Enforcement Directorate. Perhaps the day was closed wrong; on the one hand India was celebrating its new woman President Murmu, the Congress President was called for scrutiny. Rahul Gandhi was questioned for over 40 hours across five days. But keeping the Congress president's health in mind, the Enforcement Directorate wrapped up her questioning far sooner. There is no new summons yet.

The Enforcement Directorate claims Rahul Gandhi's questioning took more time because his answers "did not match". After each round of questioning, when he was asked to sign off on the typed transcript, the Congress MP "improvised some answers", claimed sources. Rahul Gandhi and the Congress, however, accuse the agency of dragging out his questioning deliberately, to harass him.

The Enforcement Directorate says the Young Indian company also took over ₹ 800 crore in assets of AJL. According to the Income Tax department, this should be considered an asset of the shareholders of Young Indian -- Sonia Gandhi and Rahul Gandhi, for which they should pay tax. The Congress says the assets of AJL went to Young Indian, a non-profit, and so the shareholders could not make any money from the assets since that is not allowed under the law. To which, the Enforcement Directorate says the Young Indian claims to be a nonprofit but has not done any charity work.

Sonia Gandhi's questioning revolved around personal details of her shareholding and taxes and the links of Associated Journal to Young Indian, say sources. She was also asked about the links of the Congress party with the companies. Sonia boldly faced ED; she calmly answered whatever was asked to her. Her conduct was graceful. On the other hand, Mrs Murmu was very much confident of winning presidential elections. It was the day of contrast; one woman is going to be India's president and on the other hand India's national party Congress's president was asked to appear for investigations.

Netflix documented the National Herald case; it would run to 12 seasons of 20 episodes each. The action-packed series would span almost a century, beginning in the era of India's freedom struggle and traversing through high courts and the Supreme Court, and various government offices including that of the Enforcement Directorate (ED). It would have a parallel track covering a media trial, and a social media trial, of the protagonists, the Gandhis. The Congress describes the ED probe as vendetta politics. The ruling BJP believes this is a crackdown on 'corruption' and accuses the Gandhis of trying to pressurise the investigating agencies and prevent them from doing their job.

In 1937, Nehru floated a company called Associated Journals Ltd (AJL) with 5,000 freedom fighters as its donors. Therefore, there was no particular owner to that company. AJL launched three newspapers — in English, Hindi and Urdu. Nehru was the international correspondent for National Herald, the English language newspaper that was a powerful mouthpiece of the Congress party. He continued to voice his opinions in the daily even after he became the Prime Minister.

His son-in-law Feroze Gandhi was the managing director of AJL between 1946 and 1950. Nehru would have little imagined that decades later his grandson's wife Sonia and her children Rahul and Priyanka would find themselves embroiled in criminal investigations following a case filed by their bete noire Subramanian Swamy and two others. Meanwhile, the enforcement agencies alleged that since 2008, AJL was not publishing any newspapers and was only collecting rent from its tenants, therefore it was a real estate company. This was denied by the Gandhis, who said the newspaper publication was only temporarily suspended and not closed. The lease agreements allow renting. They gave examples of how all other newspaper companies were involved in similar practices. The probe agencies were unwilling to believe that the Congress actually extended money to AJL. Rather, they said, AJL's takeover was based on fraudulent transactions; the ₹90 crore loan from AICC to AJL was "non-existent' and just a paper entry, they claimed.

Devendra Fadnavis asked the urban development ministry to start construction of the shed at Aarev milk colony

he urban development department has removed the stay on constructing a Mumbai Metro 3 car shed in Aarey on Thursday, said additional chief secretary Bhushan Gagrani who heads the department.

Soon after taking over, Deputy Chief Minister Devendra Fadnavis asked the urban development ministry to start process for construction of the shed at Aarey milk colony. "We have examined the entire



matter and there is no need to bring the matter before the cabinet. We asked the implementing agency Mumbai Metro Rail Corporation to prepare the proposal and mobilise contractor."

Meanwhile, Nationalist Congress Party president Sharad Pawar has dissolved all departments and cells of the party with immediate effect, senior NCP leader Praful Patel said. Patel did not disclose the reason for the sudden move, which comes three weeks after the collapse of the Maha Vikas Aghadi (MVA) government in Maharashtra.

Two men dupe senior citizen of Rs 22 lakh using online payment app

wo persons have been arrested for allegedly duping a senior citizen of Rs 22 lakh through a fraudulent transfer from his bank account using an online payment app, a Mumbai police official said on Thursday.

According to a Dindoshi police station official, two persons befriended the 68-year-old victim and transferred Rs 22 lakh from his account through an online payment app on the pretext of playing a



game on his mobile phone.

"After a complaint was filed, we managed to arrest both accused. Further probe into the incident is underway," he added.

Best Bakery accused claims witnesses being tutored



n a c c u s e d a n d undertrial in the 2002 Best Bakery case is going to approach the principal judge of the sessions court seeking to transfer his case to another judge.

Advocate Prakash Salsingekar, the lawyer representing accused Harshad Solanki, alleged that the trial court had not taken cognizance of his apprehension that witnesses were being tutored, adding he is going to file an application in the sessions court regarding the same.

Solanki had earlier written to Gujarat police to investigate if activist Teesta Setalvad has played any role in tutoring witnesses. In February, 2019, the sessions court had framed charges against two persons – Harshad Solanki and Mafat Gohil.

The two are facing trial for charges including murder, attempt to murder, rioting and other sections of the Indian Penal Code for the communal violence in Vadodara in 2002. The duo had pleaded not guilty.

Duty of police to register FIR when cognizable offence is brought to its notice: Bombay HC

he Bombay High Court on Thursday said it was the duty of the police to register a First Information Report (FIR) if a cognizable offence was brought to its notice.

The remark was made by a division bench of Justices Revati Mohite Dere and Sharmila Deshmukh while hearing a



petition challenging the circular issued by the former Mumbai police commissioner that stipulated seeking approval of the deputy commissioner of police (DCP) before registering FIRs under Protection of Children from Sexual Offences (POCSO) Act and in cases of outraging modesty of women.

PIL on water, toilet facilities in cricket grounds:

If parents can buy children gear, they can buy water as well, says HC



he Bombay High Court on Thursday said if parents can buy their children cricket gear then they can buy bottled water too.

A division bench of Chief Justice Dipankar Datta and Justice M S Karnik was hearing a public interest litigation lamenting the lack of basic facilities like drinking water and toilets at cricket grounds.

The bench further noted

cricket was not even a game that is originally from India.

The PIL, filed by one advocate Rahul Tiwari, claimed several cricket grounds in the state, including the one in south Mumbai managed by the Mumbai Cricket Association, do not have basic facilities of drinking water and toilets despite budding and professional cricketers playing on them.

Maha CM lifted all curbs in upcoming festivals

aharashtra Chief Minister Eknath Shinde on Thursday announced that the restrictions imposed on festivals during the coronavirus pandemic have been lifted and there would no curbs on the upcoming Ganesh Chaturthi, Dahi Handi and other religious events.

There will also be no restrictions on the commemoration of Muharram when processions are taken out, he said.

After the pandemic broke out in March 2020, the Maha Vikas Aghadi (MVA) government, which was then led by Uddhav Thackeray, imposed several restrictions on festivals, including a ban on processions during the Ganeshotsav. There were also curbs on the height of the Lord Ganesh idols installed

by sarvajanik (community) mandals and as well the household level.


Due to these factors and the prevalence of infection, the Ganesh festival and other religious events had mostly remained low-key in the last two years.

Speaking to reporters, Shinde said, "All the restrictions on the religious festivals introduced during the pandemic have been lifted. People should be able to welcome such festivals with a positive attitude." He added that a single-window system would be set up to facilitate the Ganesh mandals across the state in obtaining permissions for pandals and other things. "There will be no registration fees for it," the chief minister said

Mumbai Youth Congress opposes naming of new MU hostel after Savarkar

he Mumbai Youth Congress submitted a letter to the Vice Chancellor of Mumbai University, Dr Suhas Pednekar, objecting to the naming of the new international students' hostel facility after Vinayak Damodar Savarkar.

The name was suggested by Governor Bhagat Singh Koshyari, who inaugurated the new building earlier this month. "Savarkar is mythologised in



popular imagination as 'Veer Savarkar' – he refrained from participating in the freedom struggle and the British released him from prison on account of his relentless plea for mercy. He pushed his communal ideology, which led to the communal divide as a time when a united front against colonial rule was needed," reads the letter by Hargun Singh, General Secretary of Mumbai Youth Congress, which suggests that the new facility should be named after Chhattrapati Rajarshi Shahu Maharaj.



Change mindset with times, create awareness about writings of social reformers: HC to Maha govt

he Bombay High Court on Thursday said the Maharashtra government has to change in its mindset with the times and make efforts to create public awareness about the writings of Dr Babasaheb Ambedkar and other social reformers.

A division bench of Justices Prasanna Varale and Kishore Sant noted that the Maharashtra government has published "wonderful" volumes of the handwritten literature of several social reformers, but unfortunately not many are aware of it.

The government should create awareness about this, the court said.

"Volumes (of writings) of so many social reformers are published by the Maharashtra government but how many people are aware of this? These volumes have been published



decades ago and some of them are the most wonderful ones. Care is not taken. Readers have to be brought to the bookshop," it said.

"You (state government) have to change your mindset according to the changing times. Earlier, people used to go to bookshops but now it is all available at a doorstep. Publishers have to bring people to the shops," Justice Varale said.

"You are not taking any steps for awareness. You will have to make concrete and positive efforts," the court said, adding that many people do not even know where government bookshops are located.

The bench was hearing a petition taken up suo motu (on its own) in December 2021 after the media reported that the Maharashtra government had halted its project of publishing Ambedkar's literature.

The HC also expressed dissatisfaction over the affidavit submitted by the state government and said it did not have all the necessary details sought by the court.

The affidavit does not have details about the formation of the committee set up to address this issue, the names of members of the committee if any meeting has been held by it and details of their remuneration, the court pointed out.

The bench directed government pleader Purnima Kantharia to file an additional affidavit within two weeks.

"We are not satisfied with this approach (of the government). This is not the way we expect the state government to handle such matters," Justice Varale said.

Kantharia told the court that volumes of Ambedkar's writings were being distributed to colleges and other institutions.

But, the HC said it wants the committee to say this and not the government.

"Let the committee make a statement that these books are reaching the readers. We want to see if the government is taking appropriate steps to ensure that these volumes are published in reasonable time," it added.

4 swine flu patients in city on life support; virus in the air, say doctors

t least four people infected with influenza H1N1 (swine flu) are on life support in the city.

Doctors caution that the viral infection is back in circulation in the city and people who test negative for Covid-19 must be tested for H1N1 by their physicians.

The civic body on Tuesday said 11 confirmed cases of influenza H1N1 have been reported in July, up from two in

These numbers are only the tip of the iceberg though, said doctors, adding most are

encountering a minimum of two to three cases in their outpatient departments daily. Like Covid-19, H1N1 is a respiratory disease, which started as aglobal pandemic in 2019 but became endemic soon after.

At Bandra's Lilavati Hospital, two patients below the age of 50 years are on extracorporeal membrane oxygenation (ECMO) therapy, considered the last resort and offered when even ventilatory support has failed.

The hospital has five other patients admitted in wards with H1N1.

2 arrested for attacking Shiv Sena workers of the Thackeray group

olice on Thursday arrested two persons in connection with the attack on a worker of the Uddhav Thackeray-led Shiv Sena here in Maharashtra, an official said.

Harshawardhan Palande, deputy chief of the Sena's Kalyan city unit, was on Wednesday injured in the attack and admitted to hospital, said an official.

The incident had taken place on Pune Link Road in Kalyan East. Four to five men had arrived in a car and attacked Palande with sticks, iron rods and choppers, a police official said.


The Kolsewadi police on Thursday arrested two persons in this connection, the official said.

They registered a case under Indian Penal Code Sections 323, 324 (voluntarily causing hurt by dangerous means or weapons), 504 (intentional insult with intent to provoke breach of peace), 506 (criminal intimidation) and 34 (common intention), he said.

Nagpur Central Jail sends names of 14 inmates to Maha Governor for remission

agpur Central Jail authorities have sent names of 14 inmates to the Maharashtra governor's office for inclusion in the remission scheme launched by Prime Minister Narendra Modi on the occasion of 75th anniversary of Independence, officials said here on Thursday.

As part of the scheme, some prisoners above the age of 60 and who have completed over half of their prison sentence will be eligible for remission, they said. The move is to encourage good behavior and learning among prisoners, they added.

SC finally allows Maha to grant OBC quota in local body polls

fter having failed multiple times in convincing the Supreme Court in the past one year to allow it to grant reservation for Other Backward Classes (OBCs) in local body elections, the Maharashtra government can now do so as the court on Wednesday asked the Election Commission to take into account the report of the State Commission for Backward Classes which had recommended the reservation.

Armed with the final report of the Commission for Reservation of Backward Class of Citizens in Local Bodies, the state government pleaded before a bench of Justices A M Khanwilkar, Abhay S Oka and J B Pardiwala that the reservation for backward classes be allowed as the commission has come to the conclusion that they are underrepresented despite forming 37% of the state's population.

fter having failed multiple times in convincing the Supreme Court in the past one year to allow it to grant reservations for Other Backward Classes (OBCs) in local body elections, the Maharashtra government can now do so as the court on Wednesday asked the Election Commission to take into account the report of the State Commission for Backward Classes which had recommended the reservation.

Armed with the final report of



the Commission for Reservation of Backward Class of Citizens in Local Bodies, the state government pleaded before a bench of Justices A M Khanwilkar, Abhay S Oka, and J B Pardiwala that the reservation for backward classes be allowed as the commission has come to the conclusion that they are under-represented despite forming 37% of the state's population.

"All Congress MPs and CWC Members have courted mass arrest outside our Party HOs in a show of collective solidarity with Congress President Sonia Gandhi, a target of Vishguru's political vendetta. We are being taken away to a police station in Old Delhi evidently," said party leader Jairam Ramesh.

Protesting Congress leader Mallikarjun Kharge said that the ruling party (BJP) is showing its highhandedness by misusing the probe agencies by asking them to target opposition

"They (ruling party) want to show how powerful they are. We've raised the issue of inflation in Parliament but they're not ready for discussion. We are now raising the issue of misuse of central probe agencies," Kharge.

Congress MP Deepender S Hooda said that they are protesting peacefully. "We are protesting peacefully.

They cannot suppress our voice," said Hooda. Rajasthan Chief Minister Ashok Gehlot, who is also in Delhi slammed the probe and said that since Sonia Gandhi is over 70 years old, ED should have gone to her house for investigation.

Sri Lankan Navy arrests six TN fishermen



Sri Lankan Navy has arrested six fishermen from the Palk Bay area and seized their boats and accused them of poaching in the country's territorial waters, said police on Thursday.

"When the six fishermen were fishing in the Palk Bay sea area, the Sri Lankan Navy came to the area and claimed that they were fishing across the border and arrested the six fishermen and took them with their boat to Thalaimannar for investigation," said Q Branch Police, Rameswaram.

On July 20, the fishermen went fishing from Rameswaram port after obtaining permission from the Department of Fisheries.

The fishermen who went for fishing have been identified as N Palamurugan (32) from Kariyur; D Anthony (38) and K A r j u n a n (23) f r o m Thangachimadsm; J Maduku Pichai (45) from Rameswaram; K Thangapandi (55) and Raja (21) of Rameswaram Sivagami Nagar.

Earlier, 12 Indian fishermen were arrested by the Sri Lankan Navy for allegedly fishing illegally in the country's territorial waters.

Following which, Tamil Nadu Chief Minister MK Stalin requested External Affairs Minister (EAM) S Jaishankar to take appropriate action for the immediate release of 12 Indian fishermen arrested by the Sri Lankan Navv.

All India Anna Dravida Munnetra Kazhagam (AIADMK) leader O Panneerselvam also wrote a letter to External Affairs Minister S Jaishankar seeking his immediate intervention for the release of 12 Indian fishermen arrested by the Sri Lankan Navy.

On March 25 this year, the fifth meeting of the India-Sri Lanka Joint Working Group on Fisheries was held through virtual mode.

The Joint Working Group discussed all relevant issues in detail including the concerns relating to fishermen and fishing boats which have been on the agenda of bilateral discussions between India and Sri Lanka for many years.

The Indian side expressed its readiness to work together with Sri Lanka for joint research to enhance the productivity of the Palk Bay fisheries.

Ranil Wickremesinghe: From PM to President in Sri Lanka's troubled times



anil Wickremesinghe, a seasoned politician who was appointed as the Prime Minister in May to deal with Sri Lanka's worst economic crisis in decades, faces new challenges to fix a collapsed economy, end political turmoil and unite the deeply divided country in his new role as President.

The 73-year-old lawyer-turned politician, who is believed to be close to India and its leaders, was appointed as the 26th prime minister of Sri Lanka in May by then President Gotabaya Rajapaksa amidst the worst economic crisis in the country. His appointment took place nearly two years after his United National Party (UNP) was routed and failed to win a single seat in the general election held in August 2020.

His appointment filled the void of leadership as Sri Lanka was without a government following the ouster of Gotabaya's elder brother and Prime Minister Mahinda Rajapaksa after violent protests

following an attack on the antigovernment protesters by his supporters.

Widely accepted in political circles as a man who could manage the economy with far-sighted policies, Wickremesinghe, however, struggled to fix the economy which, he said, had collapsed at the time of his appointment in May.

He was appointed acting president on July 13 after President Rajapaksa fled to the Maldives and then to Singapore from where he resigned in the face of public revolt against his government's mishandling of the country's economy.

Wickremesinghe was later sworn in as the eighth President after he defeated former information minister Dullas Alahapperuma during a vote in parliament. Wickremesinghe, who was backed by members of the fragmented ruling coalition, remained unpopular among voters who view him as a holdover from the previous government that led the country into an economic crisis in decades.

Wickremesinghe, perceived as the Sri Lankan politician who could command international cooperation, has held many important posts during his political career spanning four and half decades.

Protest planned against Pak Army during Baba Ghundi festival over forceful land grabbing

he locals in Hunza, Gilgit-Baltistan (GB) are planning to hold a protest against the Frontier Works Organisation (FWO) and Pak Army on the occasion of the Baba Ghundi festival, for forceful land grabbing near the Chiporsun valley. Baba Ghundi festival, slated to take place on July 21-23, is celebrated by the locals of Hunza and the Wakhi tribe of Afghanistan every year at the shrine of Baba Ghundi at the Wakhan Corridor along the Pak-Afghan border.

It is organized by the GB tourism department in collaboration with Chiporsun Local Support Organisation (CLSO) to pay homage to the local sufi saint. Besides the Hunza natives, a large number of people from Afghanistan's Wakhan region also attend the festival.

The Wakhan corridor is an ancient route used by the local tribes and natives for trade and business activities. Therefore, the festival holds huge economic importance for the local GB people Wakhan Corridor is an ancient historical route for trade between Hunza valley and Afghanistan.

Due to its historical and strategic importance, Pak Army / FWO have reportedly started forceful acquisition of land from the local people. FWO has already seized control of one village near the Wakhan corridor and locals fear more such acquisitions.

Asia's central banks forced to play catch-up in global rush to raise rates

aving bucked a global dash to tighten monetary policy for a year, Asian central banks find themselves scrambling to catch up in order to tackle rising inflation and defend weakening currencies.

Market analysts suspect Indonesia, the last remaining dove in emerging Asia, may be the next to move by pushing interest rates higher on Thursday, as policymakers rush to convince investors they are tackling rising prices.

Singapore and the Philippines surprised markets with unscheduled tightening announcements last week, underlining the growing urgency among policymakers to act.

Asia has lagged as the rest of the world, including emerging markets, began lifting rates as early as last June, after the U.S.



Federal Reserve kicked off an accelerated timeline for its policy tightening.

While relatively subdued inflation allowed central banks in Asia to remain dovish in a bid to support the post-pandemic economic recovery, that led to weakening currencies and capital outflows, even as the war in Ukraine exacerbated price pressures globally.

Only decentralised renewable energy can help achieve 2030 targets: Experts

ndia may have taken great strides in utility scale deployment of renewable energy (RE), but the 2030 targets -- as promised by Prime Minister Narendra Modi at the climate summit last year -- can be achieved only by increased de-centralised installation of RE. experts have warned.

At the annual climate change negotiations platform at Glasgow in November 2021, Prime Minister Narendra Modi had announced that India will have installed capacity of 500 GW of non-fossil energy and meet 50 per cent of its requirements through renewable energy. Modi also announced that India will achieve Net Zero in 2070.

As of date, according to the

Ministry of Renewable Energy (MNRE), India is now at 4th global position for overall installed renewable energy capacity. The solar capacity has increased in the last 7.5 years from around 2.6 GW to more than 46 GW. India currently has the largest RE expansion programme with 175 GW till 2022.

provisions and contingencies fell to Rs 253 crore as compared to Rs 1.384 crore in O1FY22.

China's 'Didi Global' fined \$1.2 billion for data violations since 2015



hina's internet watchdog on Thursday fined ride-■hailing firm Didi Global more than 8 billion yuan (\$1.2 billion) following an investigation into the company's cybersecurity practices.

The probe found Didi violated China's network security law, data security law and a law protecting personal information, the Cyberspace Administration of China said in a statement.

A separate statement explaining the fine said Didi's illegal operations had brought serious national security risks, affecting the country's information infrastructure and data security.

Didi's chairman Cheng Wei and president Jean Liu were fined 1 million yuan (\$148,000) each as they were held responsible for the company's violations, regulators said.

Didi's violations of laws and regulations are serious, and in light of the network security review, they should be severely punished, the statement read.

Net profit for the three months ended in June rose to 3.08 trillion won (US\$2.34 billion) from 1.98 trillion won during the same period of last year, the company said in a statement.

In the six-month period, Hyundai sold a total of 1.88 million vehicles, achieving 43 per cent of its sales target of 4.34 million units for the year.

The second-quarter bottom line was buoyed by increased sales of Hyundai's independent brand Genesis models, decreased incentives and the won's weakness against the dollar, reports Yonhap news agency.

The dollar rose to an average of 1,259.57 won in the second quarter from 1,121.23 won a year ago, according to the Bank

"It was my first major tournament with the Senior team and I scored my first goal in the opening game itself against Australia, so it is my favourite memory of the Commonwealth Games. We missed the Gold medal with a very narrow margin, but it was a great experience overall. We finished second in the pool stage and then defeated New Zealand 1-0 in the semi-Final to ensure the Indian Women's Hockey Team's second consecutive medal at the Commonwealth Games," said Asunta.

[1]- It is in the knowledge of the ECI that Shiv Sena is not merely in Maharashtra but in other States and Union Territories of India too where even candidates are fielded by Shiv Sena in elections to Parliament, State Assemblies and Local Bodies by giving A & B forms to such Shiv Sena candidates.

[2]- These Shiv Sena candidates in the rest of India (other than Maharashtra) are also entitled (on preferential basis for the symbol of Shiv Sena) as per section 10 of the ESRAO which reads as -

"[10. Concessions to candidates set up by a State party at elections in other States or Union territories.—If a political party, which is recognized as a State party in some State or States, sets up a candidate at an election in a constituency in any other State in which it is not a recognized State party, then such candidate may, to the exclusion of all other candidates in the constituency, be allotted the symbol reserved for that party in the State or States in which it is a recognized State Party, notwithstanding that such symbol is not specified in the list of free symbols for such other State or Union territory]".



candidates all over India are supported by Shiv Sainiks in respecting areas who become Shiv Sena members as per rules of Shiv Sena and after giving membership contributions to Shiv Sena hence are to be recognized by the ECI as per section 29 A (4) (e) of the THE REPRESENTATION OF THE PEOPLE ACT, 1951 (RPA) which reads as-

"[29A. Registration with the Election Commission of associations and bodies as political parties. — (1) Any association or body of individual citizens of India calling itself a political party and intending to avail itself of the provisions of this Part shall make an application to the Election Commission for its registration as a political party for the purposes of this Act.

(2) Every such application shall contain the following particulars, namely:—

(e) the numerical strength of its members, and if there are categories of its members, the numerical strength in each category]"

[4]- These Shiv Sainiks from rest of India (than Maharashtra) not only give membership contribution to the Shiv Sena as per section 29B of the RPA but also bring donations etc from other persons for Shiv Sena and which is the mandatory duty of the ECI to

take cognizance of as per section 29 C (3) of the RPA which reads as -

"[29B. Political parties entitled to accept contribution.—Subject to the provisions of the Companies Act, 1956, every political party may accept any amount of contribution voluntarily offered to it by any person or company other than a Government company:

29C. Declaration of donation received by the political parties.—(1) The treasurer of a political party or any other person authorized by the political party in this behalf shall, in each financial year, prepare a report in respect of the following, namely:—

(3) The report for a financial year under sub-section (1) shall be submitted by the treasurer of a political party or any other person authorized by the political party in this behalf before the due date for furnishing a return of its income of that financial year under section 139 of the Income-tax Act, 1961, to the Election Commission]".

[5]- In view of the above mentioned provisions of laws the ECI is under legal obligation to decide the claim between Eknath Shinde and Uddhav Thackeray (as to who represents the political party Shiv Sena) after first ensuring

organizational elections of Shiv Sena by the Shiv Sainiks of all over India (and not merely of Maharashtra) and after ensuring proper financial returns of Shiv Sena with the Income Tax Department and with the ECI.

[6]- Here it is in context to add that I was associated with the Shiv Sena (SS) from 1986 to 2003 in Navi Mumbai, Kota, Bhopal and Delhi (where I worked for SS trade union in Navi Mumbai, was office bearer of the SS from City to State level and contested election for the SS for Loksabha in 1998 from

[7]- Normally if any other constitutional authority indulges in dereliction of statutory duty then it is widely reported and discussed in the media that such authority (as in this case the ECI) takes bribes from the top office bearers of the party (in this case the Shiv Sena). But Indians (including its media) have been over indulgent towards the ECI which has not attracted such


