

The Supreme Court will deliver the verdict on the Centre's curative plea for enhanced compensation for the victims of the 1984 Bhopal Gas tragedy from US-based firm Union Carbide Corporation, now owned by Dow Chemical on Tuesday. On January 12, the Supreme Court on Thursday reserved its verdict on the Centre's curative plea for enhanced compensation for the victims of the 1984 Bhopal Gas tragedy from US-based firm Union Carbide Corporation, now owned by Dow Chemicals.

The judgement will be pronounced by a five-judge constitution bench headed by Justice Sanjay Kishan Kaul. The bench also comprises Justices Sanjiv Khanna, Abhay S Oka, Vikram Nath and JK Maheshwari. The Centre's curative plea for enhanced compensation for the victims sought a direction to Union Carbide and other firms for over Rs 7,400 crore additional amount over and above the earlier settlement amount of USD 470 million (Rs 715 crore at the time of settlement in 1989) for paying compensation to the gas tragedy victims. The government sought a reexamination of the apex court's February 14, 1989 judgment which had fixed compensation at USD 470 million, contending that the 1989 settlement was seriously impaired.

The contention of the Central government was that the compensation, determined in 1989, was arrived on the basis of assumptions of truth unrelated to realities. During the hearing, successor firms of the Union Carbide Corporation told the apex court that the depreciation of the rupee since 1989, when a settlement was arrived at between the company and the Centre, cannot be a ground to now seek a top-up of compensation for the victims.

Senior advocate Harish Salve, appearing for one of the firms, had told the top court that the government of India never suggested at the time of the settlement that it was inadequate. The Bhopal gas tragedy, touted as the world's worst industrial disaster, had claimed the lives of several thousand people after deadly gas leaked from the Union Carbide India Limited pesticide plant on the intervening night of December 2 and 3, 1984. The tragedy unfolded in Bhopal, Madhya Pradesh, when the highly dangerous and toxic gas, methyl isocyanate (MIC), escaped from the Union Carbide India Limited (UCIL) and resulted in the death of 5,295 human beings, injuries to almost 5,68,292 persons besides loss of livestock.

The apex court had already dismissed a curative petition filed by the Central Bureau of Investigation (CBI) in 2010 for enhancement of punishment. The agency had approached the Supreme Court, facing public outcry over a Bhopal court order that sentenced Union Carbide executives to two years imprisonment. Those convicted included former Union Carbide India chairman Keshub Mahindra.

Dismissing the CBI's curative plea in 2011, the top court had held that "no satisfactory explanation has been given to file such curative petitions after about 14 years from the 1996 judgment". (ANI)

Their tattered clothes, emaciated bodies, and unclean body frames, followed by equally unclean mangy dogs, are an eyesore. There was one beggar at Krishna Nagar, Borivali. He was my morning walk partner. He used to stay alone on the footpath of a bungalow. Later on, the landlords asked him to evict the pavement and shift to another side. The area was not fully developed, so he could hardly ask for some help.

One day, I saw him sitting on the other side of the pavement. It was raining badly, and the man was so fragile that he could hardly call us. He just raised his hand to ask for assistance.

I had both an umbrella and a raincoat, so I gave him an umbrella. He wanted something else, but I failed to understand his sign language. I returned home, but while going to the office, I saw someone give him food, but he did not eat it. The footpath was full of water, and he somehow adjusted himself in the corner with that umbrella. The very next day, I approached some BMC staff and asked them to help this old man. But they were not ready to encourage beggars by providing them a safe place to stay. I called my home help; she brought meters of poly sheets and created a small tent out of it. That tent became the home of that old man until his death.

From that day on, he became my street buddy. Every morning I used to give him some money for food and tea; gradually, people in the locality also started giving him food, water, and leftovers. Monsoon season approaches; every year, my organization distributes blankets to the people on the street. That year, I got two blankets for this old man too. His happiness knew no bounds. Looking at his happy face, I felt scared. In sign language, we conversed for ten minutes. Can you imagine him looking like the king of his small tent with new clothes and blankets? Some people gave him some bed sheets and a mattress too. His asset was a dirty bag that he always used to keep under his head.

By now I could understand him completely. During COVID, many NGOs in Mumbai made special efforts to reach beggars on the street. Mumbai might be a concrete jungle, but it has a lot of humanity and love for deprived people. Each one of them does something or other in their capacities. But an old beggar in a remote corner gets neglected. During those days, there was one young boy who started his catering start-up. I gave him his first job, providing two full meals to such beggars who were not part of the mainstream street population. Throughout his time in COVID, he served these people wholeheartedly. His start-up needed funds, but getting a bank loan was not possible for him, and meanwhile COVID had also financially broken everyone, so no one was ready to give him financial assistance. Still, he continued doing his job.

Let me cut the story short. In those days, the old beggar met me as I walked past that night; he was trying to say something by showing his bag. I was very busy with my own priorities; I just ignored him and, as usual, asked for his well-being before moving ahead. Next

morning I came to know that he had passed away. I rushed to his hut; his body was taken away by BMC personnel. His stuff was also taken into custody; to our surprise, when that bag was opened, there was a big amount in it. Well, the cops did charity work for other beggars with that money and made sure the small streetside eatery of that caterer got some funds for its makeover. Well, this was one of the rarest of the rare stories to tell, but we need government policies to make our country beggar-free.

In the whole of India, one may find a dozen rich beggars. Rich people may possess lakhs of rupees. Some may lend money to small traders at a reasonable monthly rate of interest. Even if they possess so much money, they cannot lead a decent life by buying or renting a house in a decent locality because the whole town would know them as beggars, and there is a fear of losing their clients. Despite having so much money, they are unable to abandon their begging profession because it pays well.

Most of the beggars are working for a gang that collects money from them every evening; worse still, they dress them to look like beggars. These normal people, fully capable of doing manual labor, are dressed and, yes, touched up to look poor. In this case, charity does not help; there are a number of children who are stolen from hospitals, homes, and streets. Worse, their poor parents sell them to these gangs to be used as beggars. Their limbs are operated upon, and they are made physically handicapped so that they can get alms. It is an endless chain, which is a vitiating circle; you give more money, the gangs want more, and they steal more children to create more beggars for society.

In order to improve their condition, successive governments have to formulate schemes in their favor. Beggars Rehabilitation Centers should be established in all states where beggars can be assigned a task and given food, shelter, and income-generating skills so that, once released, they can easily make a living in the outside world. However, the majority of those released continue to engage in the same illegal activity, are apprehended by Rehabilitation Center employees, and are returned to the center to repeat the process.

According to NASA, the most likely scenario is that climate change causes surface water to add to the stress on a fault. There are also droughts. Droughts, according to NASA researchers, can change the size of mountains due to water loss. In theory, this could result in a change in stress on faults. Other studies have found that groundwater extraction during droughts can affect stress by essentially changing the weight of the planet's crust, which can cause changes between both sides of a fault line and causes an earthquake. Then there are glaciers, which move as well. Glacial earthquakes can occur as glaciers shift due to climate change. Therefore, to reduce earthquakes lowering stress loads is very much essential. In other words, climate change could play a role in earthquakes.

Two arrested for circulating morphed video of Shiv Sena Shinde faction leader

wo persons were arrested for allegedly circulating a morphed video of Shiv Sena MLA Prakash Surve and a woman party leader, the police informed on Sunday.

The accused have been identified as Manas Kuwar (26) and Ashok Mishra (45).

Based on the complaint of the woman leader, the police registered against unknown accused under sections 354, 509, 500, 34 and 67 of the Indian Penal Code (IPC) and started investigation into the matter.

The matter pertains to Saturday evening, when a rally was organized in Mumbai's Dahisar are, which was also attended by Maharashtra Chief Minister Eknath Shinde During the event, Shiv Sena MLA Prakash Surve and the woman leader welcomed the chief minister on stage.

As per allegations, during the rally some miscreants made a

video of the MLA Surve and the woman leader. They allegedly edited the video, put obscene songs into it and made it viral on internet, the police said. After the video went viral on Saturday night, leaders and workers of the Shinde faction reached the Dahisar police station and demanded an investigation against the accused.

The woman leader, whose alleged morphed video has been made viral, told ANI that she has been on the receiving side of hate for a long time.

Talking to media, she said, "The attacks on me started when my friends and I started working with CM Eknath Shinde. We have been subjected to abusive messages and derogatory comments on social media."

The leader said that she always chose to ignore the hate, but the situation escalated, when the morphed video was made viral.

She added, "During a rally, our local MLA Prakash Surve, CM Eknath Shinde and several BJP leaders were present. At that time, someone made a video, morphed it and made it viral on social media."

She also claimed that no woman will enter politics if such things happen. "They are trying to assassinate the character of woman who are working in politics. There are women working as a journalist, woman going to office, if this is how the character of women is assassinated, no woman will come in politics," she said.

She also alleged that the two accused who have been arrested are "office bearers of Thackeray faction".

"I complained to the police about the matter, after which two people were arrested who are office bearers of Thackeray group, so there is nothing to say," she alleged.

Mumbai sizzles at 39.4 degrees **Celsius, logs highest temperature in** India for 2nd time in Mar

or the second time in the - current month, Mumbai recorded the highest maximum temperature in the country at 39.4 degrees Celsius on Sunday, the India Meteorological Department (IMD) said, attributing the rise in mercury to the absent or delayed sea breeze.

The IMD had warned of a heatwave on Sunday and Monday. The Santacruz observatory (located in suburbs) and the Colaba observatory (located on southern tip of island city) around 19km apart recorded temperatures of 39.4 degrees Celsius and 35.8 degrees Celsius, respectively, on Sunday,

"This is for the second time this month that Mumbai has recorded the highest maximum temperature in the country. On March 6, Santacruz (observatory) recorded 39.1 degrees Celsius, also the highest in the country (that day). On Sunday, the city recorded 39.4 degrees Celsius," said IMD scientist Rajendra Jenamani

According to the IMD, the highest Mumbai temperature in March was 41.3 degrees Celsius recorded at the Santacruz observatory on March 17, 2011.

Seven years later, the metropolis (Santacruz observatory) had recorded 41 degrees Celsius on March 26, 2018.

The IMD scientist said the temperature recorded in the coastal Konkan region, which encompasses Mumbai, was 4 to 6 degrees Celsius above normal on March 12

This was also observed between March 5-7 when the temperature was 5 to 7 degrees above normal, Jenamani added.

"Normally, Konkan witnesses low temperatures during this time because of the sea breeze between 11.30 am and 1 pm. However, in the last seven to ten days the sea breeze is absent or delayed because of the dominant easterly winds which have resulted in high temperatures," he said.

Major fire in slums in Malad and furniture

on Monday afternoon, but no casualty was reported, a Fire Brigade official said.

The level 3 (major) fire engulfed slums located in the Appa Pada locality and efforts were on to douse the flames, he said. Smoke billowing out of the area could be seen from several kilometres away.

According to the official, fire tenders, jumbo water tankers and other equipment were engaged in controlling the blaze. An ambulance has been also stationed at the site. No details were immediately available on the cause of the fire.

In another case, A major fire broke out in a furniture godown located in suburban Jogeshwari in Mumbai on Monday morning, officials said.

No casualty is reported. The blaze erupted after 11 AM in the Ghas Compound located on the Relief road in Jogeshwari, Fire Brigade officials said, adding it was classified as a level three fire (major emergency call).

At least 12 fire engines, six jumbo tankers, ambulances, and senior Fire Brigade officials rushed to the spot.

"The fire is confined to the furniture market," an official said, adding the cause of the fire is yet to be ascertained.

SC refers petitions seeking legal recognition of same-sex marriage to Constitution Bench

The Supreme Court on Monday referred various petitions seeking legal recognition of same-sex marriage to the Constitution Bench.

A bench headed by Chief Justice of India DY Chandrachud listed the petitions seeking legal recognition of same-sex marriage to a five-judge bench constitution bench and said that the hearing will take place on April 18.

Solicitor General Tushar Mehta, appearing for Centre, says the right to love, expression and freedom of choice is already upheld and no one is interfering with that right but doesn't mean conferring the right of marriage.

SG Mehta argued that the moment marriage as a recognized institution comes between the same sex, the question will come on



adoption and therefore parliament will have to see on the issue of the psychology of the child, which has to be examined whether it can be raised in such a way.

He further said that the parliament will have to debate and take a call on whether in view of ethos.

However, the court remarked adopted child of a gay or lesbian couple does not have to be gay or a lesbian. SG Mehta said that this is a matter having grave ramifications.

When the bench was apprised that the Centre has filed an affidavit, CJI DY Chandrachud remarked Centre is saying it is in the legislative domain Senior Advocate NK Kaul said that controversy is narrowed down and they can show that either the statute can be harmoniously construed or in light of Navtej Singh, it has to be recognised Senior Advocate KV Vishwanathan apprised the SC that the transgender protection act exists even though the centre stated that it doesn't recognise such a union.

The court was hearing a batch of petitions pertaining to the issue of same-sex marriage, which had challenged the denial of access to the institution of marriage to the members of the LGBTQ+ community as being in contravention of Part III of the Constitution, including Articles 14,15,19 and 21.

The Senior counsel appearing for the Petitioners submitted that the petitions pertained to issues of fundamental rights. Centre has opposed the prayers in the petition on the ground that such questions ought to be left to the legislature which is representative of the will of the people.

The Bench was pleased to fix a schedule for hearing for this batch of petitions and directed that the matter be placed before a Hon'ble Constitution Bench pursuant to Article 145(3) of the Constitution.

One of the petitions was represented by Senior Advocates Mukul Rohatgi and Saurabh Kirpal briefed by a team of advocates from Karanjawala and Co.

Earlier, Centre, in its affidavit, had opposed the plea seeking legal recognition of same-sex marriage, saying that living together as partners by same-sex individuals, which is decriminalised now, is not comparable with the Indian family unit and they are clearly distinct classes which cannot be treated identically.

Oppn protest against "misuse of central investigative agencies", demand probe into Hindenburg-Adani issue



pposition leaders on Monday protested against the Central government in front of the Mahatma Gandhi statue in Parliament before the second part of the Budget session began on Monday.

Bharat Rashtra Samithi (BRS) and Aam Aadmi Party MPs protested in Parliament against alleged misuse of Central investigation agencies and demanding joint parliament" parliamentary committee (JPC) probe into the Hindenburg-Adani issue.

Earlier on Monday, 16 parties participated in the Opposition party leaders' meeting chaired by Leader of Opposition in Rajya Sabha Mallikarjun Kharge in Parliament.

The 16 parties comprised In-

dian National Congress; Dravida Munnetra Kazhagam(DMK), Janata Dal (United); Aam Admi Party; Communist Party of India (Marxist); Kerala Congress, Rashtriya Lok Dal; Nationalist Congress Party; Communist Party of India; Indian Union Muslim League; Shiv Sena (Uddhav Thackeray); Marumalarchi Dravida Munnetra Kazhagam, Revolutionary Socialist Party; Rashtriya Janata Dal; Jharkhand Mukti Morcha and the NC.

Both Houses of Parliament adjourned till Tuesday amid ruckus over Rahul Gandhi's London speech

Both Houses of Parliament were on Monday adjourned till 11 am on Tuesday amid uproar with the govenment demanding an apology by Congress leader Rahul Gandhi over his remarks in a speech in London followed by protests by Opposition members.

The second leg of the Budget session kicked off this morning amid chaos with treasury and opposition benches trading charges.

While the BJP has hit out at Rahul Gandhi demaniding an apology for his speech in London, the Opposition protested with LoP Mallikarkun Kharge stating that the BJP was not following rules.

With moments of the Session

starting the Rajya Sabha was adjounrned till 2 pm and when the House resumed, Union Minister Piyush Goyal demanded an apology from Congress MP Rahul Gandhi over his speech in London.

In response, Leader of Opposition Mallikarjun Kharge alleged that BJP is not following rules and demanded Goyal's words be expunged.

Earlier in the day, both the houses of Parliament were adjourned till 2 pm after the protesting Opposition leaders rushed to the Well of the House leading to a ruckus.

While addressing the lower house, Union Minister Pralhad Joshi started speaking on Congress leader Rahul Gandhi's recent speech in London.

The Opposition leaders rushed to the well of the house in protest leading to a ruckus in the Parliament. Following this, Lok Sabha speaker Om Birla adjourned the Lok Sabha till 2 pm.

The Rajya Sabha was also adjourned by the speaker Jagdeep Dhankar as a ruckus was created by protesting Opposition MPs.

Nepal Telecom reaches maintenance agreement with Chinese company billing issues



epal Telecom has reached a maintenance agreement with Asian Info, a Chinese company that has repeatedly caused problems in the billing system, EPardafas reported. According to EPardafas, Nepal Telecom has entrusted the company with maintenance at a cost of 3 billion rupees for four years, with a provision that the agreement can be extended for one year.

Asian Info had connected the current billing system with Telecom. The company has continuously been getting responsibility for the maintenance of the system. However, a recent investigation report by Nepal's Ministry of Communication and Information Technology, showed that the company has installed a decadeold 'outdated billing system', due to which the telecom network has been going down several times.

According to Nepal Telecom sources, it has been found that more than three billion rupees are not reflected in the billing every year due to problems in the billing system. Because of this, the income has been affected and the telecom itself has reached a state of collapse. As 1 to 1.5 per cent 'variation' is considered normal in the billing system, currently, up to 10 per cent variation occurs in telecom and sources say that high officials of the Nepal Telecom are involved in this. Telecom has been billing more than 32 billion rupees annually. According to 10 per cent of which, more than 3 billion 20 million rupees are missing, according to EPardafas.

There was a problem in Nepal Telecom's postpaid SIM account management system, a few weeks ago. Due to this problem, the postpaid user's amount was deducted. Even before that, due to problems in the billing system itself, the telecom network was disrupted across the country. After the problem came to light. the Ministry of Communications formed an inquiry committee. The committee, drawing the conclusion that the billing system is not only old but also non-standard, suggested that the billing system in Nepal Telecom should be changed. Managing Director of Telecom, Sunil Paudel has, however, signed a maintenance contract with the same Asian Info Company for five years. (ANI)

Hindu community of Pakistan to protest against forced conversions, abductions and marriages of minors

embers of Pakistan's minority Hindu community will organise a rally and converge at the Sindh Assembly building here later this month to protest the rising incidents of forced conversions, abductions and marriages of minors.

The rally, which is being organised by several Hindu community leaders in Sindh province, will be held on March 30, under the banner of Pakistan Darawer Ittehad, an organisation working for minority rights in the country.

Posters released by the organisation on social media said the rally is being held to protest the abduction, forced conversion and marriages of minor girls and forced possession of land belonging to the Hindu community in the Sindh province. "We are expecting thousands from the Hindu community to participate in the rally as the government has turned a blind eye to the abductions, forced conversions and fake marriages of our women and girls," Chairman of Pakistan Darawer Ittehad Faqir Shiva Kuchi said.

He said the outfit has already begun mobilising protest rallies across the province to raise awareness. "When this protest rally will be held on March 30, we want everyone to see the issues faced by Hindus and members from other minority communities in the country," he explained.

Kuchi added that their demand was that a stalled bill against forced conversion and marriages be passed in the Sindh Assembly. PTI

Russian wives called on Putin " Stop forcing husbands and sons to join assault groups'



group of Russian wives and mothers have called on President Vladimir Putin to stop sending their husbands and sons "to the slaughter" by forcing them to join assault groups without adequate training or supplies, CNN reported.

Independent Russian Telegram channel SOTA shared a video in which women said their loved ones had been "forced to join assault groups" at the beginning of March despite having just four days training since their mobilization in September. The video shows the women holding a sign in Russian that reads, "580 Separate Howitzer Artillery Division," dated March 11, 2023. One woman in the recording said: "My husband... is located on the line of contact with the enemy."

"Our mobilized [men] are being sent like lambs to the slaughter to storm fortified areas, five at a time, against 100 heavily armed enemy men," she continued. "They are prepared to serve their homeland but according to the specialization they've trained for, not as storm troopers. We ask that you pull back our guys from the line of contact and provide the artillerymen with artillery and ammunition," she said as quoted by CNN. CNN could not independently verify the claims made by the group of women in the video.

According to CNN, Russia's move to send hundreds of thousands to fight on the battlefields of Ukraine has generated dissent and protest and prompted many Russians, young men in particular, to flee the country. "We ran away from Russia because we want to live. We are afraid that we can be sent to Ukraine," said one man who asked not to be identified.

Families of drafted Russian men have criticized the mobilization, saying it is beset by problems such as discipline issues and lack of leadership from mid-ranking officers, non-existent training as well as logistical difficulties like insufficient uniforms, poor food and a lack of medical supplies. US Treasury, Federal Reserve Board, says depositors of SVB will access to their money

The US Treasury, Federal Reserve Board, and the Financial Deposit Insurance Corporation on Sunday (local time) announced that depositors of the failed Silicon Valley Bank will have access to all of their money starting from March 13. In a joint statement released by Secretary of the Treasury Janet Yellen, Federal Reserve Board Chair Jerome H Powell, and FDIC Chairman Martin J Gruenberg announced they would "fully protect" all depositors who had funds in Silicon Valley Bank, just days after regulators took control of the institution.

"Depositors will have access to all of their money starting Monday, March 13. No losses associated with the resolution of Silicon Valley Bank will be borne by the taxpayer," read the statement. After receiving a recommendation from the boards of the FDIC and the Federal Reserve, and consulting with the President, Secretary Yellen approved actions enabling the FDIC to complete its resolution of Silicon Valley Bank, Santa Clara, California, in a manner that fully protects all depositors.

In addition, Signature Bank, a New York bank, was also closed by regulators over the weekend. Signature depositors will also be made whole. "We are also announcing a similar systemic risk exception for Signature Bank. New York, New York, which was closed today by its state chartering authority. All depositors of this institution will be made whole. As with the resolution of Silicon Valley Bank, no losses will be borne by the taxpayer," added the statement. Shareholders and certain unsecured debtholders will not be protected. Senior management has also been removed. Any losses to the Deposit Insurance Fund to support uninsured depositors will be recovered by a special assessment on banks, as required by law. ANI

arginalized elements of life, in today's environment there is a need to protect childhood from the market Cultures are made of rituals, passing on them from generation to generation and build their palaces on memories. What future are we trying to give to our children by depriving them of the chemical from which our memories were made? There is no wonder if the children who do not even have any local taste, their memories also have objectivity. It should be a pity that their dearest people will be responsible for all this! About two decades ago ioint families were commonly found in villages. Families would have many children of our age. In many households, there was no concept of food, especially breakfast, but eating three meals a day was more like a rule. No matter where one went, whatever the time, he always used to go after having food. Possibilities like 'will eat outside' were not considered there. The children go to school at seven in the morning in the summer, till then Khan Due to not being ready, he used to eat the remaining food of the night as a snack. Breakfast was eaten during half the holiday, then lunch was eaten in the afternoon. In winter, when the school time started at 10:30 in the morning and at 4:30 when they came home after the whole vacation, the children would be very tired. Bread replaced grandma's bread However, in spite of that fatigue, his liveliness would remain intact. Then his grandmother would prepare tea and red chili chutney for everyone. As soon as they



arrived, they would bake the morning roti on the embers in the chulha and serve it with tea. She would give food and without asking any question, the children would gobble it up. Actually, the name of bread or double roti was not that popular in the villages during that period. Children would have only imagined if they heard about it from someone's mouth, because then generally such things hardly entered the rural farmer's family. Nowadays, seeing children eat everything with bottled chutney brought from the market, these memories seem far away and somewhat imaginary. The discipline

called eating has ended Now in the name of food The discipline that was there is over. There was no concept of ready-made breakfast in the village. Milk, buttermilk, curd, rabri, gram, moong dal, gram flour-onion curry, roti with raw onion or dry jaggery in summer, all this was in the fixed rules of eating. The taste was linked to the land, the food and vegetables grown indigenously in the fields had their own taste. The goods of the market were brought to meet the needs, and not for hobby, show or entertainment. But then things changed not slowly, but aggressively. based on existing internet. In the era, the market spread

everywhere. In such a situation, what was to be saved even for the food plate! Now the villages have left the cities behind in terms of food and drink for the children. Nowadays it is difficult to find such children even in the village, whose mind is not satisfied with eating curd or who is fond of milk. It is surprising that parents have started taking this aspect of parenting so seriously keeping aside all other responsibilities as a way of modernity. Whether they give good ideas to their children or not, the slavery of the market and their show off These are going on giving. Parents feel proud to say that our child does not even touch bread or the children of today do not eat anything at all. He is also heard saying about these children that even if they are fed canned food for a hundred rupees a day, they will eat it. The question is, do any parents ever think about why children do not eat. Second, the important question of whether children really don't eat or we don't want to feed them has been completely ignored. Is. In fact, in the frenzy of providing all kinds of facilities to the children, we are not only cutting them off from their roots, but are also playing with their health. We have created a wrong definition of modernity and facilities. We have our memories in our values and we only care about those shortcomings, which remained in our childhood. That's why we are trying to satisfy our memories by fulfilling them in our children. But this is probably the wrong way. Every time and generation has its own kind of needs. What was a dream for us yesterday, is today It is a strange reality for children. We need to protect their childhood from the market. There is a need to retain them as children rather than consumers as long as possible. They need to be given ideas, discretion and clear vision, not objects.
