218 Private Schools 'Illegally' Running in Mumbai

Under the jurisdiction of the Brihanmumbai Municipal Corporation (BMC) education department 218 primary unaided private schools are running without RTE Right to Education (RTE). some of the schools have failed to renew their recognition certificates which are authorization under the RTE Act. Most of the well-known schools around the city have made it to this list of 'illegally' run-

ning school, reports stated. This data is reviled under the RTI query made by Maharashtra Rajya Vidyarthi, Palak, Shikshak Mahasangh, a parent organisation.

Anandilal Podar High School (Santacruz), Raje Shivaji primary school (Dadar), St Michael's high school (Mahim), St Andrew's high school primary section (Bandra). St Aloysius primary school (Santacruz), The Alexandra Girls High School

(Fort), Gloria convent (Byculla), St Pius X high school (Nahur), Dr Sarvepalli Radhakrishnan Vidyalaya (Borivli), Rustomjee Troopers (Dahisar) and VPM's Vidya Mandir primary school (Dahisar) being a few of such schools. For those unversed, according to the Right of Children to Free and Compulsory Education Act, schools are required to renew their RTE approval every three years.

Such school having no Right to Education may have to pay fine of INR 10,000 per day until they fulfill the canons, as well as for operating the school without recognition is violation of rules. Every year, after receiving RTE approval, the school administration is required to submit the balance sheet to the government and parents. However, the government's inaction has provided an easy escape for many private schools.

We all must know that the office of the governor under the constitution of independent India is overall altered from the provincial governors of the Maurya, Mughal or British empires. The Governor's role and purposes had been broadly debated by some of the think tanks of the Constituent Assembly like Dr. Ambedkar, Dr. P.S. Deshmukh, T.T. Krishnamachari, H.V. Kamath, Pt. H.N. Kunzru, Alladi Krishnaswamy Ayyar, Rohini Kumar Chaudhury, Shibban Lal Sakshena, K.M. Munshi .

Their understanding was that the proposed constitution was creating 'responsible government' in the states as much as at the centre — that is, responsible alone to the respective legislatures, that the states

were indeed sovereign within their own domain, that the discretionary power, beyond the specific situations mentioned in the constitution, does not enable a governor to override the state government.

As Dr. Ambedkar had said, "I have no doubt in my mind that discretionary power is in no sense a negation of responsible government. It is not a general clause giving the governor power to disregard the advice of his ministers in any matter in which he finds he ought to disregard." Therefore, selecting a chief minister of his choice or creating/utilising opportunities for defections to change the party in power cannot be a governor's job.

The MVA government and governor have been engaged in a series of spats over various issues. In February, the state government denied Koshiyari permission to use the state's airplane to travel to Dehradun.

While the legislature has the power to amend the rules and they followed similar process in the Lok Sabha. Maharashtra adopted the same process of electing the Speaker by voice vote.

The tussle between the governors and the ruling party of the state is not new to Indian politics. Remember how Delhi Chief Minister Arvind Kejriwal used to stage continuous protests against then the Lieutenant Governor. The Governor troubled him on various issues. When Arvind kept power for the second time his challenges to deal with Lieutenant Governor minimised.

Similarly, during the last few years, the governors of Karnataka, Madhya Pradesh, Kerala, Maharashtra and, of course, West Bengal have played their roles in such a way as to make them highly debatable without essentially adding to the glory of the position and Raj Bhavan. The negative image of the state governors as "a proxy of the centre" has proved difficult to wipe out.

The MVA government and governor have been engaged in a series of spats over various issues. In February, the state government denied Koshiyari permission to use the state's airplane to travel to Dehradun. Last October, Koshiyari and the CM wrote letters to each other over the reopening of places of worship. The Governor ridiculed the CM as "secular" while Thackeray reminded him of the Constitution and the oath he had taken.

In September 2021, Governor wrote to CM following the Saki Naka rape incident, asking him to hold a two-day special session over security for women in the state. In response, Thackeray wrote back to Koshiyari, saying that since violence against women was a national issue, Koshiyari should request Prime Minister Modi and Union home minister Amit Shah to call a four-day special session of the Parliament to discuss the same. The present controversies have been around the issues of the speaker's election. On December 28, the state passed the Maharashtra Public Universities Act Amendment Bill to curtail the powers of the Governor in appointing vice chancellors of various universities.

The Governor said he had never questioned the prerogative of the House in the matter of its procedure/proceedings but he could not be pressured to give consent to a process "which prima facie appears to be unconstitutional and illegal, as enshrined in Article 208 of the Constitution". Well! The Article 208 (I) of the Indian Constitution empowers each House of Legislature of a State to make Rules for regulating

its procedures and conduct of its business. For nearly one year, the Governor has not approved the nomination of 12 members to the Legislative Council. But there are letter of exchange between the ruling party and governor. The government had planned to hold the election for the Speaker's post on December 28, through voice vote instead of the secret ballot.

The government has emphasized that the amendments are constitutional and the legislature has followed all procedures to make them. Also, the same practice is followed in the Lok Sabha and other states and that the Governor needs to act on the advice of the state cabinet. However, the Opposition had objected to it, stating that rules of the Speaker's election cannot be amended in the absence of the Speaker and called the MVA government the "most insecure government".

While the legislature has the power to amend the rules and they followed similar process in the Lok Sabha. Maharashtra adopted the same process of electing the Speaker by voice vote. It followed the same tradition in other states. Therefore, the decision taken by the Maharashtra legislature is not unconstitutional.

Under Article 178 of the Constitution, the Assembly chooses the Speaker, which means it is an internal procedure of the House and the Governor has nothing to do with it. Similarly, Article 208 of the Constitution also states that the House decides the internal matter of the legislature; however, it must be in conformity with the Constitution, which has been followed in this case. It again means that it is the prerogative of the state Assembly whether the election is conducted by a secret ballot system or voice vote etc. Every Legislative Assembly of a State shall, as soon as may be, choose two members of the Assembly to be respectively Speaker and Deputy Speaker thereof and, so often as the office of Speaker or Deputy Speaker becomes vacant, the Assembly shall choose another member to be Speaker or Deputy Speaker, as the case may be.

National Green Tribunal has to direct the state governments to take remedial action against illegal sand mining, especially in a submerged water area. Extraction of sand-mainly through an open pit -mined from beaches and inland dunes or dredged from ocean and river beds. Beach sand may contain garnet, leucoxene, sillimanite, and monazite. Sand mining presents opportunities to extract rutile, ilmenite, and zircon. Sand mining is the world's largest mining endeavor, responsible for 85 percent of all mineral extraction. The disturbance of underwater and coastal sand is due to illicit sand mining. It can also destroy fisheries,

India's puppeteers struggle to survive

You must have probably familiar with puppets and if you're like most people, you must have probably seen a puppeteer in action and may have even played with a puppet yourself. Every year 21st March is celebrated as World Puppetry Day to recognize puppetry as a global art form. Puppetry is considered to be one of the oldest forms of storytelling in the country. Puppetry is a real challenge to the imagination of the individual and is one of the oldest forms of entertainment. Puppetry is a beautiful and colourful art. It is so sad to see that puppeteers are slowly fading away.

Puppetry is an animated visual art form. Kathputli that means a puppet which is made from wood. Whereas the words kath means 'wood' and putli means 'a doll or toy'. The craft of making Kathputli, was practiced by a community of performing artists. The puppeteer uses his or her skills to makes the puppet, an inanimate object, talk, sing, dance and behave the way humans do.

Most of the puppeteers around the country and even in Gujarat are of the opinion that that the competition from cinema and TV had hit them hard. As one puppeteer from Ahmedabad Ramesh Rawal 72 Year old an Indian folk and Puppet Artist says "Television, especially, has given us a big blow". Rawal a puppet artist from Ahmedabad, Gujarat who has participated in various International Puppet festivals in Afghanistan, Tehran, Iran, Rome, Italy, Japan and in various places of India, is striving very hard to keep the culture of puppet shows active but he is helpless as he is not getting any support from concerned authorities. The Puppetry has been his family profession since many generations. Over a period of time, the colourful art started fading away and the artists like Rawal started struggling to get any work opportunities. The prospects of making good money from doing puppetry shows are quite minimal now-a-days. Modern day entertainment options like television, movies and the internet are pushing traditional puppetry towards



a slow death. In order to keep the culture and heritage of our nation alive with more charisma, we need to keep Educational Puppet shows in schools in such a way the students can easily grasp a certain topic. Puppeteers through cultural exchange can learn new techniques and apply in their performance. Schoolchildren are often attracted by puppets and interact strongly with them as they help them to overcome shyness and stage fear. Puppet shows have powerful visual impact and establish direct rapport with the audience. It can be tailored to promote civic sense, promote awareness of socio-economic problems and national issues.

The concerned officials and politicians must make puppet shows an integral part of cultural functions and festivals in villages, towns and cities. On a personal level, wealthy patrons can also arrange for puppet shows during their celebrations. Puppet shows are one of the notable marvels in the lap of the heritage of India. It is quite essential to maintain the trade of ancient artworks. . Due to the lack of patronization of government and lack of audience interest, most of the people engaged in puppetry quit from it and are involved in other lucrative source of Income but all cannot afford. Poor puppeteers like Ramesh Rawal are not able to introduce modern techniques in their performance due to Lack of sponsors. Further, many of the puppeteers of old puppet troupes are not adequately literate. Most of the traditional Puppeteers are not willing to teach puppetry to their children as they do not want to see their

children in problem, as puppetry cannot provide adequate money to live life. Schools can arrange for puppet shows on different themes from which the children can learn new things. Teenagers can easily search valuable information, which is not in their textbooks, in a novel way. Puppets provide a way of holding children's attention and in a way helps in behaviour change.

The families of puppeteers like Ramesh Rawal see a new hope to revive the lost art of puppetry to help them earn a little more than what they usually get.

Let us understand that Puppets are a different mode of communication. Besides entertainment, these dolls convey social message to everybody, irrespective of age groups. It is clear that Puppetry is one of the arts facing extinction. Government must think over for a permanent source of income to provide them livelihood on a regular basis, Let us make efforts to breathe life into it by introducing it to school students and also in financial literacy. It will be worthwhile for the government to look into the neglected art form and evolve schemes for its revival in a big way. Let us make an effort to bring back this art form viz puppeteer back in action.

Amruta Fadnavis bribe FIR: Bookie Anil Jaisinghani held from Gujarat



A bookie from Ulhasnagar, Anil Jaisinghani, has been arrested by the Mumbai crime branch from Gujarat's Godhra following a three-

day hunt. He was named as a co-accused in the case related to alleged blackmailing of Amruta Fadnavis, wife of deputy CM Devendra Fadnavis. Apart from

Anil, his daughter Aniksha was arrested last week in a case pertaining to offering Amruta Rs 1 crore bribe to get the man off the hook in a police case.

Meanwhile, the Opposition boycotted the Maharashtra Legislative Assembly alleging that the government is delaying panchnamas of farm lands affected by hailstorm and unseasonable rains. Revenue Minister Radhakrishna Vikhe-Patil said that the state government has no intention to hide any losses and it will do thorough panchnamas and ensure that relief aid is given. However, Opposition leader Ajit Pawar alleged that due to ongoing strike of government employees the panchnamas are not being conducted.

Flyer dies on flight to Mumbai from Bangkok



A passenger on board an IndiGo flight from Bangkok to Mumbai on Sunday suffered a heart attack and passed away. The flight was diverted to Myanmar due to the medical emergency. According to a flyer on board IndiGo flight 6E-57, the passenger suffered a heart attack less than an hour after the flight took off from Bang-

kok at 4pm, local time. He said that the passenger died and the flight was diverted to an airport in Myanmar. It took off from Yangon about five hours later. This is the second medical emergency diversion in the past two days. On Friday, a Ranchi-Pune flight was diverted to Nagpur after a passenger took ill. The flyer was later declared dead at a local hospital.

4 months, 50 rallies in Maharashtra, one theme: 'Love jihad', 'land jihad' and economic boycott



Starting November last year, at least 50 'Hindu Jan Aakrosh Morcha' rallies have been held across Maharashtra, in almost all of the state's 36 districts. Each of these events has followed a set pattern: a brief march through the heart of the city, amid a sea of saffron flags and caps, followed by a short rally, where speakers on a makeshift dais attack minorities, invoke "love jihad", "land jihad", "forced conversions", and call for the economic boycott of the Muslim community.

In other news, a fortnight

after Shiv Sena (UBT) chief Uddhav Thackeray held a rally in Ratnagiri district's Khed, Chief Minister Eknath Shinde on Sunday addressed a gathering at the same venue in a show of strength. Stressing that his party is "the real Shiv Sena", the Chief Minister took a dig at Thackeray, using terms such as "fuska baar" (a defused bomb) and "a circus" for his rally. The rallies were considered to be a major show of strength for both factions in Konkan, which is considered to be the bastion of the undivided Shiv Sena.

'Book presents authentic picture of Shivaji Maharaj's life and times': author Shrimant Kokate

Popular Marathi author and historian Shrimant Kokate, whose first book in English, Chhatrapati Shivaji Maharaj (illustrated) was launched recently, said he has made effort to present the Shivaji era correctly before the world, at a time when some authors are distorting history and trying to belittle the grand image of the Maratha king.

"Chhatrapati Shivaji Maharaj is known as a great king, not only in Maharashtra or India, but people across the world adore and respect him. His achievements are a great inspiration to the society, which makes it necessary to pres-



ent his journey on the basis of facts. I have made sincere efforts to bring forward the authentic

history of the great king," Kokate told The Indian Express after an event in the city on Sunday.

Maharashtra govt employees call of strike

Maharashtra government employees called off their strike after a meeting between employees' representatives and Chief Minister Eknath Shinde. The state government approved the in-principle extension of monetary benefits like the Old Pension scheme to those who are part of the new pension scheme. A total of 17 lakh government, semi-government, teaching and non-teaching staff were on strike from March 14.

HC allows SP MLA to convert plea against Maha inter-faith marriage panel into PIL

The Bombay High Court on Monday permitted Samajwadi Party MLA Rais Shaikh to convert his petition against the Maharashtra government's decision to set up an inter-faith marriage coordination committee into a public interest

litigation (PIL).

A division bench of Justices Gautam Patel and Neela Gokhale noted that the petition seemed to be in the nature of a PIL and hence the petitioner (Shaikh) could convert the same into a PIL. (PTI)

Air India urination case: Passenger moves to SC for not receiving support from SOPs



A 72-year-old woman, at the centre of headlines after a co-passenger allegedly urinated on her on board a New York-Delhi Air India flight last November, has moved the Supreme Court seeking a direction to the Directorate General of Civil Aviation (DGCA) and airlines to frame SOPs to deal with such incidents.

The woman said she was constrained to approach the court because Air India and the DGCA failed to treat her with care and responsibility after the

incident. "In addition, the wide-ranging national press reportage full of conjecture and surmises has severely undermined the petitioner's rights as a victim under Article 21 of the Constitution, and in fairness has also affected the rights of the accused as well. Their rights to a free and fair trial have also been substantially affected due to a selective leaking of the 'AIR SEWA' complaint of the petitioner, the FIR and selective witness statements being released to the media to match specific narratives," she said in

her plea.

The petition said an absence of clear guidelines for media outlets on what requires reporting, whether they ought to make conjectures where matters are sub-judice, and the impact of media coverage based on unverified statements end up impacting the victim as well as the accused.

The petitioner further said her intentions were inspired and motivated in the interest of the general public and are a sincere attempt to set up a framework within the airline industry so that such incidents are prevented, and if they do occur, they are dealt with in a manner that does not cause additional trauma to the passengers.

She also sought a direction to the Union Civil Aviation Ministry and the DGCA to ensure that Civil Aviation Requirements (CAR) norms adhere to the highest standards laid down internationally. The woman sought directions to the DGCA and the airline companies to comply with legal requirements of the SOPs, operation manuals and reporting protocols to be followed by airline crew and staff. Rahul Gandhi announces "unemployment allowance for the youth" to fight against BJP in upcoming Karnataka polls



Congress leader Rahul Gandhi on Monday called on party leaders in the state to fight the BJP with unity, as he exuded confidence of "sweeping" the forthcoming Karnataka Assembly polls with absolute majority.

He also announced unemployment allowance for the youth, as the party's fourth poll guarantee, on coming to power. The Congress has already announced three poll guarantees' 200 units of free power to all households (Gruha Jyoti), Rs 2,000 monthly assistance to the woman head of every family (Gruha Lakshmi), and 10 kg of rice free to every member of a BPL household (Anna Bhagya).

Addressing a public rally at Belagavi in northern Karnataka, Gandhi hit out at the BJP-

led Central government, saying "this country belongs to everyone, does not belong to two to three selected, it is not Adani's". "Select people, who are BJP's friends, are getting all the benefits. It is leading to corruption," the Wayanad MP alleged.

Gandhi and AICC President M Mallikarjun Kharge, who hails from the state, said an unemployment allowance of Rs 3,000 per month would be given for graduates and Rs 1,500 for diploma holders for two years in the event of the party gaining power in the State, where Assembly elections are due by May. Gandhi attacked the Basavaraj Bommai government in Karnataka, dubbing it as the "most corrupt government". "It is a 40 per cent commission government," he claimed. PTI

SC refuses to stay at Karnatak HC order to conduct board exams of class 5 and 8

The Supreme Court on Monday refused to stay a Karnataka high court order allowing the government to conduct board exams for students of Classes 5 and 8 studying the state board syllabus. A bench of Chief Justice DY Chandrachud and Justices PS Narasimha and JB Pardiwala, however, agreed to hear on March 27 a plea filed by as-

sociations of unaided private schools against the high court order. The matter was mentioned before the bench seeking an urgent hearing.

"Let's not interfere with the high court order. The high courts know what is best in that state," the bench said and added that it does not want any uncertainty to prevail. A division bench of the high court on March 15

had stayed an order of a single bench, which had set aside circulars dated December 12 and December 13, 2022, and January 4, 2023, issued by the Commissioner of Public Instructions and the Department of State Education. The single bench had said the circulars are contrary to the intentions of the Right to Education Act under which they were issued. PTI

J&K Lt Governor Manoj Sinha says, "Will Quit if any proves fraudulent recruitment" over Aptech appointment

Jammu and Kashmir Lt Governor Manoj Sinha on Sunday said the recruitment process in the Union Territory was fair and vowed to quit if anyone proved otherwise. For the first time in history, results of the Jammu and Kashmir Administrative Services examination were declared within three hours of the

last candidate's interview.

His remarks come amid criticism of the government's decision to appoint Aptech, a previously blacklisted agency, to conduct the Jammu and Kashmir Services Selection Board recruitment examination. "Questions have been raised on selections. For the first time after Independence

when the last candidate was interviewed in the Jammu and Kashmir Administrative Services examination, the results were announced within three hours of that. "If anyone alleges that one fraudulent recruitment has been made, I will leave Jammu and Kashmir the next minute," Sinha said here. PTI

India records 918 new Covid-19 cases, 4 deaths

India saw a single-day rise of 918 fresh coronavirus cases, while the active cases rose to 6,350, according to the Union health ministry data updated on Monday. The country's COVID-19 death toll has increased to 5,30,806, with four latest fatalities -- two reported by Rajasthan, one by Karnataka and one death reconciled by Kerala. According to the data updated at 8 am, the daily positivity was recorded at 2.08 per cent while the weekly positivity was pegged at 0.86 per cent.

The infection tally stands at 4.46 crore (4,46,96,338). The active cases now comprise 0.01

per cent of the total cases, while the national COVID-19 recovery rate has been recorded at 98.8 per cent, according to the health ministry website. A total of 92.03 crore tests for detection of Covid have been conducted so far with 44,225 tests conducted in the last 24 hours. The total number of people who have recuperated from the disease surged to 4,41,59,182, while the case fatality rate was recorded at 1.19 per cent. According to the ministry, 220.65 crore doses of Covid vaccine have been administered in the country so far under the nationwide vaccination drive. PTI

Japanese PM Fumio Kishida held talks with PM Modi

PM Fumio Kishida, who arrived in New Delhi early this morning for a two-day visit, held a meeting with PM Modi at the Hyderabad House. Kishida invited PM Modi for the G7 leaders meeting scheduled to be held in Hiroshima in May this year.

After the meeting, PM Modi in a joint statement said, "Today Japanese Prime Minister Fumio Kishida invited me to the G7 Leaders' Summit which will be held in Hiroshima in May. I thank him for this."

"I welcome Japanese PM Fumio Kishida to India. In the last one year, PM Fumio Kishida and I have met several times and



every time I've felt his positivity and commitment to the India-Japan bilateral relationship. His today's visit will be beneficial to maintain this momentum," he added.

PM Modi called today's meeting a "great opportunity" to work together keeping the goals of both nations in mind. PM

Modi said he is happy to be able to welcome his Japanese counterpart again in September this year for the G20 Summit.

PM Modi said that he spoke to Kishida regarding India's G20 goals and priorities. In his statement after the talks, PM Modi said this meeting aims to give a voice to the global South and

strengthen the India-Japan relationship.

He said, "I have spoken to him regarding India's G20 priorities in detail. Our main priority is to give voice to the needs of the global south."

He said that the culture that believes in "Vasudhaiv Kutumbakam" believes in taking everyone along. In a joint statement after meeting PM Modi, Kishida called India an "indispensable partner" of Japan.

He said, "It gives me great pleasure to be able to unveil my new vision on the soil of India which is our indispensable partner in realising a free and open Indo-Pacific."

In the joint press statement, the Japanese PM said, "I formally invited PM Modi to G7 Hiroshima Summit and on the spot, my invitation was immediately accepted."

Speaking about the economic cooperation between Japan and India, Kishida said, "Our economic cooperation with India which continues to grow rapidly will not only support the further development of India but also create significant economic opportunities for Japan. In this regard, we welcome that steady progress is being made towards realising 5 trillion yen of public & private investment in financing from Japan to India in 5 years."

Over 70 countries, including EU express concerns over Afghan women's rights, education

As the Taliban continues to suppress women and restrict their fundamental rights in the country, the European Union (EU) along with more than 70 countries in a joint newsletter on Sunday expressed concern over the situation and said that these restrictions undermine economic and social stability and development in Afghanistan, Khaama Press reported.

The letter further stated that one of every three aid workers in the country is a woman, and as a result, they are no longer allowed to assist women and other people in need.

According to the statement, restrictions on Afghan women

working for domestic and international non-governmental groups would prevent millions of Afghans from receiving humanitarian aid, Khaama Press reported.

Ban on education and other fundamental rights of women is undermining inclusive governance and the recognition of human rights, the statement read further.

The de facto authorities have restricted women's and girls' freedom of movement since August 15, 2021, preventing girls from attending secondary education, excluding them from the majority of the workforce, and forbidding them from utilising public parks, gyms, and bathrooms.

In a recent move, the Organization of Islamic Cooperation (OIC) is all set to send a team of scholars to the country to discuss women's right to education and work with the regime, TOLONews reported as female education continues to suffer majorly in Afghanistan.

The Secretary General of the Organisation of Islamic Cooperation, Hissein Brahim Taha announced the scholars' team on the first day of the Organization of Islamic Cooperation's meeting in Mauritania.

Almost 40 countries sent representatives to the 49th OCI meeting, which took place in Mauritania on March 16 and 17, TOLONews reported.

Afghan families call on Taliban to reopen schools for girls above grade 6



Families in Afghanistan called on the Taliban yet again to open schools for girls in grades 7 to 12 as they are worried about the future of their daughters in the country under the regime of the organisation, TOLONews reported.

This comes as Afghanistan enters a new education year, however, the female students in the country are still denied their basic right to attain education.

Since the Taliban took control of Afghanistan, schooling above grade six has been closed, which, later in December last year, barred girls and women from going to universities and working with NGOs.

In a statement given to TOLONews, the families lamented over the ongoing situation in the country and said that the cruel de-

cision of the de facto authorities has put the future of their daughters at stake.

"I have four grandchildren who did not attend school and are now staying with me. They should decide whether or not to attend school," Kabul resident Abdul Jalil said.

In a separate statement, another resident, Raziq said, "I have two daughters. One of them is in grade 8 and another one is in grade 10. We are calling on the Islamic Emirate to allow them to go to their schools."

This comes as female pupils have also expressed sadness over their schools closing. Zainab, a student, stated, "We urge the Islamic Emirate to reopen the schools for us so that we can finish our education," according to TOLONews.

Putin tells Xi they will discuss China's Ukraine peace plan

Russian President Vladimir Putin on Monday told Chinese President Xi Jinping that he had looked at China's proposals for a resolution of the Ukraine conflict and that he viewed them with respect, reported Reuters.

Putin tells Xi Jinping, who is in Moscow for a three-day state visit to Russia, that they will discuss China's Ukraine peace plan.

Xi arrived in Moscow to meet with President Putin, a state visit that will highlight their nations'



close ties amid the war in Ukraine and will be closely watched by Kyiv and its Western allies.

Xi Jinping told President Putin that he was convinced that Putin enjoyed the Russian people's support ahead of a presidential election scheduled for next year, it reported.

Speaking at informal talks at

the start of Xi's state visit to Moscow, Putin also said that Russia was "slightly envious" of China's rapid development in recent decades.

Meanwhile, Ukraine and the United Kingdom have called on the Chinese leader to use his influence and press Moscow to end the war.

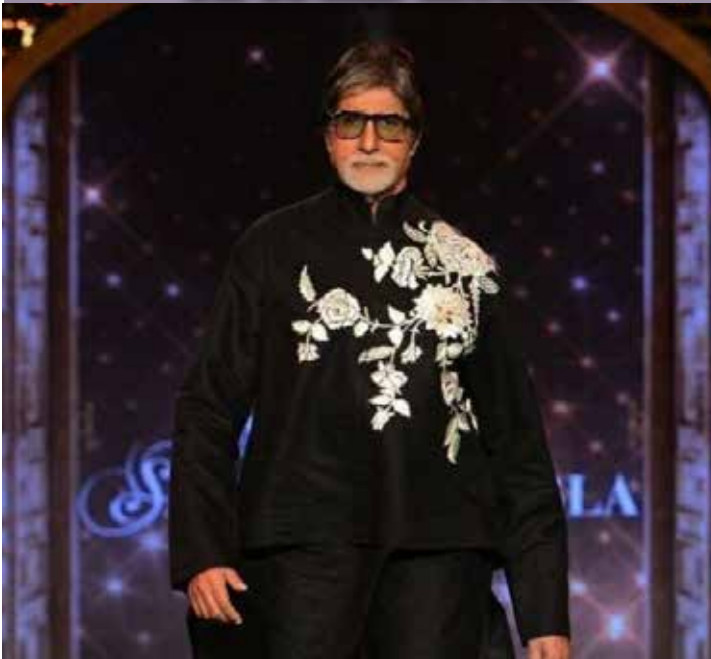

America is becoming a cultureless country – this nation is riding on physical development and weapon culture. The citizens there can keep as many arms as they want. In some places even a license for arms is not required. There are very few homes in America that do not have a gun or pistol. This weapon culture of America is connected with its birth. It has become prosperous on this weapon culture and has ruled the world. Today the same violent weapon culture is taking a heavy toll on its own.

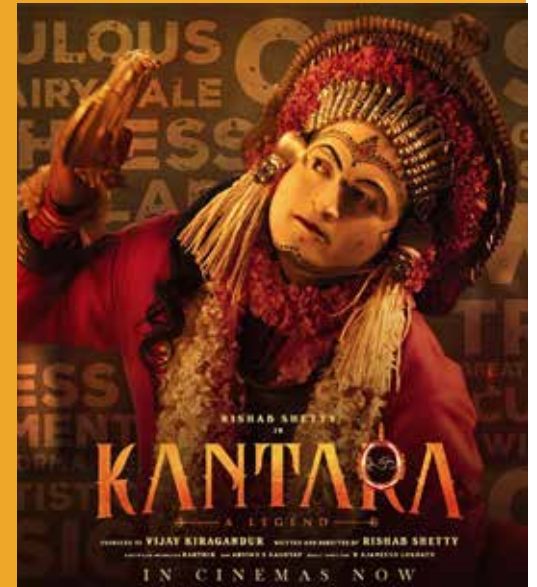

Film 'Kantara' was screened at Pathe Balexert theatre Geneva

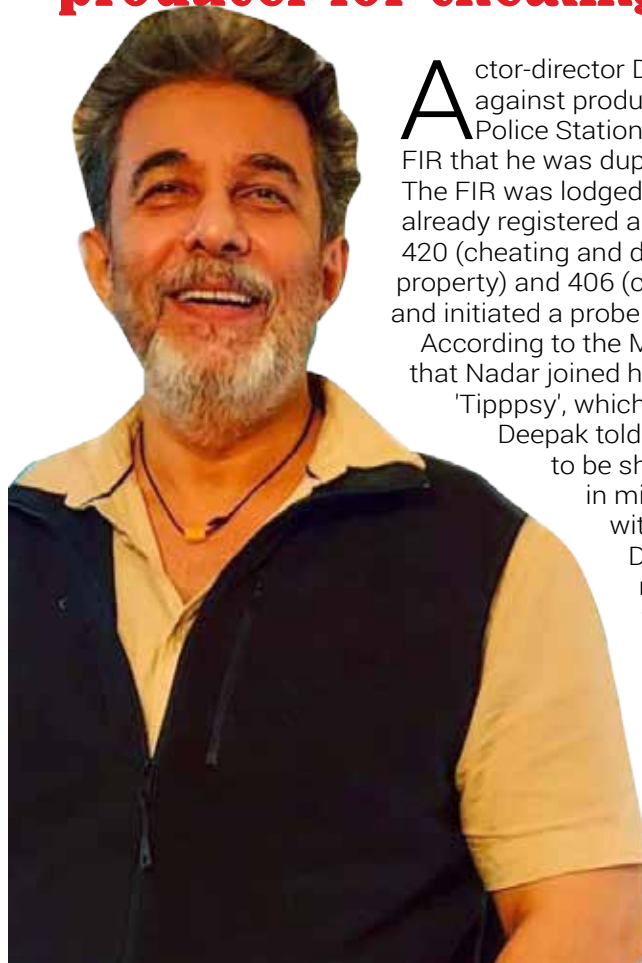
