n Thursday (March 23), Gandhi was held guilty and sentenced to two years in jail by a Surat court in a 2019 defamation case, over his remarks about the "Modi" surname. The conviction prompted the process of his disqualification as a lawmaker. A notice issued by the Lok Sabha Secretariat said he stood disqualified from the House from March 23. the day of his conviction. Rahul Gandhi has to now move a higher court and get his conviction staved

Chief Judicial Magistrate HH Verma convicted Gandhi in a 2019 defamation case, for saying 'why do all thieves have the name Modi', and sentenced him to two years in prison. The remarks were made during a rally in Kolar, Karnataka, in the run-up to the 2019 Lok Sabha elections. "Why do all thieves, be it Nirav Modi, Lalit Modi or Narendra Modi, have Modi in their names," Gandhi had said in Hindi. Section 500 of the Indian Penal Code (IPC) prescribes for defamation a simple imprisonment for a "term which may extend to

two years, or with fine, or with both." The court also approved Gandhi's bail on a surety of Rs 15,000 and suspended the sentence for 30 days to allow him to appeal.

Disqualification of a lawmaker is prescribed in three situations. First is through the Articles 102(1) and 191(1) for disqualification of a member of Parliament and a member of the Legislative Assembly respectively. The grounds here include holding an office of profit, being of unsound mind or insolvent or not having valid citizenship. The second prescription of disqualification is in the Tenth Schedule of the Constitution, which provides for the disqualification of the members on grounds of defection. What does the RPA say?

There are several provisions that deal with disqualification under the RPA. Section 9 deals with disqualification for dismissal for corruption or disloyalty, and for entering into government contracts while being a lawmaker. Section 10 deals with disqualification for failure to lodge an account of election expenses. A key provision, Section 11, deals with disqualification for corrupt practices. Section 8 of the RPA deals with disqualification for conviction of offences. The provision is aimed at "preventing criminalisation of politics" and keeping 'tainted' lawmakers from contesting elections.

First, disqualification is triggered for conviction under certain offences listed in Section 8(1) of The Representation of The People Act. This includes specific offences such as promoting enmity between two groups, bribery, and undue influence or personation at an election. Senior Samajwadi Party leader Azam Khan lost his Uttar Pradesh Assembly membership in October 2022 after he was convicted in a hate speech case. Defamation does not fall in this list. Section 8(2) also lists offences that deal with hoarding or profiteering, adulteration of food or drugs and for conviction and sentence of at least six months for an offence under any provisions of the Dowry Prohibition Act.

Section 8(3) states: "A person convicted of any offence and sentenced to imprisonment for not less than two years shall be disqualified from the date of such conviction and shall continue to be disqualified for a further period of six years since his release." The disqualification can be reversed if a higher court grants a stay on the conviction or decides the appeal in favour of the convicted lawmaker. In a 2018 decision in 'Lok Prahari v Union of India', the Supreme Court clarified that the disqualification "will not operate from the date of the stay of conviction by the appellate court."

Significantly, the stay cannot merely be a suspension of sentence under Section 389 of the Code of Criminal Procedure (CrPC), but a stay of conviction. Under Section 389 of the CrPC, an Appellate Court can suspend the sentence of a convict while the appeal is pending. This is akin to releasing the appellant on bail. This means that Gandhi's first appeal would be before the Surat Sessions Court and then before the Gujarat High Court.

### Buying house in Mumbai is challenge for commoners



The Union Budget 2023 empowered self-help groups and introduced a savings scheme, among other measures to empower women with financial freedom. As Maharashtra's new government led by Eknath Shinde announced its first budget, the focus was on benefits for women. Following the success of cash transfer schemes in India, Maharashtra's deputy CM Devendra Fadnacis announced Rs 90,000 for girls in the state. Following the birth of a girl child, the family will get Rs 5,000, and Rs 4,000 when she is in fourth standard in school, Rs 6,000 in sixth and then Rs 75,000 when she turns 18. The cash transfer

will be provided for girls from families which have yellow and orange ration cards. Women will also get a 50 per cent discount for travelling on buses and trains.

Stamp duty discounted by 1 per cent for women will also make home purchases less expensive for them. It will also increase the number of properties registered in the name of women. The government had been looking at demands for reducing stamp duty since it came to power last year, in order to boost affordable housing.

Apart from these financial incentives, separate hostels will be set up for providing legal help, counselling and other required assistance for survivors of sexual exploitation. Yes, the steel and cement prices may have come down but labour costs have gone up, statutory dues have gone up and there is no significant reduction in land pricing happening. The worst-affected pockets across India such Greater Noida, Ghaziabad, Mumbai, Navi Mumbai and Chennai, where sales pace has dropped to a level that it will take 36 months and more for all existing stock to be cleared, developers need to struggle. But even in these real estate markets and others, credible developers with a delivery track record will continue to command a pricing premium. Many developers who have been lax and taken the buyer for granted have realized that fixing their business is the only way to win the buyer back. The focus has shifted from launching new projects to delivering existing ones.

Indian buyers usually pay for apartments before construction has been completed. Many buyers do not take-out mortgage loans. As a result, the ratio of housing loans to GDP is very low. In 2012, housing loans in India were only around 4.14% of GDP. The leading mortgage lender is the Housing Development Finance Corporation (HDFC) followed by the State Bank of India (SBI). Total housing loans in India were around INR 4,033.78 billion (US\$ 63.36 billion) in 2012, up by 12.3% from INR 3,590.67 billion (US\$ 56.40 billion) a year earlier. Economy is not growing at a greater rate. Foreign rating agencies and Investment firms predict our growth rate to be a bit+1 or -1% less than the government announced rate. Indian companies are in huge debt so they cannot raise money unless they clear the balance sheet. PSU banks are in huge debt; they are not in a position to fund new ventures. Real estate inventory is at an all-time high. People are on a wait and watch mode, Stamp duties across states ranges from 6 to 10% (very high). Only desperate buyers for a first home or buying new property. The second and third home buyers as investment options are going slow. Landowners who desperately need money are selling land at a discount based on their need. Developers who can withstand pressure are not selling.

The major reason for the lowering property rates in India is demonetization then GST and now lockdown. According to surveys, residential property prices are now falling in majority of Indian cities and the nominal house prices have risen in some cities of its premium areas. If we talk about real estate trends in Delhi/NCR, there is a lot of panic and shock among the builders because transactions will be closer to the circle rates and the rates have come down by 25% to 30%.

espite the huge strain on the state's exchequer, Deputy Chief Minister and Finance Minister Devendra in the budget refrained from announcing a hike in stamp duty or taxes. But now the proposal to increase the stamp duty is taken into consideration, reported Loksatta quoting high-ranking sources. Stamp duty in Mumbai, Pune indicates a possibility that the

cost of houses will be increased. If the proposal is approved then the stamp duty in Mumbai will be hiked to seven percent from its earlier six percent. The stamp duty in Pune, Thane and Navi Mumbai will go up to eight percent. In case one percent Local Body Tax and metro surcharge are applicable the stamp duty will be at eight percent whereas if LBT is not applicable then the stamp duty will be at seven per-

The report also added that the rate of recalculator has also been reviewed. The ready reckoner will increase in any areas of the big cities in the state. The state exchequer has been on a huge financial burden and the government has no option but to increase the stamp duty rate. Although the Goods and Services Tax (GST) revenue in increasing the fiscal deficit will move up to Rs 95,000 crore. The major sources of income for the state are stamp duty and taxes on cigarettes and liquor. This is why the state is considering hiking stamp duty. Meanwhile, the banks have this month increased their interest rates making loans more expensive for the common people, but if the read reckoner rate is increased then houses will become even more expensive.

# After almost three years Uddhav **Thackeray and Devendra walked** together at the legislature

fter almost three years since the Maharashtra Assembly polls and in the wake of their strained relations after the Shiv Sena split, former chief minister Uddhav Thackeray and Deputy Chief Minister Devendra Fadnavis had a jovial meeting in the public on Thursday, triggering speculations across the corridors of power. Thackeray, who arrived at the legislature building in the morning, was informed that Fadnavis's convoy was behind him. The former chief minister along with MLAs and MLCs from his Shiv Sena (UBT) waited for the BJP leader at the gate. Thackeray and Fadnavis exchanged greetings with smiling faces and had a jovial conversation. Later speaking to reporters, Thackeray said it was merely an exchange of greetings and nothing much. "In the past, the (political) atmosphere was more open. Nowadays it is said that discussions held behind a closed door turn out to be more fruitful. Therefore, if we ever hold a meeting behind closed doors, we will surely let you know," he said. Asked whether the meeting was the beginning of an end to the disagreement between the two, Thackeray

said that not every meeting took place with intentions. "We both came to the legislative building at the same time and therefore exchanged greetings," he said. The relations between Thackeray and Fadnavis soured after the former's party snapped ties with the BJP and joined hands with the Congress and the NCP to form the Maha Vikas Aghadi (MVA), after the 2019 Assembly polls. Last year, 40 Sena MLAs led by Eknath Shinde rebelled against Thackeray and formed a new government with the help of the BJP.

Shinde has won the battle in the Election Commission with the party name and its symbol going his way. The BJP has been targeting the Thackeray family since the formation of the MVA. At a recent MVA meeting, Thackeray told workers of the three parties to ensure that there would be no electoral alliance with the BJP in the future.A former chief minister from the Congress said that nobody should read too much into the meeting. "Maharashtra's political culture is such that leaders of parties with diametrically opposite ideologies share personal relations. Nobody should read too much into it," he said.

# Regional political parties moved to the Supreme Court against misuse of ED, IT and CBI

The petitioners, 14 regional parties have sought guidelines to fulfil and realise the guarantee of personal liberty under Article 21 of the Constitution for all citizens including those targeted for exercising their right to political dissent and for performing their duties as the political opposition. They have prayed for the triple test to be used by police officers, ED officials and courts alike for the arrest of persons in any cognisable offences except those involving serious bodily violence.Where these conditions are not satisfied. alternatives like interrogation at fixed hours or at the most house arrest be used to meet the demands of investigation.

The petitioner-political parties are: INC, DMK, RJD, BRS, TMC, AAP, Nationalist Congress Party (NCP), Shiv Sena (UBT), JMM, JD(U), CPI(M), CPI, Samajwadi Party, J&K National Conference. According to the petitioners, there has been an alarming rise in the use of coercive criminal processes against



opposition political leaders and other citizens exercising their fundamental right to dissent and disagree with the union government. Investigating agencies such as the CBI and ED are being increasingly deployed in a selective and targeted manner with a view to completely crush political dissent and upend the fundamental premises of a representative democracy, it was submitted.

The petitioner had prayed the principle of 'bail as rule, jail as exception' be followed by all courts especially in cases of non-violent offences. They have also prayed that bail be denied only where the triple-test is not met.In cases where special laws such as PMLA with stringent bail conditions are concerned, the petitioners have sought directions harmonies such bail with Article 21 of the Constitution. Where it appears that trial is unlikely to complete within 6 months, the accused be released on bail even under special laws unless the conditions under the triple-test are not fulfilled. The petition has been drawn and filed through advocate Shadan Farasat and settled by Senior Advocate Dr Abhishek Manu Singhvi.

# FM Sitharaman to setup committee into issues related to pension for govt employees

Inance minister Nirmala Sitharaman on Friday proposed setting up of a committee to look into the issues related to pension for government employees and evolve an approach to address the need of employees while maintaining fiscal prudence. While moving the Finance Bill 2023 in the Lok Sabha for consideration and passage, the minister also said the RBI will look into the issues related to credit cards payments for foreign tours not being captured under Liberalised Remittances Scheme (LRS)

Representations have been received that the national pension system for government employees needs to be improved, Sitharaman said. "I propose to set up a committee under the finance secretary to look into this issue of pension and evolve an approach

which addresses the need of employees while maintaining fiscal prudence to protect the common citizens. The approach will be designed for adoption by both central and state governments," the minister said.

The minister further said it has come to notice that payment for foreign tours through credit cards are not being captured under LRS and such payments escape tax collection at source. "RBI is being requested to look into this with a view to bring credit card payments for foreign tours within the ambit of LRS and tax collection at source there on," she announced. Several opposition members were in the well of the House raising slogans demanding setting up a joint parliamentary committee probe into the allegations against Adani group of companies. PTI

# Govt: 50% o respiratory infection cases admitted to hospital over two months are H3N2 influenza

n ICMR survey has shown that 50 per cent A of the respiratory infection cases admitted to hospitals in over two month are of H3N2 influenza, the government told the Lok Sabha on Friday. A total of 1,161 cases of H3N2, which is a subtype of seasonal influenza virus, have been reported between January 1 and March 20, Minister of State for Health Bharati Pravin Pawar said in a written reply. She said most of these cases showed symptoms of cough and fever.

The minister said H3N2 is a viral respiratory infection and antibiotics have no role in its treatment. However, she added, sometimes in a respiratory infection a bacterial infection may also occur and therefore physicians may prescribe an antibiotic to take care of the secondary



bacterial infection. According to the data shared by her, Delhi (370) reported the highest number of H3N2 cases followed by Maharashtra (184), Rajasthan (180) and Karnataka (134).

Pawar said the Health Ministry is monitoring the situation and taking steps to support states and UTs in management of influenza cases, including H3N2,

which include issuing an advisory for closely following the trend of influenza-like illness (ILI) or severe acute respiratory infection (SARI)Incre. The ministry has asked states and UTs to monitor the proportion of SARI cases among all infection cases and refer sufficient number of samples for testing for influenza, SARS-CoV-2 etc.PTI

n activist from the Geneva-based Universal Rights Group apprised the United Nations Human Rights Council (NHRC) of how stability and prosperity are returning to the Kashmir Valley.

In her intervention during the 52nd Session of the UN Human Rights Council in Geneva, the activist from J-K said, "More families are expected to come forward, sharing their experiences as stability and prosperity return to Kashmir."

Further sharing details of the

situation returning to normal in the Union Territory, the activist said, "As violence in Kashmir is on the decline and life returns to normal, there is a visible change in the attitude of the common Kashmiris."

Also sharing the "tough times" her family had experienced before things changed for the better in the UT, she said, "For the first time, numerous Kashmiri families have shared their inability to speak about atrocities committed by terrorist organisations. In 2003, my sister was brutally

She added, "Today, we are willing to speak up and soon. We spend decades in anonymity. Out of fear of retribution by militants and existing patriarchal structures all these years, the information vacuum was exploited by giving false impressions on the developments in Kashmir."

On her expectations from the Council, the activist said, "Taking the focus away from the perpetrators of terror is not enough for women to feel secure. Acknowledgement and moral support for these families and protection of human rights shall go a long way in establishing the desired comfort zone."

She concluded her intervention with an appeal to the UNHRC, "It is a humble request to Human Rights Councils that the voices of Kashmiri victims of terror be heard by the international committee and effort be made to sensitise the world about

# **China 'firmly opposes'** forced sale of TikTok



hina said it would strongly oppose any forced sale of TikTok, responding for the first time to Biden administration demands that the video app divest itself from its Chinese parent ByteDance or face a US ban, reported CNN.

China's commerce ministry said on Thursday that a forced sale of TikTok would "seriously damage" global investor confidence in the United States.

"If the news (about a forced sale) is true. China will firmly oppose it," Shu Jueting, a spokeswoman for the ministry, told in a news conference in Beijing, adding that any potential deal would need approval from the Chinese government, reported CNN.

"The sale or divestiture of TikTok involves technology export, and administrative licensing

procedures must be performed in accordance with Chinese laws and regulations," she said.

Previously, Beijing didn't weigh in directly on a potential forced sale.

However, starting in 2020, it had signalled it wanted to protect Chinese technology by adding recommendation algorithms, which could include TikTok's, to a list of technologies restricted for export, reported CNN.

During a four-hour long hearing, Chew time and again stressed that the TikTok app, which is owned by the Chinese technology company Bytedance, has long maintained that it does not share data with the Chinese government and it doesn't pose a risk to its 150 million users in the US nor share their data with the Chinese Communist Party (CCP).

# 'No new escalation...' **Armenia and Azerbaijan to** sign peace treaty

rmenian Prime Minister Nikol Pashinyan on Thursday announced that there will be a peace treaty between Armenia and Azerbaijan based on joint official statements adopted at the highest level.

The PM said, "There won't be a new escalation.'

"There will be a #peace treaty between #Armenia and #Azerbaijan, and it will be based on the joint official statements adopted at the highest level. There won't be a new escalation! The international community must strongly support this narrative," the Armenian PM tweeted on Thursday.

US State Department's Principal Deputy Spokesperson Vedant Patel in response to the development said the US is encouraged by the progress made toward lasting and sustainable peace in the

South Caucasus.

He said US Secretary of State Antony Blinken is engaged in facilitating peace discussions between Armenia and Azerbai-

"@SecBlinken is very engaged in facilitating peace discussions between Armenia and Azerbaijan, and we are encouraged by the progress made toward lasting and sustainable peace in the South Caucasus. We very much appreciate @NikolPashinyan's message on that progress," Patel tweeted on Friday.

Armenia and Azerbaijan have engaged in two wars in the more than 30 years both ex-Soviet states have been independent. Thousands of lives have been claimed in fighting for the control of Azerbaijan's Armenianpopulated enclave of Karabakh.

# North Korea tests underwater nuclear-capable attack drone

orth Korea has tested a new underwater nuclearcapable attack drone, Al Jazeera reported citing the country's state news agency KCNA said on Friday.

Significantly, the drone operated continuously for 59 hours underwater before being destroyed as part of a drill to intimidate the US and South Korean armed forces.

The North Korean military deployed and tested-fired the new weapons system this week during a military drill directed by Kim Jong Un, with the aim of determining if it could produce a deadly blast and wave on a "su-

According to KCNA, "This nuclear underwater assault drone may be launched at any coast and port or operated while being towed by a surface ship."



As per several media reports, the nuclear-capable underwater attack drone tested by Pyongyang can also leash a "radioactive Tsunami".

The drone was placed in the ocean near South Hamgyong province on Tuesday as part of the experiment, and it drifted there for 59 hours and 12 minutes, at a depth of about 80 to

150 metres (260 to 490 feet), before exploding on Thursday in the waters of the province's east coast.

However, the South Korean news agency, Yonhap said that the drone's final target point was a mock enemy port set up in the waters of Hongwon Bay, Al Jazeera reported citing the media report.
