# Sharad Pawar announces resignation as NCP chief; will take 2-3 days to reconsider decision, says Ajit Pawar

In a major political development, Nationalist Congress Party supremo Sharad Pawar on Tuesday announced that he has decided to step down as party chief drawing emotional reactions from thousands of NCP leaders, workers and supporters who urged him to reconsider the decision.

The move also came as a surprise in political circles with Pawar, a former Maharashtra Chief Minister and union minister, seen as a key architect of moves towards opposition unity ahead of 2024 electoral battle.

Sharad Pawar's nephew Ajit Pawar,

who had earlier said that "Pawar Saheb himself had said about the necessity of change in guard a few days back" later said that the NCP veteran would take two to three days to rethink his decision.

Pawar, who founded the NCP in 1999, has held the post of party chief for the past 24 years. Sharad Pawar, while announcing his decision, said he will not contest elections.

He recommended a committee of senior NCP leaders to decide on the future course of action. The committee will include Praful Patel, Sunil Tatkare, PC Chacko, Narhari Zirwal, Ajit Pawar, Supriya Sule, Jayant Patil, Chhagan Bhujabl, Dilip Walse-Patil, Anil Deshmukh, Rajesh Tope, Jitendra Awhad, Hasan Mushrif, Dhananjay Munde, Jaydev Gaikwad and chiefs of party frontal cells, he said.

"Since the formation of the Nationalist Congress Party in 1999, I have had the privilege of being elected as its President, which today is in its 24th year. This entire journey of being in public life, which began on May 1, 1960, has continued unabated for the past 63 years, having served Maharashtra and India in various capacities during this period," Pawar said. "I have three-year tenure remaining in Rajya Sabha. I will not contest elections henceforth. In these three years, I will concentrate more on issues concerning to state and the country. I will not take any additional responsibilities. I started my political career on May 1, 1960. Yesterday we celebrated May Day. After this prolonged political career, one must think about stopping somewhere. One must not be greedy. I will never take the position of sticking to a post after so many years. Therefore, you might feel uneasy. But I have decided to retire from the post of the NCP chief, " Pawar added.

espite the government's persistence may not be as clear-cut as a case of state domination and over-reach. It turns out that the Indian government might be right to fear that technology, for all the very real benefits it's brought India, could also help to magnify ancient communal tensions in a way that costs lives and, perhaps even worse, might destabilize the delicate social balance within the world's second-largest country. Technology didn't cause any of this, of course. But social media and text messaging, both of which are becoming increasingly common in the reaches of India's enormous lower and middle classes, accelerated the flow of rumors and of inflammatory images.

The government, unable to counter the destabilizing rumors, shut down some of the means of their dispersal. Whether the Indian government's

censorship does anything to calm this crisis, their apparent desperation is understandable. Still, India's willingness to censor the web is part of the government's longer-running effort to standardize the Internet, to which Western governments and web freedom advocates have persistently objected. Some of India's sweeping restrictions compel web companies like Google and Facebook to self-police, and then self-censor, any content that could be perceived as profane or offensive to ethnic groups.

In the recent past #censorship was a big debate on social networks; the social network authorities deactivate or block these days. Censorship in India, which involves the suppression of speech or other public communication, raises issues of freedom of speech, which is protected by the Indian constitution.

# Technology can be sometimes a public jeopardy?

A classic example of censorship in India is the Central Board of Film Certification or Censor Board, which comes under the purview of the Ministry of Information and Broadcasting. The Board regularly orders directors to remove anything it deems offensive or subjects considered to be politically subversive.

The Cinematograph Act, 1952 governs the censorship of films. It assigns certification as Universal, Adults, and Parental Guidance to films in India before public exhibition. The Indian government has earlier blocked around 250 websites, ordered Google and Facebook to pull content, threatened legal action against Twitter if it doesn't delete certain accounts, and has arrested several people for sending provocative text messages, all in the name of public safety.

Web freedom activists distinguish this as little more than an excuse for online authoritarianism, and they're probably often correct. We cannot isolate ourselves from this but can make a safe distance to access genuine information. A parallel system needs to strict its security norms so that any state against information and data is not in the reach of the common citizen of the country.

Being a person from Cyber Security, I know how much it is for us to fool inexperienced people on the internet and then use those resources to do something illegal and improper. There should be a body which will not only work towards security of cybercrime in government and Militant organizations but also work towards enforcement of awareness of cybercrime. It is always better to take precautions.

Rapidly increasing two-edged sword, Social media has created a vibrant online community and widened public discourse, allowing a platform for activists with a thousand causes. On the flip side, it has also become a vehicle of skewered misinformation. The perspective of an individual using a social networking site enigmatically is much more in a social networking site than in a social media. There is no procedure for registration and ownership. And so there is no way to pin down the culprits.

Censorship has become a weapon in the hands of the State to make people agree with its ideology. Now is the time to look into the role that healthy criticism, analysis, and cinema literacy, posts, cartoons, blogs or tweets rather than relying on controllers that act as moral police can play, stopping the dissent. Information technology seems to be the latest weapon of waging proxy wars.

Countries have borders and restrictions to each other's jurisdiction, but cyberspace has no boundaries. Recent NE exodus was a disastrous moment for Indian Citizens and the Government. With 2-3 online users and a couple of hours of editing work, various groups could trigger the most massive internal exodus of People in India and nationwide protests. Most of the public who does this assumes that they do this with a false sense of secrecy.

While Cyber War between India and Pakistan is not new, something limited it to hacking off each other's websites. Interestingly, this time it may not have been carried out by so-called hackers. Since it was easier to spread hatred than to block websites, 4-5 Social Media addicts have carried the whole episode out. The law is there to prevent this, but enforcement is far from adequate. There are many such instances and evidence that one country rages its anger or one particular religion condemns another religion, hurting its sentiments online.

But we did not do so. It was our prejudice and lack of unity that contributed to the success of the mischief-mongers. To control the situation and stabilize the country, the Government opted for censorship. There is no point in blaming the government. At least the educated should take pains to verify the truth. Pointing a finger at Pakistan will not solve the problem. The crisis has brought social media to the forefront, relegating the print and electronic media to the background. Perhaps it is one more revolution in the history of humanity. People today believe in non-stop, one-to-one communication/conversation, rather than the mass media.

Anyway, censorship might help control the situation, but this will remain as superficial of the problems that country is facing. Making the people aware of the "cyber threat" takes an hour but censorship can't be the exact way out. India really requires proper systems to be adopted in order to be safe or else this might really create colossal disasters in the future. In the information age we cannot lock our cyberspace because it is among one of the primary tools for the sustainable development of the state. But curbing cyber-attack in any form, either cyber war or putting illegitimate material on the web has really become necessary around the globe. Though we are having strict policies, we are still not guarding our information web properly and which causes recent NE exodus type events.

# **Cong demands special session of Maha legislature to** discuss sunstroke tragedy deaths Barsu refinery protests

he Maharashtra Congress has demanded that a special session of the state legislature be convened to discuss issues including the death of more than a dozen people due to sunstroke last month and protests against a proposed oil refinery project at Barsu in Ratnagiri district.

A Congress delegation made the demand to Governor Ramesh Bais during a meeting with him at the Raj Bhavan here on Tuesday.

Notably, 14 people died due to sunstroke after attending the 'Maharashtra Bhushan' award event in Kharghar area of Navi Mumbai on April 16. A section of residents in and around Barsu in



Ratnagiri have been opposing the proposed refinery as they fear the mega project will adversely affect the fragile biodiversity of the coastal Konkan region and also hit their livelihood.

Speaking to reporters after meeting the governor on Tuesday, state Congress president Nana Patole alleged the incident that took place in Kharghar during the 'Maharashtra Bhushan'

award ceremony was a "statesponsored murder" and till date no case has been registered in this connection

"Poor planning of the government was responsible for the in-

cident. It should be investigated by a high court judge," he said.

Patole also claimed that the Barsu refinery project was being imposed by the government on locals despite their opposition. The state government was using police force to oppress the locals and it wants to destroy the pristine environment of Konkan, he further claimed

Patole further said farmers have suffered losses due to unseasonal rains and hailstorms and they should be given immediate help. The cultivators have been devastated by the weather change and the rate of farmer suicides has increased in the state, he said.

## **Raut not spokesman of Cong he should stop** interfering in other parties' affairs says Patole



aharashtra Congress chief Nana Patole on Wednesday hit out at ally Shiv Sena (UBT) leader Sanjay Raut, saying that he should stop "interfering in other parties' affairs", a statement that drew a sharp reaction from the latter.

The Congress, Shiv Sena (Uddhav Balasaheb Thackeray) and Nationalist Congress Party (NCP) are partners in the opposition alliance Maha Vikas Aghadi

(MVA). The government headed by this alliance ruled Maharashtra from November 2019 to June 2022

On Tuesday, Raut said that decisions in the Congress are ultimately taken by Rahul Gandhi although Mallikarjun Kharge currently occupies the post of the grand old party's president. When asked about Raut's remark, Patole told reporters at his residence in Nagpur that the Shiv Sena (UBT) leader should stop interfering in the affairs of other parties.

"Sanjay Raut is not a spokesperson of Congress. How can he raise question marks over the capability of Congress chief Mallikarjun Kharge? It is wrong to level false allegations against the Gandhi family," he said.

"I would suggest that he (Raut) should not interfere in our party's affairs," Patole added. Reacting to Patole's statement, Raut said, "No one has talked about his (Patole's) party.

#### Mumbai police bust ring of cybercriminals say 12th pass mastermind made more than Rs 5 crore a day

umbai police have exposed a ring of cybercriminals that stole money from people from across the country by posing as police personnel and arrested its kingpin, who has studied till Class 12 and used to do transactions of more than Rs 5 crore a day in his accounts, an official said on Wednesday.

Mastermind Shrinivas Rao Dadi (49), who has sound technical knowledge despite limited education, was taken into custody by a team of Bangur Nagar police station from a plush hotel in Hyderabad, the official said.

Besides Dadi, police also arrested four more members of his gang, including two from neighbouring Thane and as many from Kolkata, he said. Dadi pretended to run a real estate business and used to communicate only through the Telegram app. Police have so far frozen 40 bank accounts used by Dadi and recovered cash of Rs 1.5 crore from him, the official said.

### Woman paramour held for killing her husband in Thane

olice have arrested a 24-year-old woman and her paramour for allegedly killing her husband and dumping the body in a hill section in Maharashtra's Thane district, an official said on Wednesday.

On April 24, the decomposed body of an unidentified man was found behind a temple in the Kasara Ghat valley on Nashik-Mumbai highway, Deputy Superintendent of Police. Sahapur division, Vikas Naik told PTI.

A police probe team sent the body for postmortem. The police later identified the victim as Sunil Kothere (28), a vegetable vendor from Cholegaon in Dombivli area, he said.

The police worked on various

inputs and on Tuesday arrested the accused's wife Komal Sunil Kothere and her paramour Monukumar Triloknath Kharvar (28), who was also a vegetable vendor, the official said. According to the police, the deceased doubted his wife's character and the couple used to have frequent quarrels over the issue.

The woman later hatched a conspiracy along with her paramour and his associate to kill her husband, the official said. The trio allegedly killed the victim by hitting him with an iron rod on the intervening night of April 12 and 13. They then transported the body in a tempo from Dombivli to the ghat section and threw it in the valley, the official said.

#### Maha Cabinet nod for scholarships to 75 students for research in mangroves and marine biodiversity

he Maharashtra cabinet on Wednesday approved a proposal to provide scholarships to a total of 75 students over a period of three years for carrying out research in mangroves and marine biodiversity in prestigious universities abroad.

A statement from the Chief Minister's Office (CMO) said that as part of this exercise, every year 25 students will be given scholarships by the forest department's

Mangrove and Marine Biodiversity Conservation Foundation. These scholarships will be given to students who have taken admissions in educational institutions abroad which are within 150th ranking of Times Higher education (THE) or Quacquarelli Symonds (QS).

The statement said 30 per cent of these scholarships will be given to female students. Of these 25 students, 15 will be post-

graduate and 10 PhD students from the fields of marine science, marine ecology, oceanography, marine biology, marine biotechnology, microbiology, biodiversity subjects.

The minimum age of postgraduate students should not exceed 35, while for the PhD students, it should not be more than 40. Their annual income limit should not be more than Rs 8 lakh, the statement said.

# Will form committee to look into issues faced by LGBTQIA+ community: Centre to SC



The Centre on Wednesday apprised the Supreme Court that they will constitute a committee headed by the Union Cabinet Secretary to look into the issues faced by the LG-BTQIA+ community. This was informed to a Five-judge Constitution Bench by Solicitor General Tushar Mehta who was appearing for Centre.

The five-judge Constitution Bench comprising of the Chief Justice of India DY Chandrachud, Justice Sanjay Kishan Kaul, Justice S Ravindra Bhat, Justice Hima Kohli and Justice PS Narasimha is dealing with a batch of petitions pertaining to

'marriage equality rights for LG-BTQIA+ community. Solicitor General Tushar Mehta apprised the Supreme Court that a committee headed by the cabinet secretary will be formed to look into the issues faced by the same-sex couple. SG Mehta further submitted that petitioners can submit suggestions so that the committee can apply their minds to it. The bench observed that it appears that the Centre is accepting that people do have a right to co-habit and basis of that there may be certain incidents of that cohabitation like bank accounts and insurance policies. SG Mehta submitted before the Supreme Court that the government is positive about the concerns raised by the top court for giving some social benefits to same-sex couples. He further said that this would need coordination between more than one ministry.

In the last hearing on April 27, the Supreme Court asked the government to give a response on social benefits that can be given to same-sex couples even without legal recognition of their marital status. CJI DY Chandrachud has suggested that there are ministries dedicated to this purpose like social justice and empowerment such as Ministry for Women and Child Development.

The court has asked Solicitor General Tushar Mehta to see if there can be separate legislation taken which would protect the rights of same-sex couples. Solicitor General had expressed his acknowledgement that concerns such as having a joint bank account, nomination in insurance, etc are all human concerns and there can be deliberation to find a solution. Solicitor General had indicated that he could attempt to undertake this exercise since the suggestion has come from the Bench.

## Gangster murder: 6 arrested, 20 detained during police raids in Delhi, Haryana

raids by Dwarka District Police in the national capital and Haryana concluded with the arrest of six people and detention of 20 others, officials said.

Those arrested have been identified as Nitin Narulla, Nikhil, Rajpal, Deepak, Mohit, and Jitender Dahiya.

"They have been arrested for various offences under the Arms Act and Narcotic Drugs and Psychotropic Substances (NDPS) Act", said officials. The raids were carried out at around 21 places including 15 in the national capital, and six others in Haryana, in search of gangsters and their associates. The raiding teams also recovered a bulletproof luxury car, firearms, cash, and heroin in raids officials said.

"Dwarka District Police detained 20 people and arrested six others based on the recovery during the raids and searches today," Deputy Commissioner of Police M Harshawardhan told media after the massive operation.

## The Kerala Story: SC declines to entertain pleas seeking to stop film's release, asks them to approach HC



The Supreme Court on Wednesday refused to entertain pleas seeking a stay on the release of the movie 'The Kerala Story' in theatres and OTT platforms and allows the petitioners to approach the Kerala High Court.

A bench of Chief Justice of India DY Chandrachud and Justice PS Narasimha said a similar plea is pending before the Kerala High Court and asked them to move the High Court with their pleas.

The high court is scheduled to hear the case against the film on

May 5. Advocate Vrinda Grover mentioned the petition before the bench seeking urgent listing tomorrow saying the film is getting released on May 5. The petition mentioned by Grover sought a modification in the disclaimer of the film to state that it is wholly fictional. Grover said, "The opening shot says the film is true. It has been advertised as a true story. That movie vilifies the entire community. There is no disclaimer. It's a pan India release."

Advocate Nizam Pasha, appearing for Jamiat Ulama-I-Hind, also mentioned the plea for an urgent hearing, saying his petition is seeking different reliefs to stop the film's release and not just a modification of its disclaimer. The bench, however, asked them to approach the High Court where a similar petition is pending.

### K'taka polls: Bajrang Dal stages protest against Cong manifesto

Bajrang Dal workers staged a protest near the Congress office and burned the party manifesto released for the upcoming Karnataka elections.

This comes after the Congress on Tuesday in their Karnataka election manifesto said it will take "decisive action" as per law including banning organisations like Bajrang Dal, the Popular Front of India and others.

"We will take decisive action as per law including imposing a ban on any such organisations, read the Congress manifesto released by the party president Mallikarjun Kharge here.

"The Congress party is committed to taking firm and decisive action against individuals and organisations spreading hatred against communities on the grounds of caste and religion," read the Congress manifesto.

"We believe that law and Constitution are sacrosanct and cannot be violated by individuals and Organisations like Bajrang Dal, PFI or others promoting enmity or hatred, whether among majority or minority communities," it added.

# PT Usha meets with protesting wrestlers; assures support

ce wrestler Bajrang Punia on Tuesday said that Indian Olympic Association (IOA) president PT Usha has assured the grapplers of her solidarity with their protest against Wrestling Federation of India (WFI) Chief and said that she will help them to "get justice."

The IOA president arrived at Jantar Mantar earlier today where the wrestlers have been staging a protest for the last 11 days demanding that action be taken against the WFI chief Bushansharan-singh" Brij Bhushan Sharan Singh, who is facing allegations of sexual harassment.

"She (Usha) said that I am with you and I will help you get justice," Punia told media persons after the meeting. The Olympic 2021 Bronze medalist further added that the wrestlers will continue their protest till the time the WFI Chief is put behind bars.

"We will stay here until he goes to jail," Punia said.

Previously, Usha had ruffled feathers with her remarks that the wrestlers should have approached the IOA instead of going out in the streets against the WFI and its president, whom the wrestlers accused of sexual harassment and mismanagement of athletes.

# Sudan's warring sides 'agree seven-day truce' from today

The warring parties in Sudan have agreed to the seven-day truce, South Sudan's foreign ministry in Juba said in an official statement on Tuesday (local time). In a telephonic conversation with South Sudan's President Salva Kiir Mayardit, the warring parties agreed to the seven-day truce from May 4 to 11.

"The two principals, General Abdel Fatah Al Burhan, the Chairman of the Sovereign Council and Commander in Chief of Sudan Armed Forces (SAF) and General Mohamed Hamdan Dagalo Leader of the Rapid Support Forces (RSF), have agreed in principle for a seven-day truce from May 4th to 11th. They also agreed to name their representatives to the talks," the statement read. In the telephone conversation, South Sudan's President stressed the importance of a longer ceasefire and naming of representatives to peace talks to be held at an agreed venue. This statement came as Sudan continues to face bloodshed as a result



of clashes between the army and paramilitary forces.

"President Salva Kiir, who is the team leader of the IGAD Assembly of Heads of State tasked with consultations with the Sudanese leaders, has urged the Sudanese leaders to name their representatives and propose a date to commence the talks as soon as possible," the statement read.

"The rapidly deteriorating humanitarian situation in Khartoum

makes it imperative for the leaders to de-escalate, President Kiir told the Sudanese leaders. While expressing his appreciation to General Al Burhan and General Dagalo for heeding regional and international calls for a ceasefire, President Kiir urged them to take advantage of the 7-day truce to name representatives and propose the date for beginning the talks," the statement added. In line with the initiatives of South Sudan's President, the Acting Minister of Foreign Affairs and International has also been in contact with his counterparts regionally and internationally.

The Acting Minister conferred with the Ministers of Foreign Affairs of Egypt, Uganda, Kenya, and Canada, in addition to the British Minister of State in the Foreign, Commonwealth and Development Office, dwelling on the issues of ceasefire, cessation of hostilities, humanitarian situation and evacuation of affected Sudanese and foreign nationals as well as the coordination efforts at various levels.

## Israel strikes Gaza after Palestinian Rocket Fire

he Israeli Defense Forces struck a number of Hamas sites in Gaza overnight in retaliation for Tuesday's rocketfire">rocket fire. According to unconfirmed Mideast media reports based on Palestinian sources, Israel and the Gaza terror groups agreed to a ceasefire. Palestinians fired rockets at Ashkelon. Sderot and other communities adjacent to the Strip on Tuesday following the death of Sheikh Khader Adnan, a senior figure in the Palestinian Islamic Jihad terror group who died following an 86-day hunger strike in an Israeli prison.

Three people in Sderot suffered shrapnel wounds when a Palestinian rocket struck a construction site. A 25-year-old Chinese labourer was seriously injured when one of the rockets struck a construction site in Sderot. Another two people were lightly wounded. The other rockets landed in open areas, causing no damage. A military spokesperson said the IDF struck a munitions warehouse, weapons production facilities, training sites and a concrete factory used to build Hamas infrastructure. Also hit were an underground tunnel and a Hamas naval outpost

"Hamas bears responsibility for what is happening in the Gaza Strip and it is the one who will pay the price for the security violations against the State of Israel," the IDF statement said. After the initial air strikes, Palestinians fired rockets, triggering sirens in Sderot, Netiv HaAsara, Yad Mordechai and other Israeli communities near the Gaza border.

The 45-year-old Adnan spent many years in Israeli prisons during 10 different terms. He popularized the use of hunger strikes by Palestinian prisoners. The Israeli Prison Service said that Adnan was found unconscious in his cell at the Nitzan Prison early Tuesday morning. CPR was performed and he was taken to the Assaf HaRofeh Hospital in Beer Yaakov where he was pronounced dead. The IPS stressed that Adnan had refused to undergo medical tests or receive medical treatment during his hunger strike

# Pakistan violates FATF redline by letting JeM seek funds for jihad

n UN-proscribed global terrorist group Jaishe-Mohammad (JeM), openly sought funds for jihad in Peshawar and other cities during the Eid celebrations.

By letting this happen, Pakistan has violated a key redline set by the global anti-terrorist financing watchdog, FATF, in letting the country off the greylist last year, European Times reported.

According to local residents, members of JeM were reportedly seeking funds for carrying out jihad in Kashmir and Palestine in Bagh-e-Naran, a suburb on the outskirts of Peshawar in Khyber Pakhtunkhwa in April this year.

Several Pakistani Twitter users have since pointed out that similar fundraising activities by extremist groups were happening in other areas as well. Many of them said these fund-raisings had been a regular feature at many mosques, sometimes under the protection of security personnel. There were other Twitter statements showing terrorist groups openly seeking funds in mosques in Karachi, European Times reported. The Eid fundraising by JeM clearly proves that Pakistan has failed to keep its promise to FATF to curtail terrorist funding.

According to European Times, in June 2021, FATF declined to let off Pakistan from the greylist citing laxity in taking action against proscribed terrorist groups like Lashkar-e-Tayyeba (LeT), JeM and similar entities. The FATF said that despite completing 26 of the 27 tasks it had been handed, Pakistan's failure to complete the last task on convicting terrorists and terror entities meant it would not be delisted for now.

Afghanistan is deteriorating with every passing day as the violence against the community has increased manifold in the nation under Taliban rule. According to Khaama Press, the Afghanistan Journalists Cen-

the Afghanistan Journalists Centre (AFJC) released a study on the deteriorating state of the media in Afghanistan, noting that violence cases against journalists have climbed by 64 in the previous year.

dom Day. The majority of violent incidents, including threats against and arrests of journalists and media personnel, have been conducted by Taliban government agencies, according to the AFJC.

One person was killed, 21 people were hurt, six people were physically harassed, 115 people were threatened, and 70 journalists were detained, of which at least two (Murtaza Behbudi and Khairullah Parhar) are still in Taliban custody, Khaama Press According to the Afghan news agency, the centre has also stated that the media environment in Afghanistan under the Taliban regime has been unfavourable, adding that after the previous government was overthrown in August 2021.

About half of Afghanistan's 600 media outlets ceased operations because of financial difficulties and restrictions put in place by the ruling regime, according to Khaama Press.

# 'Operation Kaveri' flight carrying 231 stranded Indians reaches Mumbai

s 'Operation Kaveri' continues to bring stranded Indians back to the country from conflict-hit Sudan, another flight with 231 passengers landed in Mumbai on Wednesday. Taking to Twitter, the official spokesperson of the Ministry of External Affairs, Arindam Bagchi informed about the flight's arrival and said that citizens are back home now.

"Another #OperationKaveri flight brings citizens back home. Flight carrying 231 passengers lands in Mumbai," Bagchi tweeted. The 12th flight carrying 231 stranded Indian evacuees, departed from Jeddah earlier today. "12th outbound flight departs from Jeddah. 231 passengers are heading to Mumbai," External Affairs Ministry Spokesperson Arindam Bagchi tweeted on Wednesday
