RPF CONSTABLE SHOOTS DEAD SENIOR, 3 PASSENGERS ON BOARD JAIPUR-MUMBAI TRAIN



Railway Protection Force (RPF) constable on Monday shot dead four persons on board a running train near Palghar railway station in Maharashtra, an official said.

Constable Chetan Kumar Choudhary fired from his automatic weapon, killing an RPF Assistant Sub-Inspector (ASI)

and three other passengers of the Jaipur-Mumbai Central Express shortly after 5 am, the official said.

According to a senior police official, the accused RPF constable was mentally unstable.

Palghar is around 100 km from Mumbai. The constable opened fire on his escort duty in-charge ASI Tika Ram Meena in the running train, the official said.

After killing his senior, the constable went to another bogie and shot dead three passengers, the official added.

The accused then tried to escape from the train between Mira Road and Dahisar, but was later nabbed by the Government Railway Police (GRP) personnel and his weapon was also seized,

The accused is in the custody of the Mira Road railway police, the official said. The bodies were taken out of the train at Borivali railway station, he said.

On the other hand, Ajit Pawar who is part of the incumbent government also demanded the arrest of Sambhaji Bhide. The Amravati police have already registered the police complaint against Sambhaji Bhide under IPC section 153 A — promoting enmity between two groups. This is a cognisable offence with three years of imprisonment and a penalty. Earlier former Maharashtra Congress chief minister Prithviraj Chavan brought up Bhide's remarks against Mahatma Gandhi on the floor of the House in the Maharashtra state assembly monsoon session and demanded the arrest of Mr Bhide. Former Maharashtra cabinet minister and Congress MLA Yashomati Thakur had asked "for whose permission the BJP-led government is waiting" when there are demands for Bhide to be arrested.

Surprisingly no congress leaders know about the book that Mr Bhide referred to. We personally spoke to dozens of Congress leaders, each one of us told that they have not read the book or not even aware of such a book that is available online. Many opposition leaders said that they don't know the writer A Ghosh, and some of them said we have ordered the book, we will read it and seek appropriate action against the writer. Political think tanks look at this entire contreversy as a diversion tactic, they believe that the Bhide is assigned to make such a statement by the BJP to divert attention from the burning issue of Manipur issues which has severely brought embracement to BJP.

Writer A. Ghosh is an Indian writer. He won India's highest literary honor. Ghosh worked at the Indian Express newspaper in New Delhi and several academic institutions. Ghosh holds two Lifetime Achievement awards and four honorary doctorates. In 2007 he was awarded the Padma Shri, one of India's highest honours, by the President of India. This most acclaimed writers' book was missed by the Congress leaders.

Ghosh in his book The Kuran and The Kafir writes "some say that Gandhi's natural father was the Moslem employer of Gandhi's father. Gandhi's father used to work for a Moslem landowner and had stolen money from the cash box and had fled. He was a fugitive for three years and his wife was taken over by the

Moslem landlord and placed in his harem. Gandhi was born during this period when his father was a fugitive. There are people who assert that Gandhi's father used to come inside the harem like a thief to sleep with his wife, and he indeed was the true father but that seems to be highly unlikely. However! Gandhi had promised to his mother to be a strict vegetarian. This promises he kept all throughout his life. Otherwise, he was a servant of Islam in his political dealings."

No one knows from where A Gosh has gathered this kind of information, there is no authentication to his claims. This can be a propaganda but surprisingly no one has taken objection to his book and the book is in the best category at Amazon. Learned congress leaders should have questioned the motive of the author or they could have demanded the ban on this said book, but the irony is that until Bhide's statement they were clueless about it.

No congress leader so far took any action against the writer or the book, they all went after 90 years old Bhide and made several condemnations and complaints against him. Bhide, is accused of making offensive remarks about Gandhi in his speech during a programme at Bharat Mangal Hall in Badnera Road area in Amravati district on Thursday, July 27. The Rajapeth police in Amravati booked Sambhaji Bhide under Indian Penal Code section 153A (promoting enmity between different groups on grounds of religion, race, place of birth, residence, language, etc., and doing acts prejudicial to maintenance of harmony). Though his statements were not against any religion, cast, creed or group, he just stated the paragraph written in the book. The question is, will the Congress leaders take action against A Bose? Or will they haunt the book reader?




The following demands have been made in this memorandum.

Illegal parking in Granth Sangrahalaya premises, court-matters, contracts awarded should be investigated. The transactions in the properties of the organization in Pune, Chembur, Pantnagar, Bandra and also the illegal sale of the branch of the organization

"They called me gold digger..." Nora Fatehi tells court Jacqueline, others ruined her reputation



ctor Nora Fatehi on Monday recorded her statement before the Metropolitan Magistrate Kapil Gupta in a defamation case filed by her against another Bollywood actor Jacqueline Fernandez and various media organizations. Fatehi who appeared in Patiala House Court today stated, "This defamation case has been filed against Jacqueline Fernandez and the various other channels and publications who have ruined my reputation in the public eye

through false narratives. They have called me a gold digger and accused me of having a relationship with a con artist Sukesh Chandrasekhar."

"This has caused me a loss of financial gain and reputation. The reason why I have filed this case is because of the ongoing ED case against Sukesh who was accused of conning a sum of Rs 200 crore that I have nothing to do with and neither do I know anything," she said further. "I feel that I have been used as a scapegoat in this

case in the media to safeguard certain people and because I am an outsider and I have been taken as a soft target and I want compensation for all the damages caused to my career," the actor said. Jacqueline has stated in the media why the ED has listed me as a witness in the case and herself as an accused. "This statement has led to prolonged and unnecessary harassment, loss of work and cyberbullying," Fatehi said in her statement.

The actor in her defamation complaint, also stated that she is aggrieved of defamatory remarks made by Jacqueline Fernandez, initially, which was further carried forward and circulated by the other accused persons (media organizations), all of whom were acting in connivance with each other and a conspiracy by the Jacqueline Fernandez to ensure the financial, social, and personal downfall of the complainant (Fatehi) was hatched, and enacted by the said actions. Over 17,000 people died in floods and heavy rains between 2012-2021: Govt

ver 17,000 people died in floods and heavy rains between 2012 and 2021 in the country, the government said on Monday. Responding to a question in the Rajya Sabha, Minister of State for Jal Shakti Bishweswar Tudu said the increased incidence of high intensity rainfall of short duration is mainly responsible for urban floods, which is further compounded by unplanned growth, encroachment of natural water bodies and poor drainage system. According to data shared by Tudu in the House, 17,422 deaths due



to floods and heavy rains from 2012 to 2021 took place in India.

The state-wise data on damages due to heavy rains and floods in the entire state (rural and urban areas) has been compiled by

Land-for-job-scam: ED attaches assets worth over Rs 6 cr of people linked to Lalu Yadav's family



he Enforcement Directorate (ED) has attached assets worth over Rs 6 crore of many people linked to former Bihar Chief Minister Lalu Yadav's family in the land for job scam, the sources said on Monday. The sources from the federal agency said that the seized property includes properties in Patna and Ghaziabad as well.

The development comes nearly a month after the CBI, which is also probing the scam, filed a fresh charge sheet against former Bihar CM Lalu Prasad Yadav, his wife Rabri Devi, and his son and current deputy chief minister Tejashwi Yadav in connection with the case. Recently, CBI has filed a chargesheet in a land-for-job alleged scam case of

former Union Railway Minister Lalu Prasad Yadav naming Bihar's Deputy Chief Minister Lalu Prasad Yadav and others including Tejashwi Yadav etc.

According to the CBI, this is the 2nd chargesheet in the Designated Court against 17 accused including the then Union Minister of Railways, his wife, son, then GM of West Central Railways(WCR), then two CPOs of WCR, private persons, private company etc. in a case related to Land for Job Scam.

CBI had registered a case on May 18, 2022, against the then Union Minister of Railways and 15 others including his wife, two daughters and unknown public servants and private persons. ANI

"Why police took 14 days to register zero FIR in Manipur viral video case": **CJI Chandrachud**

upreme Court on Monday questioned the Central government on the Manipur viral video, in which two women were allegedly sexually assaulted and paraded naked by a mob, asking why the FIR in the case was registered on May 18 when the incident happened on May 4. "Supreme Court questions why the FIR was registered on May 18 when the incident happened on May 4. What were the police doing from May 4 to May 18? The incident came to light that women are being paraded naked and at least two were raped. What were the police doing?" the Supreme Court asked the Central government.

However, Solicitor General Tushar Mehta said that government has nothing to hide. "This court can monitor the situation.



Something coming from here or there will be hazardous," he added. A 26-second video from Manipur has triggered outrage in the whole country where two women were stripped naked, assaulted and paraded by a mob. The incident allegedly took place on May 4, a day after ethnic clashes broke out in Manipur. After a video of the same went viral, the police swung into action and arrested seven people, including the main accused. ANI

Will hold talks with other countries to resolve Rohingya crisis, says EU representative



he European Union assured that they will hold conversations with other countries about what needs to be done to resolve the Rohingya crisis, reported Dhaka Tribune. Eamon Gilmore, European Union's Special Representative for Human Rights spent a full day in Cox's Bazar and met the Rohingyas who fled from Myanmar over the past six years.

Bangladesh is hosting over 1.1 million Rohingyas in Cox's

Bazar district and Bhasan Char. He said they are talking to other governments about what needs to be done. "Becauste we recognize that there is a need for support. And we will continue to work on that. We will continue to keep it on the international agenda," he said. Gilmore added that they are particularly conscious about the reductions in food rations that are being made this year, Dhaka Tribune reported. "It has to be resolved and it has to be re-

solved in Myanmar. The resolution of that crisis has to happen. And the circumstances need to be created whereby the Rohingva refugees in Bangladesh can voluntarily go home safely, with their rights respected and in full dignity," he said.

Gilmore also said that the food rations for the Rohingya refugees in Cox's Bazar have been cut from USD 12 to USD 10 (per person per month) and then USD 8 due to funding reductions by international donors. Gilmore heard their problems and assured them that the European Union has not forgotten them despite the current crises going around the world, reported Dhaka Tribune. While appreciating the Bangladesh government and the office of the Refugee, Relief and Repatriation (RRR) Commissioner, he added, "We are working with countries in the neighbourhood and with the ASEAN countries." Pakistan: Unknown assailants hurl grenade at police checkpost in Khyber district



assailants nknown hurled grenade and fired gunshots at a police checkpost in Khyber Pakhtunkhwa's Khyber district on Sunday, reported Geo News. The attacker was blocked from leaving by the counteraction of the police and the Frontier Corps (FC) officials.

There were no reported victims from the terror incident that took place. The existing security concerns in the province of Khyber Pakhtunkhwa, which has been the scene of multiple insurgent strikes just in July, are made worse by this assault on law enforcement,

according to Geo News.

On July 21, Geo News reported at least four terrorist assaults in Khyber Pakhtunkhwa in within 48 hours, including one in Peshawar, the nation's capital, which was successfully thwarted by officials.

On July 20, a terrorist killed one police officer and injured ten others when the police stopped him and his accomplice as they entered the Bara tehsil compound, which houses the Bara Police Station, government buildings, and a counterterrorism department (CTD)

Residents evacuated as flash flood hits China's **Fangshan district**

According to National Meteorological Center (NMC) of China, heavy rain will continue to hit Beijing, Tianjin, Hebei and nearby provinces on

Some areas will see extraordinarily heavy rainfall, with up to 400 mm of rainfall within 24 hours, Global Times reported citing the NMC. China's Ministry of Water Resources upgraded the emergency response for the flood

in Beijing, Tianjin, and Hebei to Level II on Sunday afternoon. Strong convective weather, thunder, and lightning warnings have been issued already.

According to Global Times, scenic spots across Beijing and suburbs, including the Palace Museum and the Yonghe Lama Temple, will be closed on Sunday and Monday out of safety concerns due to heavy rainfall. After battering the Philippines and Taiwan, where it caused scores of deaths and compelled thousands to flee, Typhoon Doksuri has brought severe rainfall to numerous districts in northern China, including the capital Beijing. US extends support to ECOWAS, demands immediate release of President Bazoum

he United States on Monday extended support to the leadership of the Economic Community of West African States (ECOWAS) to defend constitutional order in Niger. This comes as the Niger military has been holding Mohamed Bazoum, the elected president since Wednesday in the third attempt to depose a Sahelian leader in as many years.

"The United States welcomes

and commends the strong leadership of the Economic Community of West African States (ECOWAS) Heads of State and Government to defend constitutional order in Niger, actions that respect the will of the Nigerien people and align with enshrined ECOWAS and African Union principles of zero tolerance for unconstitutional change," US Secretary of State Antony Blinken said in a US State Department statement. The US further called

for the immediate release of President Mohamed Bazoum and his family and the restoration of all state functions to the legitimate. democratically-elected government. "The United States further welcomes the dispatch of the special representative of the ECOW-AS Chair to Niger and urges all parties to work with ECOWAS for a peaceful and expeditious resolution of the current situation," the state department stated. ANI

Death toll rises to 12 in Thailand fireworks warehouse explosion

The death toll of the people killed in the fireworks warehouse explosion in Thailand has risen to 12, CNN reported on Sunday. According to state-run Radio Thailand, at least two of the victims were children, including a four-year-old boy and an eight-month-old baby girl. At least 121 people are injured in the explosion at the warehouse in southern Thailand.

Drone footage of the incident in the town of Mu No showed that the warehouse and the surrounding area were reduced to ruins,



according to CNN. A hundred or more homes also sustained damage. According to CNN, Anuruth Imarb, commander of the Narathiwat Provincial Police, stated in a press conference on Sunday that police intend to file criminal charges against the warehouse owner for "causing the explosion and resulting in people's deaths, injuries, and property damage." NEP Challenges and Major Action Points



n course of the implementation of the National Education Policy (NEP) 2020, major challenges have been categorized under three broad themes - School, Teacher and Child. Subsequently, during the Chief Secretary conference, 35 priority areas have been identified for major actions to be taken care of by the states.

Parent awareness drives will be conducted so that they can contribute to the quality of their child's education. Twining of private and government schools should be done and private schools should adopt a remote school as part of their social obligation. Activities such as teacher exposure visits between private and government schools, hosting of government school students by private school students and joint sports competitions between private & government schools should be explored to increase exposure for both sets of students. Optimal utilization of resources should be systematically planned by the States/UTs on the concept of "Providing Urban Amenities to Rural Areas " (PURA).

There should be greater integration between Schools and Anganwadi centres and students from Anganwadis should be taken to nearby primary schools, where they should be given a platform to perform a song and creating confidence to prepare them for school. Also the school teachers should orient the Anganwadi

workers on teaching and learning for pre-school children. Adoption of Anganwadis by nearby schools should be properly planned. Hackathons should be organized, where students should provide innovative solutions to a variety of real-life problem statements created by different departments. Many of these solutions could be adopted to solve long-standing problems. Micro-improvements should be Continuously undertaken. Also activation of Tithi Bhojan concept must be activated as "Sabka Prayaas" to ensure supplementary nutrition for the school-going

Parents should confirm the teacher's performance on the large photograph of the concerned teachers displayed in the classroom. The Campus-based recruitment drive, as done in technical colleges, for Teacher Education Institutions should be explored. Regular e-training should be promoted for capacity building of teachers to

excel. Retired outstanding teachers should be invited for mentoring a cluster of schools and motivating its teachers. Efforts will be made to do away with single-teacher schools and adequate amenities should also be provided in the school. To make teaching and learning more engaging for TV-driven education, teachers should be encouraged to provide high-quality content in various forms like animation, monoacting, drama, dialogues etc.

To give a boost to access to high-quality content for each grade in the country, the setting up of 200 TV channels has been planned. The content of these channels will be sourced by the teachers of the States/UTs. There should be peer-to-peer learning in the classrooms. To improve the learning trajectory of the students, classroom interactions through academic quiz is necessary.

SCERTs have a pivotal role to play in the implementation of NEP 2020 and hence all SCERTs in the country would need to be strengthened. All Teacher Education Institutions across the country have to adhere to certain norms and standards of the NCTE and gradually move towards a multidisciplinary environment. **Under National Mentoring** Mission (NMM), a unified learning interface in the form of a portal has been established where all the mentors will remain connected. National Professional Standards for Teachers (NPST) will focus on the preparation, practice and performance improvement of all teachers. Performance Grading Index (PGI) for the Districts, released by the Ministry of Education (MoE), assesses the performance of the school education system across 83 indicators and the report would be used by the States to accelerate the work in a particular district which is lagging behind. The progress with respect to these priority areas will be monitored by the NITI Aayog.
