ashabandi Mandal is the only grant-aided organization functioning through the state government to implement the government's de-addiction policy. RTI activist Anil Galgali has been informed by the Social Welfare Department that the Grant amounting to Rs.1.12 crore is outstanding for this organization.

RTI activist Anil Galgali had applied to the Maharashtra government on 17 May 2023 to the Department of Social Justice and Special Assistance asking for information on the grant given to the Nashabandi Board. The Social Welfare Department has provided information for 9 years from the year 2014-2015 to the year 2022 2023



to Anil Galgali. 30 lakh rupees per annum grant has been approved by the Government of the State of Maharashtra. 2.70 crore as a subsidy of 30 lakhs was required to be received in the last 9 years. But only Rs 1 Crore 57 Lakh 42 thousand received from the Commissionerate has been given to the Board. 1 crore 12 lakh 58 thousand rupees is due to be paid as of today.

This organization works so that the future generation of the state does not become addicted. Anil Galgali has alleged that even though the state of Maharashtra ranks second in terms of addiction, the Social Justice and Special Assistance Department headed by the Chief Minister is neglecting it.

Primarily, Islam has come together to form 'Ex-Muslims of Kerala' and also decided to observe January 9 as 'Kerala Ex-Muslim Day'. Moreover, considering India's religious history, the ex-Muslims' movement of Kerala can be viewed as an exceptional chronological development. Since 2014, many scholars also denounced Islam and they became Hindu.

Often these intimidation tactics violate the basic human rights of individuals. Eviction, ex-communication of families, family ex-communicating a member, forcing the spouse of an apostate to seek divorce, not allowing an apostate to contact their children, no share in inheritance, obstructing marriages etc. are some of the usual tactics. Families who refuse to follow the diktat of the Islamic clergy are threatened with social banishment.

Many rationalist Muslims were hacked to death by Islamists for criticising Islam. They are called Kafirs if they utter a single word about their religion or its people. In spite of all this pressure the Muslims are choosing to leave their religion. The Internet has a lot of literature on the Quran and Hadiths; Present-day generation is modern and inquisitive, they are able to do their own research. If Ex-Muslim movement has to be believed then we can say the young Muslims find many contradictions, unscientific and illogical statements, discriminatory verses and calls to violence, which are helping them realise that the Quran is not God's word, but that of allegedly a human.

Again through the internet and increased access to news and world events, Muslims are seeing the brutality of Islam and are repulsed by it. The more there are incidents of brutality, the more people leave it. The murder of Mahsa Amini and many others after her in Iran has created a huge surge in people rebelling against Islam. For a long time Muslims just listened to their scholars. But those scholars were not giving logical explanations.

Increasing trend of fast food is dangerous





Delay in Appointment of Judges

A bench of the Supreme Court told the Attorney General that the government should not test our patience. Today we are calm but this peace may not last in the next hearing. Commenting on this, Justice Sanjay Kaul, the second most senior judge, said that even today a total of 70 cases of appoint-

ment, transfer and promotion of judges are pending with the government, some of which are from last November. The Attorney General was asked to come back on October 9 after asking the government for a clear reason for this delay. This anger of the Supreme Court bench was not without reason. For some consecutive years, the government has been condemning the collegium system and wants to end it. From the Minister to the Vice President, everyone is speaking against it not only in the House but also on public platforms.

The immediate reason for the bench's anger was the latest incidents of violence in Manipur. In fact, a decision of the High Court is believed to be the reason behind the start of violence in this state. The Supreme Court condemned this decision. A few weeks later, Delhi's second-most senior judge was recommended for the vacant post of Chief Justice of the Supreme Court. But the government did not respond and the state's justice system continued to deteriorate. The Supreme Court Collegium also knows that the government acts on some names and on others there is inordinate delay. Because of this, many junior lawyers become senior judges and senior and better lawyers refuse to become judges out of resentment.

The judiciary is deprived of good future judges. In view of the allegations of transparency in the collegium, the CJI recently said that a large team has formed its opinion after looking at the quality of the decisions of the judges for promotion in the last three years. However, the government should avoid such conflicts.

Dy CM Devendra Fadnavis says, "President's Rule was imposed with Sharad Pawar's consent"



he President's Rule was imposed in Maharashtra in 2019 with the consent of NCP president Sharad Pawar, said Deputy Chief Minister Devendra Fadnavis on Wednesday.

The deputy CM was responding to a question at the India Today Conclave here about the timeline of his attempt to form a short-lived government with the NCP.

In one of the biggest political surprises in Maharashtra after the 2019 polls, the then Governor Bhagat Singh Koshyari swore in Fadnavis as the chief minister and Ajit Pawar as deputy CM on November 23, 2019. However, the government fell after about 72 hours. "Post assembly elections in 2019, we were discussing government formation with Sharad Pawar. We had even finalised portfolio distribution and guardian ministers' responsibilities. But Pawar made a U-turn and backed out," said Fadnavis on Wednesday, insisting that the decision to impose the President's Rule in the state was taken with Pawar's consent

In the last Maharashtra assembly elections, the results of which were announced on October 24, 2019, the BJP won 105

of the 288 seats in the state. The Shiv Sena, which was in an alliance with the BJP, won 56 seats. However, the allies parted ways after bickering over power-sharing, with the CM's post being the bone of contention. Following the deadlock, the President's Rule was imposed in the state. "The governor has to ask every political party whether it would like to stake claim to form the government. The NCP refused to do so and its letter (to this effect) was typed at my residence in Mumbai. Pawar suggested some corrections, which were made, and then it (letter) was submitted," said Fadnavis, claiming that Pawar's consent had been taken before it was decided to go for the President's Rule.

"Pawar told us that he could not take a decision to tie up with the BJP in a short period. Pawar said he would first tour the state and announce his decision to form a government with the BJP after convincing people. Pawar said he would need one month for it," Fadnavis said. PTI

Dy CM Ajit Pawar replaces BJP's Chandrakant Patil as guardian minister in Pune





In all, seven of the nine ministers of the NCP faction, including Ajit Pawar, are entrusted with the responsibility of various districts as guardian ministers.

As per a revised list of the guardian ministers for 12 districts issued by the Chief Minister's Office, Chandrakant Patil has been given the responsibility of Solapur and Amravati districts. The naming of guardian ministers for various districts has been delayed as equations changed after Ajit Pawar and eight MLAs joined the Shiv Sena-BJP government in July this year.

NCP ministers Dilin Walse Patil, Hasan Mushrif and Dhananjay Munde will be the guardian ministers for Buldhana, Kolhapur, and Beed districts, respectively, as per the list. Their cabinet colleagues Sanjay Bandsode, Dhrmarao Baba Atram, and Anil Patil (also belonging to the Ajit Pawar camp) are given the responsibility of Parbhani, Gondia, and Nandurbar districts, respectively. From the Bharatiya Janata Party camp, senior ministers Sudhir Mungantiwar, Vijay Kumar Gavit, and Radhakrishna Vikhe Patil will be in charge of Wardha, Bhandara and Akola districts, respectively. Deputy Chief Minister Devendra Fadnavis was holding the charge as the guardian minister of Wardha, Akola, Bhandara and Amravati districts. PTI

Hospital death case: Bombay HC takes suo motu cognizance at hospitals of Nanded and Chhatrapati Sambhajinagar

he Bombay High Court on Wednesday took suo motu (on its own) cognizance of the deaths at the state government-run hospitals at Nanded and Chhatrapati Sambhajinagar and sought details from the Maharashtra government.

A division bench of Chief Justice D K Upadhyaya and Justice Arif Doctor asked Advocate General Birendra Saraf, appearing for the state government, to submit to the bench details about the state's budgetary allocation for health on Thursday.

Earlier in the day, an advocate, Mohit Khanna, had submitted a letter to the bench requesting it to take suo motu cognizance of the deaths. The bench initially directed Khanna to file a petition and said it wanted to issue effective orders. It also asked the advocate to gather data regarding vacancies in the hospitals, availability of medicine, the percentage (of funds) the government is spending and so on.

However, in the afternoon session, the bench said it was taking suo motu cognizance of the issue noting that reasons given by the doctors at the hospitals citing shortage of beds, staff, and essential medicines cannot be accepted. The HC said it would hear the matter on Thursday.

Khanna in his letter stated 31 deaths, including those of infants, were recorded at the Dr Shankarrao Chavan Government Medical College and Hospital in Nanded in 48 hours since September 30. The letter also mentioned that the deaths of 18 patients, including infants, were recorded between October 2 and 3 at the Government Medical College and Hospital at Chhatrapati Sambhajinagar. **PTI**

Five people cheated a man of around Rs 2 crore to quash criminal cases against him

44-year-old financial services expert was allegedly cheated of nearly Rs 2 crore by five people who promised to get a criminal case against him quashed and help him obtain a liquor licence claiming that they knew influential people, an official said on Wednesday.

The case came to light after the complainant approached the Matunga police station in Central Mumbai, the official said. The complainant had spent a few days with one of the accused in a quarantine centre during the CO-VID-19 pandemic. According to complainant Eric Anklesaria, a Matunga resident, he was arrested by the Navi Mumbai police in December 2020 in connection with a criminal case.

He met one Ali Raza Shaikh (27) when the two were in a quarantine centre at Kharghar during the Coronavirus outbreak. In September 2021, Shaikh called Anklesaria saying he could help quash the FIR against the latter,

said the complaint. On September 27, 2021, Anklesaria and his partners met Shaikh at a plush hotel in Vashi, where Shaikh introduced him to one Jay, alias Raju Manglani. Shaikh claimed that Mangalani had good contacts with people like ministers, lawyers and judges, said the official citing the complaint. Manglani told the complainant that one Valmik Golher, who he claimed worked with a cabinet minister, would help in getting the criminal case quashed. **PTI**

A man is suffering from skull fracture: his family blames police

23-year-old man suffered a skull fracture after someone hit him with a stick while he was riding a two-wheeler in Vakola area of the city, with his family members alleging that he was injured after a policeman whacked him on his head with his baton during a 'nakabandi'.

Based on a complaint lodged by the victim's friend Ejaz Khan, the police on Wednesday registered a case against an unidentified person for hitting the victim on his head and injuring him. As per the complaint, Sheikh was riding the motorcycle while the complainant was riding pillion. They were on their way to Oshiwara from the Mahim Dargah. But when they reached the Western Express Highway (WEH) in Vakola, they found a number of two-wheeler riders taking a U-turn and warning others not to proceed further as there was a 'nakabandi' (police check-post) ahead. **PTI**

Delhi: LG of Delhi, VK Saxena sends **Sukesh Chandrashekhar's complaint** against Keiriwal to MHA



he Lieutenant Governor of Delhi, VK Saxena, on Wednesday forwarded a complaint made by alleged conman Sukesh Chandrashekhar against Arvind Kejriwal and AAP leaders, to the Ministry of Home Affairs (MHA). The alleged conman had written a letter to Delhi LG that he was being pressurised to retract statements made against AAP leaders.

As per a statement from Raj Niwas, Sukesh Chandrashekhar, had written to the LG on July 8, 2023, through his advocate, against Delhi Chief Minister Arvind Kejriwal alleging that his lawyer Anant Malik was getting threatening calls from people claiming to be speaking on behalf of CM Kejriwal and former Home Minister, GNCTD, Satyendar Jain. "The caller (identified as Dinesh Mukhiya) is alleged to have threatened Sukesh with poisoning in his food at Mandoli Jail, which is under the control of Aam Aadmi Party (AAP) if he did not retract his statements

against Kejriwal and Jain," the statement from LG office said.

"In his letter, Sukesh has also requested that he be transferred from Mandoli Jail and out of Delhi to any Jail, which is not under the control of AAP," it added. According to the LG. Sukesh in his July letter also sought transfer to another jail, outside the national capital. "It has been submitted by Sukesh that the Delhi Prisons rule allows inmates to be transferred to their home State or any other State on special basis or reasons, and also recently the MHA had taken decisions to transfer high profile inmates/ undertrials out of Delhi " the statement added

"I am kindly seeking a transfer from Delhi Jails which is being administered by the AAP Government to any other state iail which is not under the AAP Government till the time the investigations are completed against the above-mentioned persons exposed by me," the statement from LG office quoted Sukesh's letter as saying. ANI

Tamil Nadu: CM MK Stalin announced ex gratia of Rs 2 lakh in electrocution case

amil Nadu Chief Minister MK Stalin announced an ex gratia of Rs two lakhs for the kin of the three deceased who died in Kanniyakumari due to electrocution on Tuesday night. "I am deeply saddened to hear the sad news that Chitra (47), Athira (23) and daughter Selvam Ashwin (9) died unexpectedly yesterday due to electric shock at their home," Stalin was quoted as saying in a press release from the Chief Minister's Office, the draft of which was attached to a post on 'X'.

"I would like to offer my condolences to the family of Mr. Solraj and his family and I have decided to give two lakh rupees each from the Chief Minister's General Relief Fund to the families of the deceased," he added.

"Hon'ble Chief Minister @ mkstalin has announced condolence and financial assistance to the families of those who died due to electric shock in Kanyakumari district," read a rough translation of the Chief Minister's Office post in Tamil on 'X'.



Three members of a family were electrocuted to death near Attoor in Kanyakumari district, police said. Thiruvattar Police said they have launched an investigation into the circumstances surrounding the October 3 incident in which a woman and her two children died

"Last night three people were electrocuted to death near Attoor of Kanvakumari district. Last evening, a street light's electric wire fell on the adjacent building wall on which a person kept his hand. Noticing this, his mother and sister tried to save him. All three got electrocuted and died," said Thiruvattar Police. ANI

Sikkim Floods: NDRF conducts rescue operations in Singtam town



he National Disaster Response Force (NDRF) on Wednesday conducted a successful rescue operation in Sikkim's Singtam town, saving seven people from the aftermath of a cloudburst that led to a flood-like situation. NDRF has deployed one team in Gangtok, with two additional teams stationed at adjoining areas of Sikkim.

"Our teams have rescued seven people from Singtam. We have deployed one NDRF team to Gangtok and two to adjoining areas of Sikkim in West Bengal," the NDRF told ANI. The NDRF moved its teams soon after it got the information about the cloudburst that led to the flood-like situation in the region. In a tragic incident, 23 Indian Army personnel have gone missing after they were caught in a flash flood in Sikkim late on Tuesday night. The troopers are from various units. Defence PRO, Guwahati, earlier informed that a total of 23 army personnel were reported missing due to a flash flood that occurred in Teesta River in Lachen Valley after the sudden cloudburst over Lhonak Lake in North Sikkim. "Due to a sudden cloud burst over Lhonak Lake in North Sikkim, a flash flood occurred in Teesta River in Lachen Valley. Some army establishments along the valley have been affected and efforts are on to confirm details. A total of 23 personnel have been reported missing and some vehicles are reported submerged under the slush. Search operations are underway," said the Defence PRO. ANI

Supreme Court asks "why 'a political party' has not been made an accused in matters related to liquor policy irregularities"

he Supreme Court on Wednesday asked why "a political party" has not been made an accused in matters pertaining to liquor policy irregularities as "a political party" is alleged to have benefitted from it. It is alleged that the ruling Aam Aadmi Party (AAP) in the national capital was the direct beneficiary of the liquor 'scam'.

The court query came during the hearing on a bail plea filed on behalf of former Delhi deputy chief minister and AAP leader Manish Sisodia. A bench of Justices Sanjiv Khanna and SVN Bhatti put this question to Additional Solicitor General (ASG) SV Raju, who was appearing for the Enforcement Directorate. The court remarked that a political party (AAP) is alleged to be the beneficiary of the money launder-



ing but was not made accused or impleaded in the case. "How do you answer that," the court asked ED. The court also sought to know to what extent cabinet notes can be triable in a court of law. As the hearing on the bail plea of Manish Sisodia remained inconclusive, the matter was adjourned for Thursday. Senior Advocate Abhishek Manu Singhvi, appearing for Sisodia, said his client is a sitting legislator and not a flight risk. Defending Sisodia, Singhvi said the liquor policy is an institutional

decision spread over multi-levels.

The former deputy chief minister has moved the Supreme Court seeking bail in CBI and ED cases related to alleged irregularities in the Delhi excise policy case. He moved the apex court challenging the Delhi HC order rejecting his bail plea. The CBI, in its affidavit, opposed Sisodia's bail plea, urging the Supreme Court to dismiss it saying that he is the kingpin and architect of the conspiracy in matters related to liquor policy irregularities. Sri Lanka faces biggest challenge from its bilateral lender



ri Lanka's is facing a big challenge from its largest bilateral lender, China to secure a concrete debt relief framework, as it is blocking access to desperately needed cash bailout of 3 billion US dollars' from International Monetary fund, Nikkei Asia reported. Last month's visit by IMF officials to the crisis-recovering nation seems like a hope for the country. But IMF which has insisted on "financing assurances" from bilateral lenders as a key pillar,

gave Sri Lanka a failing grade in the first review of the bailout, denying it a second tranche of \$330 million in aid.

According to the Nikkei Asia, the chances of the relief for Sri Lanka is rising for an unexpected mid-october visit to China by Lankan President Ranil Wickremesinghe to attend a 10th anniversary summit of the Belt and Road Initiative, Beijing's regionwide infrastructure building program where he will meet the Chinese President to discuss

debt relief. Meanwhile the IMF has said that the further relief aid requires the completion of financing reviews after analysing the country's record since the first injection of 330 million US dollars, approved in late march. Nekkei Asia reported quoting IMF team, headed by Peter Breuer, senior mission chief for Sri Lanka said, "These financing assurances reviews will focus on whether adequate progress has been made with debt restructuring to give confidence that it will be concluded in a timely manner and in line with the program's debt target." China is one among other nations to join lendors like Japan and India early this year to offer initial financial assurances that met the IMF's conditions to approve the March bailout, an Asian diplomat revealed. "Beijing offered a two-year moratorium for the Sri Lankan debt and talked of providing new loans to pay for existing debt," Nikkei Asia reported. ANI

Afghanistan: EU calls for immediate release of detained women defending for their rights the release of Matiullah Wesa, an



he European Union (EU) has called for the immediate release of women detained in Afghanistan for defending their and others' rights and said arbitrary detentions undermine the caretaker government's domestic legitimacy, Khaama Press reported. The Khaama Press News Agency is an online news service for Afghanistan.

Taliban authorities continue

to crack down on dissenting voices, in particular those who speak out on issues related to the rights of women and girls. EU spokesperson Nabila Massrali on Tuesday called on the Afghanistan caretaker government to release Julia Parsi and Neda Parwani, along with their family members, as soon as possible and put an end to their arbitrary detentions. Massrali continues to demand education activist who has been detained in the Taliban's prison for over six months

European Union's special representative for Afghanistan, Thomas Nicholson, meanwhile said that arbitrary detentions of those defending their and others' rights are illegal and undermine the caretaker government's domestic legitimacy. Nicholson also called for the release of women's rights activists detained by the Taliban de facto authorities. At the same time, Taranum Saeedi, a women's rights activist, in conversation with Khaama Press News Agency, stated that although women have bravely resisted for their fundamental rights in the past two years, such detentions led to the suppression of protests. Saeedi said, "Women demand their fundamental rights through civil litigation, but the Taliban, through restrictive orders, arrests, and torture, have obstructed their quest for justice." ANI

Pakistan: Atleast 10 terrorists were killed in a gun battle with the security forces in Khyber Pakhtunkhwa



t least 10 terrorists were killed in a gun battle with the security forces in the Tank region of Khyber Pakhtunkhwa's Pezu neighbourhood on Tuesday, ARY News reported citing the country's military media wing. The Pakistani military media wing, Inter-Services Public Relations (ISPR) said on Tuesday that the terrorists were killed after the security forces carried out an intelligencebased operation on the "reported presence of terrorists".

Ten terrorists were killed immediately as a result of a fierce firefight with Pakistani soldiers that took place during the opera-

tion. "These terrorists remained actively involved in numerous terrorist activities against security forces as well as extortion [and] killing of innocent civilians," the ISPR said, according to ARY News.

The security forces found a sizable stockpile of weapons, ammunition, and explosives from the terrorists after the operation. The troops have stepped up operations against militants as a result of an increase in terrorist activity since the Tehreek-e-Taliban Pakistan (TTP) announced the termination of a ceasefire with Pakistan in November of last year. ANI

55 Chinese sailors killed after nuclear submarine accident: UK media report

¬ollowing an unfortunate d capture of their nuclear submarine in a trap meant to snare British as well as the US sub-surface vessels in the Yellow Sea, at least 55 Chinese sailors were killed in an accident in August in the Yellow Sea, according to a report by the UK based newspaper, Daily Mail Online. The Daily Mail has cited a top-secret UK report. The report claims the crew members were poisoned by the oxygen system's catastrophic failure which claimed sailors' lives. The UK report, which is based on military intelligence, has a high level of secrecy.

The Daily Mail is a British daily middle-market tabloid newspaper founded in 1896, and news website published in London. Daily Mail Online further cited the top UK report which read: 'Intelligence reports that on 21st of August there was an onboard accident whilst carrying out a mission in the Yellow Sea.' 'Incident happened at 08.12 local resulting in the death of 55 crew members: 22 officers, 7 officer cadets, 9 petty officers, 17 sailors. Dead include the captain Colonel Xue Yong-Peng. Our understanding is death caused by hypoxia due to a system fault on the submarine. The submarine hit a chain and anchor obstacle used by the Chinese Navy to trap US and allied submarines,' the report read. 'This resulted in systems failures that took six hours to repair and surface the vessel. The onboard oxygen system poisoned the crew after a catastrophic failure,' it added. However, the British tabloid, Daily Mail Online has reported that the alleged disappearance of the Chinese submarine has not yet been independently verified. ANI


