Maratha Reservation: Internet services Suspended in Jalna

Internet services have been suspended in Maharashtra's Jalna district in view of violent incidents in the Marathwada region during the ongoing agitation seeking reservation for Marathas in government jobs and education, police said on Tuesday. The district in central Maharashtra, around

400km from Mumbai, is also the site of an indefinite fast launched by Maratha quota activist Manoj Jarange last week in support of the reservation demand. Internet services in Jalna district were suspended by an order of the local administration as a precautionary measure to stop spread of rumours related to violence and arson during the agitation, an official said.

On Monday, Beed district, which is also part of Marathwada, saw large-scale violence and arson by quota protesters who torched homes of two Nationalist Congress Party (NCL) MLAs and a municipal council building dur-

ing the agitation. Beed and another district in the region, Dharashiv, are under curfew since Monday. Activist Jarange is sitting on a hunger strike since October 25 at Antarwali Sarati village in Jalna district as part of the second phase of agitation for Maratha quota. **PTI**

fter hours of peaceful agitation to demand reservation for the Maratha community, the agitators turned violent and they set fire to political party offices and politician's houses. The Bharatiya Janata Party (BJP) office in Hingoli in the Marathwada region was set on fire. Earlier the houses of NCP MLAs Prakash Solunke and Sandeep Kshirsagar were set on fire. Solunke is with the Ajit Pawar-led NCP and Kshirsagar belongs to the party led by Sharad Pawar. Protesters indulged in arson and vandalism as they targeted a municipal council building. They also vandalised the office of a BJP MLA in Chhatrapati Sambhajinagar district, and pelted stones at state-run buses as they blocked highways in other parts of the Marathwada region. After the violence, authorities imposed a curfew in the Beed district, and prohibitory orders were

clamped in Dharashi district as well. They also stepped security at the houses of MLAs, MPs, and ministers as well as offices of political parties across Maharashtra.

Maratha reservation has become a political ploy. We can understand reservations being given to backward classes up to an extent because for centuries with a system of hereditary wise nature of occupation most backward classes were denied opportunities on the basis of their caste. But Marathas are the most privileged and forward community. The Maratha community was never out of the mainstream of national life. Moreover, giving

16% reservations, thus taking the total reservations to 68%, is NOT "some relaxation in this strict rule" of a maximum limit of 50% reservations. Grant of 16% reservations to the Maratha community is absolutely unconstitutional and cannot be sustained under law. Despite knowing all this, the BJP-led Maharashtra Government has resorted to this unconstitutional act. Is it not an act of cheating the Maratha community - giving them something that they are not likely to get ultimately? Is it not an act of making fools of Marathas?

At present, the total reservation in Maharashtra accounts for 52 per cent – 13 per cent for Scheduled Caste, seven per cent for Scheduled Tribe, 19 per cent for Other Backward Class, two percent for Special Backward Class, two per cent for Vimukta Jati, 2.5 per cent for the Nomadic tribe, 3.5 per cent for the Nomadic tribe-C (Dhangar) and two per cent for the Nomadic tribe-D (Vanjari). The 16 per cent quota to the Maratha community will take the total reservation in the state to 68 per cent. The Cabinet sub-committee, which has been constituted, will implement the quota if the demand can fit into the legal frame.

Most of the people from Maratha community make their livings by farming and most of the rural population are Maratha. Farming used to be their strong source of living, most of the farmers were wealthy. But over the generations, the land farmers got divided, and now the same families ended up with very less land to do the farming. There is a point in talking about the pitiful life of the farmers in Maharashtra. If the government puts sincere efforts toward making favourable policies for farmers like (even more) subsidizing fertilizers, seeds, agricultural equipment etc, teaching farmers advanced technologies, preventing factory owners and agents from looting farmers, then I don't think the farmers would need help in other forms like reservation. However, it is India, where helpful solutions are not important, but the ones which can grab some votes for politicians matter and are applied.

In the present scenario, It is difficult to establish that Marathas are socially and educationally backward. In 2003-04, the National Commission for Backward Classes rejected the demand for including the Maratha community in the Other

Backward Class (OBC) category. The Maharashtra State Backward Class Commission had held in 2008 that "Marathas are both economically and politically a forward caste. They never faced social stigma to invite backward class status." So, weighing these reports, no reservation can be given to Marathas in educational institutions (art 15) and similarly, Marathas are adequately represented in the services under the State hence, no reservation can follow either in matters of public employment (art 16). Amendment of the constitution or circumvention of constitutional provision though an act validated by courts is the way out. Interestingly, reservation in India is capped at 50% as a general rule, where ST (7.5%), SC (15%) and OBC (27%). Now, these are categories, in which there are many tribes and castes, which compete among themselves before claiming any seat. Maratha is a standalone caste. The constitution does not provide for reservation to any particular caste, caste has to be part of a category. Standalone reservation to Maratha caste is ruled out. So, the next possibility is to put Marathas in some category. Marathas cannot go in ST because they are not tribals. Marathas cannot go either in SC because they never faced untouchability and oppression like other castes in SC category. Marathas in 27% of OBC quota will be unsustainable because there is already crowding in of too many castes in OBC, plus, OBC castes may not allow it.

So, the next option is to somehow increase the OBC quota or create a new category (say OBC 2.0) with Maratha and few other castes from the OBC quota. But this will break the Supreme Court mandated limit of 50%. (such provision will also have to stand in Supreme court if challenged). India can overhaul its reservation system through constitutional amendment by replacing 'socially and educationally backward' with 'economically backward'. This would be unprecedented but will be of no use. Since reservation policy is implemented for members of groups that are known to have previously suffered from discrimination.


he Catholic Church all over the world remembers the departed ones to commemorate the faithful departed better known as All Souls Day, on November 2. Preceding it, is All Saints Day on November 1. It is observed to honour and remember all those who have lived a pious life on earth and may have not taken cognisance by the church to honour them to be revered as saints. It is presumed that they are in their heavenly abode. When can we restore the situation in Gaza?

Nearly three dozen trucks entered Gaza on Sunday in the largest aid convoy since the war between Israel and Hamas began. However, it was not enough for the citizens of Gaza because everything that is needed for human life is disconnected. That's why humanitarian workers said the assistance still fell desperately short of needs. After thousands of people broke into warehouses to take flour and basic hygiene products, they urged people to take this step.

The Gaza Health Ministry said the death toll among Palestinians has passed 8,000, mostly women and minors, as Israeli tanks and infantry pursued what Israeli Prime Minister Benjamin Netanyahu called a 'second stage' in the war ignited by Hamas' brutal October 7 incursion. The toll is unprecedented in decades of Israeli-Palestinian violence. Over 1,400 people have died on the Israeli side, mainly civilians killed during the initial attack, also an unprecedented figure.

Communications were restored to most of Gaza's 2.3 million people on Sunday after an Israeli bombardment, described by residents as the most intense of the war, knocked out phone and internet services late Friday."

Jarange Patil demands special assembly session to declare reservations for Marathas



uring a press conference, Manoj Jarange Patil, a key figure in the Maratha reservation protest,

urged for a special assembly session to declare reservations for the Maratha community.

Chief Minister Eknath Shinde

contacted Jarange Patil on Tuesday morning and engaged in a discussion that extended for more than twenty minutes.

"We don't want a half-hearted reservation. Our demand is that all the needy Marathas should get a Kunbi caste certificate," Patil said after speaking to Shinde.

Patil said that his hunger strike will continue till the reservation is granted to all the Marathas.

"We(Shinde and Jarange) spoke over the phone. I clearly told him that we will not accept the reservation which would be

Tatkare, who is part of the deputy chief minister's fac-

tion, said his party has always believed its case was different from the rebellion in the Shiv Sena, which took place in June last year. The top court, during the day, also asked Narwekar to decide the cross-petitions filed by the rival factions of the Shiv Sena seeking disqualification of each other's MLAs by December 31.

Maratha quota stir: 13 MSRTC buses damaged since Sunday, 30 depots shut

t least 13 MSRTC buses have been damaged in the last 48 hours, including four, in the Maratha quota stir underway in Maharashtra, leading to the state-run transport corporation taking a decision to shut operations in 30 of its 250 depots, an official said. Nine buses were damaged on Sunday, he said, adding the 30 depots where operations have been stopped are in Chhatrapati Sambhajinagar division of Maharashtra State Road Transport Corporation (MSRTC). "All MSRTC depots in Chhatrapati

and Chhatrapati Sambhajinagar zones in the division, have been shut," he said.

Cong's top 4 faces in Rajasthan: The King, the Challenger, the Critic and the 'Professor'

In the 2023 Assembly elections, the Congress is hoping to change a three-decades-old trend of Rajasthan voters alternating between the BJP and the Congress. To ensure this, Chief Minister Ashok Gehlot has been trying to do whatever he can – short of replacing sitting MLAs – to ensure victory. He is betting big on welfare schemes and his personal popularity, and hoping that his political acumen sees the party through. Ashok Gehlot, 72

An Economics post-graduate with a law degree, Gehlot first entered politics via the National Students' Union of India (NSUI) in college, and was its state president 1974-79. In 1979, he became the Jodhpur district president of the Congress and was the state chief by 1985.

Between 1980 and 1999, Gehlot was elected as the Lok Sabha MP from Jodhpur five times. The only time he lost was in 1989, to the BJP's Jaswant Singh. As MP, he was also a minister in the governments of Indira Gandhi, Rajiv Gandhi and P V Narasimha Rao. While Gehlot has indicated he won't be going into the sunset anytime soon, Pilot is practising the virtue of patience, reportedly counselled to wait his turn by the high command. In the coming elections, the party will look to him to shore up its votes in eastern Rajasthan, especially of Guijars.

Govind Singh Dotasra, 59: Dotasra, a trained lawyer, too entered politics via the NSUI, moving on to the Indian Youth Congress (IYC) and eventually the Congress.

But he won his first election only in 2005 at the age of 41, when he was elected pradhan of the Laxmangarh Panchayat Samiti in Sikar. That marked an upswing in his fortunes. In the 2008 next Assembly elections, he won the Laxmangarh seat.

In 2013, he was among the handful of Congress candidates who didn't just win but also retained their seat. His performance in the state Assembly sealed his place in the party. As party whip, Dotasra was a fierce critic of the then ruling BJP, and won the 'Best MLA' award in 2016. By the end of his second tenure, he had emerged as a top Jat face in the state, helping the Congress balance its caste equations.

As Minister of Primary and Secondary Education, Tourism and other departments since 2018, Dotasra has clashed with the BJP over changes in school curricula. Following Pilot's rebellion, Dotasra was made the state president in July 2020. In November 2021, he resigned as



minister following the party's 'one person one post' rule.

Dotasra was in the news recently for Enforcement Directorate (ED) raids in connection with the 2021 Rajasthan Eligibility Examination for Teachers (REET).

C P Joshi, 73 Known as 'Professor' in party circles, Joshi holds two Masters degrees – MSc in Physics and MA in Psychology, as well as a PhD in Psychol-

ogy and an LLB. He worked as a lecturer for a while at an Udaipur college and later was a professor of psychology.

Joshi's first brush with politics came in 1973, when he was elected president of the Udaipur University Students' Union. He was elected MLA from Nathdwara in 1980, 1985, 1998, 2003 and 2018. He first became a minister in the state government in 1998, with Gehlot as CM.

Kerala blast: A case gets registered against Union Minister Rajeev Chandrasekhar for promoting enmity



case has been registered against Union Minister of State Rajeev Chandrasekhar for allegedly making statements that promote enmity between different groups, police said on Tuesday. The Kerala police registered the FIR on its own in connection with the minister's recent statements on social media regarding the Kochi blasts and a Hamas leader's virtual address at an event organised by an Islamist group in Malappuram district of the state recently. A senior officer of Kochi city police said that an FIR under sections 153A (promoting enmity between different groups on grounds of religion, race, place of birth, residence) of the IPC and section 120 (o) (causing nuisance and violation of public order) of

the Kerala Police Act has been registered against the minister.

After reports of the bomb blasts at a religious gathering of Jehovah's Witnesses in Kalamassery near here came out on Sunday, Minister of State for Electronics and Information Technology Chandrasekhar put up posts on social media platform X criticising Kerala CM Pinarayi Vijayan. "Dirty shameless appeasement politics by a discredited CM (and HM) @ pinarayivijayan besieged by corruption charges. Sitting in Delhi and protesting against Israel, when in Kerala open calls by Terrorist Hamas for Jihad is causing attacks and bomb blasts on innocent Christians," he had said.

Following this, a verbal duel

took place on Monday between the CM and Chandrasekhar with the BJP leader calling Vijayan a "liar" and he in turn lashing out and terming the MoS "extremely venomous". The CM also said that if anyone makes statements which are in violation of the law, irrespective of whether they are central or state ministers, cases would be registered against them.

The blasts were set off at a convention centre in Kalamassery near Kochi where a prayer meeting of the Jehovah's Witnesses -- a Christian religious group that originated in the US in the 19th century -- was held on Sunday. A few hours after that, Martin, who claimed to be an estranged member of Jehovah's Witnesses, surrendered before police in Thrissur district of the state, saying that he carried out the multiple blasts. Initially, one woman had died and 60 were injured, six of them critically, in the blasts.

Subsequently, one of the six critically wounded -- a 53-year-old woman -- succumbed to her injuries. By Monday morning, the death toll rose to three with the death of a 12-year-old girl who had suffered 95 per cent burns in the incident. **PTI**

US: Nuclear bomb is said to be 24 times more powerful than one of the bombs dropped on Japan, media reports

The United States Department of Defence has announced that it will pursue a modern variant of the B61 nuclear gravity bomb, designated the B61-13, pending Congressional authorization and appropriation. According to a Fox News report, the nuclear bomb is said to be 24 times more powerful than one of the bombs dropped on Japan during World War II.

"Today, the Department of Defense (DoD) announced that the United States will pursue a modern variant of the B61 nuclear gravity bomb, designated the B61-13, pending Congressional authorization and appropriation. The Department of Energy's National Nuclear Security Administration (NNSA) would produce the B61-13," the Department of



Defence release said. "The decision to pursue this capability, which was undertaken in close collaboration with the NNSA, responds to the demands of a rapidly evolving security environment as described in the 2022 Nuclear Posture Review," the statement read. The B61-13 will yield simi-

larly to the B61-7, which has a maximum output of 360 kilotons, according to Fox News citing the Pentagon statement, which had a fact sheet that was included with the release.

The bomb dropped on Hiroshima, Japan, during World War II, which was around a 15 kilo-

ton bomb, is 24 times smaller than the load. Additionally, the B61-13 would be almost 14 times bigger than the 25-kiloton bomb that was dropped on Nagasaki. "...announcement is reflective of a changing security environment and growing threats from potential adversaries," said Assistant Secretary of Defence for Space Policy John Plumb.

"The United States has a responsibility to continue to assess and field the capabilities we need to credibly deter and, if necessary, respond to strategic attacks, and assure our allies." "The B61-13 represents a reasonable step to manage the challenges of a highly dynamic security environment," Plumb added. "While it provides us with additional flexibility, production of the B61-13 will not increase the overall number of weapons in our nuclear stockpile," he noted. According to the fact sheet, the powerful new bomb will also "include the modern safety, security, and accuracy features of the B61-12," Fox News reported. ANI

Pakistan govt is threatning. abusing detaining to Afghan nationals, says activist

he Pakistani government is using threats, abuse, and detention to coerce Afghan asylum seekers without legal status to return to Afghanistan or face deportation by November 1, 2023, Human Rights Watch said today. Many Afghans at risk of being deported are awaiting resettlement to the United States, United Kingdom, Germany, and Canada. Pakistan's Interior Ministry announced on October 3 that all migrants living without legal status in Pakistan had 28 days to leave voluntarily or face deportation. Broad calls by Pakistani officials for mass deportation have instigated increased police abuse against Afghans, including harassment, assault, and arbitrary detention. While not explicitly stated, Afghans slated for deportation are unlikely to be given the opportunity to challenge the action.

"Pakistan's announced deadline for Afghans to return has led to detentions, beatings, and extortion, leaving thousands of Af-

ghans in fear over their future," said Fereshta Abbasi, Afghanistan researcher at Human Rights Watch. "The situation in Afghanistan remains dangerous for many who fled, and deportation will expose them to significant security risks, including threats to their lives and well-being." Khaliq Atifi, an Afghan refugee in Islamabad who had worked as a sports journalist in Kabul and fled in December 2021, told Human Rights Watch that since the announcement, even Afghans registered with the United Nations High Commissioner for Refugees (UNHCR) are not immune to detention or deportation. "There are police checkpoints everywhere," he said. "Even if you have a valid visa, you will still be transferred to the police station, and in most cases, you need to pay a bribe to get released." He said that in most cases, Afghan refugees had to pay between 10,000 and 40,000 Pakistani rupees (US\$36 to \$144) in bribes to Pakistani police. ANI

Bangladesh: BNP clashes leaves killed, several injured

t least one person was killed and over 50 includkilled and over 50 including 15 police personnel, were injured in a clash between law enforcement and Bangladesh Nationalist Party (BNP) leaders and activists in Kuliarchar upazila of Kishoreganj, as reported by the Dhaka Tribune on Tuesday. Shariful Azam, joint organising secretary of the BNP's central committee, who was present at the scene, reported that two persons lost their lives due to police firing, while the police confirmed the death of only one person.

The victims were identified as

local Chhatra Dal leader Refavet Ullah,20, and Krishak Dal leader Billal Mian, 30, according to Shariful, Dhaka Tribune reported.

He explained that leaders and activists of the BNP and Jamaat had assembled on a local road around 9 am to enforce a blockade. However, the police obstructed their path. Subsequently, when they initiated a procession on the road, a confrontation erupted as the police engaged their members. In response, Superintendent of Police Md Russell Sheikh said, "When the protesters established blockades on the road, the police

attempted to disperse them. This led to an altercation in which the protesters attacked police personnel. To restore order, the police resorted to firing rubber bullets. During this incident, 15 police officers, including the local police station OC, sustained injuries." Furthermore, Billal Mian, who served as the president of the local union unit of Sramik Dal, lost his life, as confirmed by the police officer. Additional forces were subsequently deployed in the area to maintain control over the situation, Dhaka Tribune reported. ANI

UN calls for meeting mentions, an immediate humanitarian ceasefire

The head of the UN agency for Palestinian refugees told a UN emergency meeting Monday an immediate humanitarian ceasefire has become a matter of life and death for millions, accusing Israel of collective punishment of Palestinians and the forced displacement of civilians.

Philippe Lazzarini warned that a further breakdown of civil order following the looting of the agency's warehouses by Palestinians searching for food and other aid will make it extremely difficult, if not impossible, for the largest UN agency in Gaza to

continue operating. Briefings to the Security Council by Lazzarini, the head of the UN children's agency UNICEF and a senior UN humanitarian official painted a dire picture of the catastrophic humanitarian situation in Gaza 23 days after Hamas' surprise Oct. 7 attacks in Israel, and its ongoing retaliatory military action aimed at obliterating the militant group, which controls Gaza.

According to the latest figures from Gaza's Ministry of Health, more than 8,300 people have been killed 66 per cent of them women and children and tens of thousands injured, the UN humanitarian office said.

UNICEF Executive Director Catherine Russell that toll includes over 3,400 children killed and more than 6,300 injured. This means that more than 420 children are being killed or injured in Gaza each day a number which should shake each of us to our core, she said. Also read: 'United Nations could step in': Aaron David Miller, Carnegie Endowment for International Peace Lazzarini said: This surpasses the number of children killed annually across the world's conflict zones since 2019. And he stressed: This cannot be 'collateral damage.' PTI
