n Sunday Deputy Chief Minister Tejashwi Yadav said, "I have heard minister Amit Shah's statement where he mentioned that they have done state's caste survey which shows population of muslim and yadav's have increased but why not done for other coummunities. If BJP is in the ruling, then why they did not do the caste survey for OBC and the whole country. Yeh sab Bakwaas boltein hai".

Earlier union home minister Amit Shah accused Bihar's Nitish Kumar government of deliberately showing inflated numbers of Muslims and Yadavs in the state's caste survey as part of its "appeasement politics" while giving a "raw deal" to backward classes as a whole.

Addressing a rally at Patahi in Muzaffarpur district, Shah also charged the Nitish Kumar government with "Muslim appeasement (tushtikaran)" and warned that this could lead to "big trouble" in areas bordering Nepal and Bangladesh (seemant kshetra). Widely

regarded as the BJP's principal strategist, Shah pointed out that his party was sharing power with Nitish Kumar when the government in the state had ordered the caste survey.

Lalu Prasad. The population of Yadavs and Muslims has been inflated (abaadi badhaa kar dikha diya). And injustice (anyay) has been done to OBCs (pichhda) and EBCs (ati pichhda)," said Shah.

The former BJP president also alleged that the Congress, which has likened the survey to an "x-ray of society" and vowed to hold a nationwide caste census if it was voted to power, "has always been hostile towards OBCs". PTI

Cooperative Bank frauds can never stop in India?

n a City Cooperative Bank fraud case along with the former CEO of City Cooperative Bank Ramesh Shirgaonkar (79), and a businessman Rajan Sawant (41) who allegedly connived with him were arrested by police. The former chief executive officer (CEO) of City Cooperative Bank for allegedly causing a loss of around Rs 96 crore to the bank by sanctioning credit to ineligible people and companies. Police suspect Shirgaonkar to have fraudulently disbursed loans to 56 people without having followed due procedure in allotting these.

In the case of Sawant, Shirgaonkar allegedly did not conduct a proper inspection of his outstanding loans before providing the credit facility. Apart from this, the loan file submitted by Sawant did not in-

clude several necessary documents like the share certificates of the cooperative society, no-objection certificate (NOC) for mortgage and sanctioned building plans among other things. During an investigation it came to light that Shirgaonkar approved loans of Sawant and 55 others without proper documents.

The number of frauds in urban and state cooperative banks dropped in FY21 from a year ago with tighter oversight by the central bank. Finance minister Nirmala Sitharaman announced that the urban cooperative banks reported 323 frauds in FY21 as against 568 in the previous year and 1,193 in FY19.

Similarly, state cooperative banks witnessed 482 frauds in FY21, down from 508 in the previous fiscal but much higher than the FY19 level of 290, she said in a written reply to a question. While Maharashtra, home to the highest number of cooperatives, accounted for 67% of the fraud cases in urban cooperative banks in FY21, Kerala made up for 44% of the frauds in state cooperative banks.

The finances of cooperative banks came under heightened scrutiny recently after the government carved out the department of cooperation from the agriculture ministry to make it a full-fledged ministry under Amit Shah. Before that, affairs of the cooperative sector came under focus following the crisis at the Punjab Maharashtra Cooperative (PMC) Bank in 2019. This had prompted the government to amend the Banking Regulation Act to empower the RBI for more effective regulation of cooperative banks. The idea was to better protect the interests of depositors and avoid a PMC Bank-like crisis in future.

The amendment was also aimed to ensure that the affairs of the cooperative banks are conducted in a manner that protects the interest of depositors by increasing professionalism, enabling access to capital, improving governance and ensuring sound banking through RBI. Sitaraman also told the Rajya Sabha that gross bad loans of district central cooperative banks (DCCBs) were among the highest in the banking system, at 12.6% (Rs 35,298 crore) of their advances as of March 2020.

The gross non-performing assets (NPAs) of urban cooperative banks (UCBs), too, remained elevated at 11.3% (Rs 35,528 crore) at the end of March 2021. However, the gross NPAs of state cooperative banks were 6.7% (Rs 13,477 crore) as of March 2020, Sitharaman had said in a statement in the Upper House.

In contrast, the bad loan ratio of scheduled commercial banks stood at 7.5% as of March 2021, having eased from

8.4% a year before, the RBI said in its latest report in July. There are 34 state cooperative banks, 351 DCCBs and 1,534 UCBs in the country. Many of the cooperatives, thanks to their opaque structure and severe governance issues, have been allegedly used to funnel black money for long.

Last year Kerala police's economic offences wing arrested four functionaries of a CPI(M)-controlled co-operative bank in Thrissur district, where a loan scam of at least Rs 104 crore was detected last week. The arrested include the secretary, manager, chief accountant and a commission agent of Karuvannur Co-operative Bank. The police also conducted searches at the premises of those arrested as well as at properties of two absconding staff of the Karuvannur-based bank, and seized documents pertaining to the illegal loans. All the accused are CPI (M) members, who were sacked from the party after the scam was unearthed on July 19. The opposition Congress and BJP, which have targeted the ruling party in the state over the issue, have alleged that the loan scam is to the tune of Rs 300 crore. State Cooperation Minister V N Vasavan, however, said that an internal inquiry has revealed financial fraud of Rs 104.37 crore. But since then, there is no follow up on this issue and now another cooperative bank scam has made news. In the recent past there have been several scams but investors have no relief or life.

NIA files chargesheet against 7 ISIS members accused for involvement in Pune-based ISIS module

he National Investigation Agency (NIA) has filed a charge-sheet against seven ISIS members accused of being involved in a conspiracy to carry out terror attacks in different parts of the country, an official said on Sunday. They were charge-sheeted before the NIA Special Court here under various sections of the Unlawful Activities (Prevention) Act, the Explosive Substances Act, the Arms Act and the Indian Penal Code (IPC) in the Pune-based ISIS module case, the spokesperson of the federal agency said.

The official identified the charge-sheeted accused as "Mohammad Imran-Mohammad Yusuf Khan alias 'Matka' alias 'Aamir Abdul Hameed Khan' and Mohammad Yunus-Mohammad Yakub Saki alias 'Adil' alias 'Adil Saleem Khan'" of Ratlam in Madhya Pradesh; "Kadeer Dastagir Pathan alias 'Abdul Kadeer' and Seemab Nasiruddin Kazi" of Kondwa in Maharashtra's Pune; and "Zulfikar Ali Barodawa-



la alias 'Lalabhai' alias 'Saif', Shamil Saquib Nachan and Aakif Ateeque Nachan" of Padgha in Maharashtra's Thane

The accused were involved in collecting and raising funds for the Islamic State of Iraq and Syria (ISIS) with the intention to further its activities related to terror and violence, the spokesperson said.

The official said it was found that the accused organised ter-

rorist training camps, harboured known and wanted terrorists, and committed acts preparatory to the fabrication of improvised explosive devices (IEDs). "In addition, they were also found in possession of IEDs, firearms, and ammunition," the spokesperson said, adding that they had hatched a conspiracy to further the terrorist activities of the ISIS, with the intention to strike terror amongst the people and threaten

the security, integrity and sovereignty of India. "Investigations uncovered a larger conspiracy with international connections and the involvement of foreignbased ISIS handlers in the ongoing case. The investigation has unveiled a complex network of individuals committed to propagating the extremist ideology of the ISIS within India," the official said.

The official said the accused,

as part of this network, also took an oath of allegiance to the self-styled Khalifa (leader) of the ISIS. "Their intentions were to carry out acts of terrorism on Indian soil. The accused conducted extensive reconnaissance missions across multiple states, including Maharashtra, Karnataka, Goa, Telangana and others. Their aim was to identify potential targets for planting and detonating the fabricated IEDs, posing a significant threat to national security," the spokesperson said.

The official said they had meticulous plans for evading arrest following the potential blasts and added that "as part of their escape plan, these individuals identified remote and deep forests as possible hideouts and used drones for reconnaissance to locate suitable camping locations while on the run". "The accused were also found to be collecting funds from various sources, both within India and abroad, to finance their terror designs and plans," the spokesperson said. PTI

Raigad firm's fire incident: Eight bodies recovered, NDRF continues its search operation



¬ ight bodies have been recovered till Saturday afternoon following the fire that broke out at a pharmaceutical company in Maharashtra's Raigad district a day ago, while search for three missing persons continued, an NDRF official said. However, Raigad police, in a release late in the evening, put the death toll at seven, adding that samples had been obtained from the kin of the 11 persons, who were declared missing immediately after the blaze, for identification purposes through DNA testing.

The blaze at Blue Jet Healthcare in MIDC Mahad in Raigad district, some 170 kilometres from here, started at 11am on Friday, the National Disaster Response Force official added. "While four bodies were found till 7am, another four were recovered till 5pm. These are part of the 11 persons who had gone missing following the fire. Search operations with personnel from local agencies as well as NDRF for the remaining three continue," he said. As per initial probe, the fire may have started due to a short circuit, leading to barrels filled with chemicals at the site exploding, which further intensified the blaze, the official said. PTI

33-year-old woman from Navi Mumbai was allegedly re-Apeatedly raped by a man she got acquainted with on a matrimonial site, police said on Sunday. Based on a complaint, the police have registered an offence under section 376(2)(n) (repeated rape on the same woman) of the Indian Penal Code against the accused who is based in Singapore, an official said. The woman, in her complaint, has alleged that she was raped by the accused on multiple occasions between December 2020 and March 2023 at lodges and hotels in Navi Mumbai, Mumbai and Singapore, he said. Chhattisgarh: Congress comes with a promise of caste census and loan waiver schemes at assembly polls



he Congress on Sunday released its manifesto for the Chhattisgarh assembly polls, promising caste census, loan waiver to farmers, Rs 3,200 per quintal for paddy procurement and subsidised cooking gas cylinders to women under a new scheme.

The ruling party in Chhattisgarh unveiled its manifesto titled 'Bharose ka Ghoshna Patra 2023-28' at six different places - Raipur, Rajnandgaon, Jagdalpur, Bilaspur, Ambikapur and Kawardha - two days before the first phase of the state polls. Chief Minister Bhupesh Baghel released the manifesto in Rajnandgaon while party's state incharge Kumari Selja unveiled it in state capital Rajpur.

Promises including loan waiver to farmers, caste census, procurement of paddy at 20 quintal per acre, free education to students from KG (kindergarten) to PG (post-graduation) made

by Congress leaders during their poll campaign have been mentioned in the manifesto.

Speaking at the launch of the manifesto, CM Baghel said farmers will get Rs 3,200 per quintal for paddy, including input subsidy currently being given under the Rajiv Gandhi Nyay Yojna to paddy cultivators. Tenu leaf collection will be done at Rs 6,000 per standard sack in place of the existing Rs 4,000 and tendu leaf collectors will additionally get an annual bonus of Rs 4,000, he said.

Baghel said, "A Mahtari Nyay Yojana will be launched for mothers and sisters," under which a subsidy of Rs 500 per cooking gas cylinder will be given to women of all income groups. The subsidy will be directly deposited into the bank accounts of women, he said.

Delhi Pollution: Air Quality remains in 'severe' category



s the air quality in Delhi continues to remain in 'severe' category for the fourth consecutive day, Delhi Fire Services joined hands with the Delhi Government in curbing pollution. Visuals showed fire tenders spraying water in the hotspot areas of the national capital.

Delhi Fire Service Director Atul Garg said, "From this morning we have started spraying water. We have identified 13 hotspots, and our main focus will be on them. There are a lot of fire incidents during Diwali time. We are using the spare ve-

hicles available with us. Right now 11 vehicles are on duty." Atul Garg further said that after Diwali, more buses would be allocated for this activity. The air quality today saw a marginal dip in the overall Air Quality Index (AQI) recorded at 410 against 504 on Saturday, as per System of Air Quality Forecasting and Research (SAFAR-India).

According to the data issued by SAFAR-India, the air quality in the Lodhi Road area was recorded at 385 (Very Poor) while at Delhi University area stands at 456 (Severe). ANI

Bengaluru: Women murdered at her house

45-year-old woman, who was working as a senior Ageologist with the Department of Mines and Geology. was found dead with her throat slit in the Gokula Badavane area of Bengaluru on Sunday morning, officials said. According to the police, the deceased has been identified as Prathima, a Deputy Director of the Mines and Geosciences Department. The murder came to light when the brother of the deceased called her and when he got no response he went to her house and found her dead with her throat slit.

Giving details, South Divi-

sion DCP Rahul Kumar Shahpurwad said that the deceased was first suffocated and then strangled to death. "Pratima came home at 8 p.m on Saturday. She was first suffocated and then strangled to death. She lived alone for the past five years. No trace of robbery has been found on the spot. Three teams of police have been constituted for the investigation," DCP Rahul said. "Pratima's body has been sent to Kempegowda Institute of Medical Sciences (KIMS) hospital, Bangalore for postmortem," he added. Further investigation into the matter is underway. ANI

TMC MP Mahua Moitra alleges questions asked by BJP MP as 'cheap sordid irrelevant questions'

Taking to the social media platform, X, the TMC MP warned BJP saying that she has the 'exact' transcript of record in Ethics Committee

Moitra and opposition members of the panel "walked out" of the meeting on Thursday afternoon. Opposition members raised questions over the line of questioning and alleged that "personal questions" were posed to the Trinamool Congress MP. Trinamool Congress MP Mahua Moitra alleged that she was subjected to humiliating personal questions from the panel. She further described the episode as "proverbial vastraharan (stripping)" referring to the chapter in Mahabharat, where Kauravas humiliated Padavas' queen Draupadi in darbar. In a letter to Lok Sabha Speaker Om Birla, Mahua stated that "unethical, sordid, prejudiced behaviour was meted out" to her during the meeting.

Nepal Earthquake: Authorities scrambled to rush aid to those affected by the disaster



epal's authorities on Sunday scrambled to rush aid to those affected by Friday's earthquake that has killed at least 157 people and left a trail of destruction in the Himalayan nation's remote mountainous region. The earthquake with an epicentre in Jajarkot district, about 500km west of Kathmandu, was recorded just before midnight on Friday.

As the earthquake destroyed hundreds of houses in the mountainous region, several people had to spend Saturday night under the open sky.

Out of a total of 157 people who died in the tragedy, the bodies of 120 have so far been handed over to the family members. About 253 people were injured in the quake, the most devastating in the country since 2015. The relatives of victims were now preparing for their cremations.

Prime Minister Pushpa Kamal Dahal 'Prachanda' on Sunday held a Cabinet meeting during which he decided to provide Rs. 2 lakh cash each to the family of those killed in the Jajarkot

earthquake as immediate relief, according to officials. The Nepal government also decided to provide free medical treatment to those injured in the earthquake. "All the injured individuals will receive treatment free of cost, whatever may the cost be," Minister for Health and Population Mohan Bahadur Basnet said after the Cabinet meeting.

According to the minister, the rescue efforts for earthquake victims have been completed. But rescuers are still looking for people who could be trapped in the rubble of collapsed buildings. "The distribution of food, tarps, and tents has already begun in some affected areas, with plans for further deliveries in progress. The government is committed to ensuring that all necessary assistance is provided to the survivors," he said. This time, the government will rectify the weaknesses that occurred during the 2015 earthquake response, he pointed out. PTI

Afghanistan: Kabul residents complains about high fuel prices, lack of jobs

s winter approaches in Afghanistan, a number of Kabul residents have complained about the high price of fuel, particularly coal and wood, Afghanistan-based TOLO News reported. People said that they are unable to purchase fuel due to economic challenges and a lack of work. Najibullah, a Kabul resident, said, "There is no work, there are no foreigners, people live in poverty, now a bag of coal costs 1,500, 1,700 or 2,000," TOLO News reported.

Mohammad Dawood, a seller, said, "Our challenges are too many, people don't have money to buy fuel." He said, "People use coal and wood more because it is economical, but [currently] wood is 8,500 afghanis and 5 bags of coal is 5,000 Afghanis," according to TOLO News report. Meanwhile, Taliban-led Afghanistan's Deputy Minister of Economy,



Abdul Latif Nazari said that the problems of people of Afghanistan will be resolved by importing cheap and quality fuel, TOLO News reported.

He said, "The Islamic Emirate intends to solve the problem of importing high-quality fuel." Earlier, some of the people in Afghanistan criticised the high price of fuel and food as winter approaches. Earlier this month, the World Bank noted that half of all Afghans are living in poverty. The World Bank has revealed the figures in its latest monthly report known as the "Afghanistan Economic Monitor," TOLO News reported. **ANI**

Amid ongoing conflict between Hamas and Israel, former US President Barack Obama says, conflict is the "century-old stuff"



In a strong condemnation of the ongoing Israel-Hamas war, former US President Barack Obama has said that the conflict is the "century-old stuff" that has now come to the fore and blamed social media for amplifying the divisions, according to the New York Times. Not only did he condemn the October 7 assault on Israel that killed many innocent Israelis but he also underlined the sufferings of the civilians in Palestine.

In an interview conducted by his former staffers for their

podcast, Pod Save America, the former US President said, "I look at this, and I think back, 'What could I have done during my presidency to move this forward, as hard as I tried?' 'But there's a part of me that's still saying, 'Well, was there something else I could have done?"" the New York Times reported. Barack Obama provided a detailed analysis of the Israel-Gaza war, telling thousands of his former aides that everyone was "complicit to some extent" in the ongoing carnage. ANI

US: Over 10,000 protestors were on the streets, demanded ceasefire and end to the siege in Gaza

ens of thousands of demonstrators on Saturday (local time) crowded the streets of American cities to criticise Israel's military campaign in Gaza in response to the Hamas attack last month, The New York Times reported. The protests in New York, Nashville, Cincinnati, Las Vegas and even Orono, Maine, demanded a cease-fire and an end to the siege in Gaza.

The demonstrations came a week after vast protests in Asian and European capitals and a day after the Israeli government appeared to reject the United States' call for "humanitarian pauses" in the bombardment. The protests were filled with messages like "Mourn the dead; fight like hell for the living" and "Let Gaza live!" They also sought a shutdown of American aid to Israel, blending policy demands with anguish and ambition.

Some of the chants, most especially "From the river to the sea!" have been condemned as an antisemitic call for Israel's de-



struction, though many protesters have defended the slogan as a cry for freedom, as per The New York Times. The protests in the capital and elsewhere unfolded as public opinion surveys showed support for Israel in its military campaign against Hamas, which the United States government considers a terrorist organisation, but raised concern for Palestinian civilians.

Roughly 1,400 Israelis were killed in the attack by Hamas, and more than 9,000 Gazans have been killed in Israel's bombing campaign. Saturday's demonstrations also reflected the constellation of causes and groups that have long connected

themselves to the Palestinian cause, including black activists, student organisations, labour unions and antiwar and environmental groups. Palestinian support stormed Cincinnati with several hundred marchers clogging roads, shutting down intersections and chanting pro-Palestinian slogans under the watchful eye of a heavy police presence.

The rally and march brought together a disparate group of people. The event was organised by the Cincinnati Socialists, but it was heavily attended by Muslims, Black activists, college students and peace advocates. **ANI**
