

Air Pollution: SC directed Rajasthan and other states, says "It is duty of everyone to manage pollution"

The Supreme Court on Tuesday directed Rajasthan and other states to follow its earlier order relating to firecrackers during the festive season and stated that it was the duty of everyone to manage pollution. A bench of Justice AS Bopanna and MM Sundresh directed Rajasthan to take steps to minimise air pollution, especially during the festival season.

The court was hearing an application relating to the issue of firecrackers in Rajasthan. One of the advocates urged the court to issue directions to comply with earlier orders. The lawyer told the court that the court's earlier order was applicable to Delhi National Capital Region. The lawyer sought a pan India ban on firecrackers. The court said there is a wrong perception that it is the court's responsibility on the issue of the environment. The court remarked that it is everyone's duty to manage pollution.

The court remarked that every citizen has to see that Diwali is celebrated environment-friendly with fewer crackers. The court also shared his observation that these days elders burst more firecrackers as compared to schoolchildren. The court also directed the state of Rajasthan to take immediate steps to control pollution in Udaipur.

Meanwhile, another lawyer apprised the court about the other application that relates to stubble burning. The court has asked the Meteorology Department to file its reply in two weeks. The court also remarked that they see that there is a blame game relating to the issue.

Earlier the top court on September 22 rejected the plea seeking the manufacture, sale and use of firecrackers containing barium chemicals. Meanwhile, it also refused to interfere with the Delhi Government's decision to put a complete ban on the use of firecrackers in the national capital.

The top court was dealing with the issue relating to firecrackers. One of the pleas was filed by BJP leader Manoj Tiwari in 2022, challenging the blanket ban on firecrackers during Diwali celebrations in Delhi. In 2021, the Supreme Court clarified there is no blanket ban on the use of firecrackers and only those fireworks which contain barium salts are prohibited. **ANI**

Cast atrocities in the past - larger the breasts, higher the tax

High indu religion has many casts, and sub casts and here started the discrimination too. Castes primarily were not a symbol for status or a justification for discrimination. Ancient Hinduism had its own way of distributing human resources and labour to various sections of the society. They gave each section of the society a specific task to do. Like Kshatriyas were the warrior class. Their job was to fight for the kingdom. But, as time passed, the actual meaning of a caste tainted .Some egoistic and misguided people of the society treated some jobs as filthy or "untouchable". The reason behind this was to prove supremacy by one section over another under the excuse that God has created some sections to do the mucky works.

Upper cast men used to summon these women of lower cast to

satisfy their lust. Even today, this practice continues in rural areas. Recently a senior police official in Bihar (supposedly upper-caste) was suspended after a viral video showed him receiving a massage inside a police station from a woman who had gone there, reportedly to file a complaint of atrocities. During the 19th century, the King of Travancore announced the payment of breast tax and it was to be paid by the only so called lower caste women within that community. The breast tax was also known as "Mulakkaram". This was to harass a lower caste woman. In those days, women were treated like objects.

Once the lower caste women attained puberty, the tax would start. It is believed that this practice was put in place to suppress them, particularly people from Ezhava and Nadar. The high caste men were the ones who collected this tax. Caste system was extremely oppressive, and these women could not wear upper garments. A refusal to do so meant that it would charge them to pay for their disobedience. In those days the amount of tax to be paid was determined based on the breast size of each woman. Two primary reasons were largely attributed to the imposition of payment of the breast tax: to insult the lower caste people and burden them with debts that kept them in poverty. Sadly, while the lower caste struggled, the upper class Brahmins and Nairs continued to enjoy prosperity and decency. The era of atrocities always ends with agitation and for that, someone has to stand against the odds.

Nangeli, a lower caste woman from Cherthala, played a vital role in putting the breast tax to an end.First, she could not afford to pay the breast tax because she was from a poor family. She obviously refused to expose her breasts in public places. After hearing of Nangeli's rebellious acts and that she had refused to pay tax, a tax inspector went to challenge her to stop breaking the law. Although several authorities have reported it contrarily, it is said that when the inspector arrived at Nangeli's house, she had cut off her breasts as protest against the unjust and hateful caste-based breast tax. Once the officer sighted Nangeli's severed breasts, which had been put on a leaf, he ran away. Sadly, this incident led to Nangeli's death as she died from excessive bleeding.

This step, taken by her, led to the succeeding abolition of the breast tax. During Nangeli's burial, her husband, Chirkundan jumped into the burning pyre of his late wife and ended his life. It remains unclear whether he did this as a form of protest against the breast tax or because he was heartbroken. In their honour, we currently know

the place where Nangeli and Chirkundan both died as "Mulachiparambu", otherwise called "the land of the women's breast."

Nangeli's rebelliousness against oppression is known as a gigantic form of confrontation. Although she is well known as a local legend, history has no record of Nangeli's act of bravery and the academic has remained largely conflicted about the correct order of events. The revolution continued after Nangeli's death.

The local rulers and traditionalists didn't initially agree to the women's objections because they wanted them to keep moving about bare-chested as a sign of respect and to reflect the caste system. However, this introduced more people to Christianity, more modest standards arose which differed from the initially accepted customs. This influenced many women's decision to cover their chests. The lower caste communities continued fighting against the unjust tax system till they forced the king to abolish it. To date, it was popularly known women from the Nadar communities to have fought for the right to cover their breasts during the Channar revolt between 1839 to 1859. The breast tax was eventually scrapped in 1924.

Even today, in this 21st century, female get raped, burned killed for the lust of upper cast men. There are hundreds of incidences of protest and agitation, but things have not changed in rural areas. The Caste system has blotted Hindu religion at large.

## Court has quashed an injunction order on demolition of the Sai Resort at Dapoli owned by Sadanand Kadam, linked to UBT Sena leader

court in Maharashtra's Ratnagiri has quashed an injunction order on demolition of the Sai Resort at Dapoli in the district, owned by Sadanand Kadam, a close associate of Shiv Sena (UBT) leader Anil Parab. This is not just the case of flouting construction laws, but the plaintiff (Kadam) has violated the provisions of Coastal Regulation Zone (CRZ) rules and regulations, the district court at Khed in Ratnagiri said in the order passed on November 4.

If construction of such a structure is protected, then it would amount to illegality by the court, it added. Kadam had purchased the plot from Parab and constructed the resort. In June 2021, a notice of demolition was issued by the Ratnagiri collector as it did not have requisite permissions. Kadam later filed a suit



against the notice before a civil court at Khed in Ratnagiri which in March 2023 granted an injunction against demolition.

The Maharashtra government, through the collector, then filed an appeal against the injunction order. P S Chandgude, ad-hoc district judge, Khed, in the November 4 order while quashing the injunction order said if construction of such a structure is protected, then it would amount to illegality by the court. The court said Kadam had constructed the property "at his own peril". "He (Kadam) was aware at the time of construction about the terms that there is no permission to carry out construction within the no development zone," the court said.

Referring to an earlier Supreme Court order, the district court said the law of the land has to be obeyed and enforced. "Construction in violation of the coastal regulation zone, regulations are not to be viewed lightly and he who breaches its terms does so at his on peril," the court said relying on the apex court order. "This is not the case of flouting construction laws only, but the plaintiff (Kadam) has violated the provisions of CRZ rules and regulations," the court said.

Kadam has carried out the construction without taking permission of the authorities concerned and beyond the limits of sanctioned plan, it further said. The court said Kadam will not suffer an irreparable loss as he has a legal efficacious remedy to approach to the National Green Tribunal. "The balance of convenience is in favour of the Maharashtra government. If the construction is protected at the hand of Court, it will be protection of illegality at the hand of Court," the order said. The government claimed the Sai Resort was illegal as it did not have the requisite permissions and there were CRZ norm violations. PTI

If Bhujbal feels that OBC leaders will be targeted and attacked, then he should meet the Home Minister and give detailed information: he is a senior leader of the state," said Desai. After Chhagan Bhujbal's statement, Minister Sambhuraj Desai said, "We will meet NCP leader Ajit Pawar regarding Chhagan Bhujbal's statement and will tell him that Ajit Pawar should explain to his ministers not to make any such statement, which may create confusion in the state." ## Former employee booked in extorting case of Rs 1.97 cr from managing director of the ship management company

former engineer of a ship management company here allegedly extorted Rs 1.97 crore from the managing director of the firm by threatening to send a video of one of his vessels discharging untreated sewage in the territory of the United States to the country's Coast Guard, police said on Tuesday. Based on a complaint lodged by the firm's managing director, a first information report (FIR) under section 384 (extortion) and other relevant provisions of the Indian Penal Code has been registered against the alleged accused, an official said.

The ship management company has an office at Churchgate in south Mumbai and offices in Delhi and Singapore, he said. The complainant has alleged that he received a call from an unidentified number in June 2022, in which the caller had threatened to send a video to the US Coast Guard of a vessel discharging untreated sewage in the sea while heading towards the US from Mexico, the official said.

The caller, who identified himself as a resident of Jharkhand, claimed that the ship had violated international laws by releasing untreated sewage and demanded \$2.5 lakh (Rs 1.97 crore) from the complainant to keep the video under wraps, he said. It was later established that the caller had worked as an engineer with the firm, the official said.

The complainant, out of fear, transferred the money from the bank account of the company's Singapore office to the accused's account in Jharkhand, he said. A few days later, he again received a call from the accused, who demanded \$3 lakh this time. Following this, the managing director approached the police with a complaint, the official said. **PTI** 

## Two unidentified persons broke into a temple at Navi Mumbai, stole cash of Rs 40.000 cash

wo unidentified persons broke into a Ganesh temple in Navi Mumbai township and allegedly stole cash worth around Rs 40,000 from there, police said on Tuesday.

The incident took place in the early hours of Monday in the temple located at Shirvane in Nerul area. The two persons broke the 'hundi' (offerings box) kept in the premises and decamped with cash worth Rs 35,000-40,000, an official from Nerul police station said quoting a complaint. As per the temple's CCTV footage, the accused are believed to be in the age group of 25 to 30 years. One of them had covered his face with a handkerchief and the other one wore a black mask.

Based on a complaint by a trustee of the temple, the police have registered a case under Indian Penal Code sections 380 (theft), 457 (lurking house-trespass or house-breaking by night in order to commit offence) and 34 (common intention). A probe was on into the case, the police added. **PTI**

## Manipur High Court asked state govt to operationalise mobile towers, on trial basis

he Manipur High Court has directed the state government to operationalise mobile towers, on a trial basis, in all those district headquarters which have not been affected by ethnic strife. The direction comes after the Manipur government extended the mobile internet ban in the state till November 8 An order issued by the division bench comprising Chief Justice Siddharth Mridul and Justice Golmei Gaiphulshillu Kabui asked the state "to extend the services to areas" which were unaffected by violence. The court also asked the state to upload on its official website copies of all the orders issued in relation to the suspension or curbing of mobile internet data services

The next hearing for com-



pliance of the matter has been scheduled on November 9. Barring a few days in September, mobile internet has remained banned in Manipur since May 3 when ethnic clashes broke out. The latest move comes after a mob had, last week, attacked a camp of 1 Manipur Rifles here to loot its armoury, prompting security personnel to fire several rounds in the air.

The internet ban was extended following apprehensions that "anti-social elements might use social media extensively for transmission of images, hate speeches and hate video messages, inciting the passions of the public which might have serious repercussions for the law and order situation in the state".

The ethnic strife in the northeastern state has affected ten districts. Broadband services, which were also banned from May 4 for around two months, were made partially available since mid-July. Manipur has remained gripped by recurring bouts of violence since ethnic clashes first erupted in May.

More than 180 people have been killed since then. The clashes have occurred over a number of grievances that both sides have against the other, however, the flashpoint of the crisis has been a move to give Meiteis Scheduled Tribe status, which has since been rolled back and an attempt to turf out tribals living in protected forest areas. Meiteis account for about 53 per cent of Manipur's population and live mostly in the Imphal Valley, while tribals, which include Nagas and Kukis, constitute 40 per cent and reside mainly in the hill districts. ### SC said, "There should be guidelines in place to govern the search and seizure of phones or other digital devices of media professionals" to the Centre



The Supreme Court on Tuesday said that there should be guidelines in place to govern the search and seizure of phones or other digital devices belonging to individuals, particularly media professionals. A bench of Justices Sanjay Kishan Kaul and Sudhanshu Dhulia said that media professionals could have confidential information or details about their sources on their devices.

"It's a serious matter. These are media professionals who will have their own sources and other things. There must be some guidelines. If you take everything away, there is a problem. You must ensure that there are some guidelines," the bench told the Centre. The apex court was hearing a PIL filed by the Foundation for Media Professionals which urged the court to establish safeguards against unreasonable interference by law enforcement agencies and create comprehensive guidelines for the search and seizure of digital devices. Appearing for the Central government, Additional Solicitor General SV Raju told the apex court that the authorities cannot be shut out from examining such devices.

He said, "But there are antinationals who may... We cannot be shut out completely. Media cannot be above the law." Justice

Kaul said that guidelines were required to ensure that the powers of the agency were not misused in this respect. "Mr Raju, I am finding it very difficult to accept some kind of all-within power that the agencies have ... This is very dangerous. You must have better guidelines. If you want us to do it, we will do it. But my view is that you ought to do it yourself. It's time that you ensure that this is not misused. It can't be a State that is run only through its agencies. We will give you time, no difficulty. But you must analyse what kind of guidelines are necessary to protect them. To some extent, this is not adversarial in that sense," the bench said.

Posting the matter for hearing on December 6, the top court in its order stated, "We have put to the ASG that there has to be a balancing of interests and proper guidelines need to be in place to protect the interest of media professionals. We would like the ASG to work on this and come back on this issue. This is more so in view of the aspect that privacy is held to be a fundamental right." **ANI** 

### Tamil Nadu: Heavy rainfall in several areas caused waterlogging



Aterlogging was witnessed in several districts of Tamil Nadu, including Tiruvannamalai and Erode, which recorded moderate to heavy rainfall on Tuesday. With the onset of northeast monsoon, the state witnessed heavy downpours across several districts.

Persistent heavy rainfall on Monday night inundated houses in low-lying areas of Malli Nagar Nesavallar Colony at Periya Semur village of Erode District. State Minister of Housing and Urban Development S Muthusamy along with district administration officials inspected and took stock of the situation in low lying areas. He also assured action to be taken to build strong banks on the ponds. The India Meteorological Department has issued isolated heavy rainfall alert for Tamil Nadu, Kerala, Puducherry and Karaikal, Coastal and South Interior Karnataka, Rayalaseema and Coastal Andhra Pradesh. Waterlogging was reported in Erode because of the continuous heavy rainfall. In low-lying areas rainwater mixed with drain water inundating houses.

Residents demanded a permanent solution to the problem of waterlogging in the area. Parts of the Madurai district were also left inundated due to the incessant rainfall in the state. The Indian Meteorological Department issued an 'orange alert' in several districts in Tamil Nadu due to the heavy rains">rains and predicted heavy rains">rains till November 8. Schools have been shut in several districts due to the bad weather conditions prevailing in the state. Northeast Monsoon onset intensified in Tamil Nadu with South Districts receiving heavy to very heavy rainfall. ANI

# Israel Defence Forces said, "They have taken control of a Hamas military outpost at Gaza"

srael Defence Forces said that Israeli forces have taken control of a Hamas military outpost in Gaza City and found anti-tank launchers and missiles, weapons, and intelligence materials on the site, The Times of Israel reported. According to the Israeli forces, Israeli warplanes hit a cell of about 10 Hamas members, directed by ground troops from the Nahal Brigade, who identified the cell and directed the aerial attack on the outpost. Later, the soldiers identified an anti-tank squad operating nearby and directed an additional airstrike, according to the statement.

Taking to X, Israel Air Force stated, "An Air Force fighter jet attacked a squad of about 10 terrorists in cooperation with the fighters of the Nahal Brigade who identified the squad and directed the attack. Later, the fight-



ers identified an anti-tank squad that was operating near them and directed another Air Force aircraft that attacked the squad." During the night, the Israeli military targeted dozens of positions for mortar launches into Israel. According to IDF, Israel's naval forces targeted a number of Hamas targets overnight, according to The Times of Israel report. The Israeli military said that the soldiers also identified Hamas terrorists who had barricaded themselves in a building near the Al-Quds Hospital in the Shejaiya area of Gaza City. According to the Israeli military, these terrorists were planning an attack on Israeli ground forces.

According to the Israeli military, an aerial attack targeted the site, which resulted in "significant secondary explosions" that indicate the presence of a weapons depot, The Times of Israel reported. Earlier in the day, IDF noted that it has been a month since Hamas launched an attack on Israel on October 7. Taking to X, IDF stated, "It's been a month since the October 7 Massacre. While the world might have moved on, we don't have that privilege. Hamas started this war--yet it's a war we must fight. A war we must win." Meanwhile, the Israel Defence Forces said it has killed Hamas' Deir al-Balah battalion commander Wael Asefa.

Taking to X, the IDF stated, "The IDF eliminated Wael Asefa. Commander of Hamas' Deir al-Balah Battalion. Asefa aided in the dispatch of thousands of terrorists to assault, abduct and murder Israeli civilians on October 7th." On Monday, the Israeli Defence Forces (IDF) said it has been conducting extensive operations in the Gaza Strip over the past 24 hours and that they targeted approximately 450 Hamas targets, which included tunnels, terrorist positions, military facilities, observation posts, and antitank missile launch sites, CNN reported. ANI

## Amid ongoing war of Russia and Ukraine, It launches a missile and drone attack at port city of Odesa



Russia launched a missile and drone attack on Ukraine's port city of Odesa, causing destruction and injuring several people, Al Jazeera reported. The attack targeted critical infrastructure, including the historic Odesa Fine Arts Museum, and raised concerns about escalating tensions in the region.

Russian forces have carried out a missile and drone attack on Odesa, a vital Ukrainian port city situated along the Black Sea. Ukraine's air force reported that the assault, which took place late on Sunday, involved four missiles and 22 attack drones launched from the occupied Crimea region of Ukraine, according to Al Jazeera. The attacks resulted in the injury of at least eight people and inflicted damage on the city, including the destruction of grain and significant harm to the 124-year-old Odesa Fine Arts Museum.

Ukraine's air force reported that several of the attack drones were successfully intercepted and neutralised. The Ukrainian Air Force mentioned the interception of "Fifteen Shaheds and one Kh-59 air-guided missile," referring to the Iraniandesigned kamikaze unmanned aerial vehicle.

Ukrainian Presidential Chief of Staff Andriy Yermak responded to the attack by posting images on social media, expressing determination to seek retribution for the assault. "This is their despicable answer to the reality - the Ukrainian Crimea will be demilitarised, without the Black Sea fleet and military bases of the Russians," he said, according to Al Jazeera, **ANI** 

### UK: London Metropolitan Police has urged the agitators to postpone any demonstrations in Armistice during weekend

The London Metropolitan Police has urged the pro-Palestine protestors to postpone any demonstrations in London during the Armistice Weekend, citing fear of "fuelling disorder" and rising "anti-Semitic" activities after the October 7 attacks in Israel. "We ask organisers to consider postponing any demonstrations in #London this #ArmisticeWeekend," the UK Met Police posted on X (formerly Twitter).

The police said that the senior officers are concerned at "criminal

acts" by breakaway groups intent on fuelling disorder who are attracted by these regular events. It added that this is despite the positive work of organisers who have supported tens of thousands of people to protest peacefully and lawfully since October 7. "We are constantly examining the intelligence ahead of the weekend to understand the issues in order to respond appropriately," the police said. Earlier on Monday, senior Met officers met with organisers from a range of groups to discuss our concerns. However, they declined to postpone any demonstrations.

Deputy Assistant Commissioner Ade Adelekan said, "The risk of violence and disorder linked to breakaway groups is growing". "This is of concern ahead of a significant and busy weekend in the capital," Adelekan said. He added, "Our message to organisers is clear: Please, we ask you to urgently reconsider. It is not appropriate to hold any protests in London this weekend". **ANI** 

### Amid ongoing conflict between Israel-Hamas, Lebanese woman and her 3 granddaughters were killed at air strike

Lebanese woman and her three granddaughters were laid to rest in their hometown in southern Lebanon on Tuesday, two days after they were killed in an Israeli drone strike that hit the car they were travelling in near the Lebanon-Israel border.

Hundreds of men and women marched before the four coffins,



which were draped in black and white banners as they were carried through the streets of the village of Ainata. The coffins were later taken for burial in a cemetery in the nearby village of Blida.

Israeli troops and militants from Lebanon's Hezbollah group and their allies have been clashing for a month along the border following the start of the Israel-Hamas war. The clashes have intensified since Israel launched a ground incursion into Gaza against Hamas, an ally of Hezbollah. **ANI**

The kingZainul-Abidin hired skilled craftsmen from Central Asia to train local inhabitants in a number of handicrafts which were till then altogether unknown to the people of the state. Since then craft legacies continued and got encouragement and patronage from different rulers, princes, and visitors to the valley, thus skills passing on from generation to generation. Jammu & Kashmir has a comparative advantage in producing high quality and worldfamous fabrics of Pashmina and Kani shawls, silken, woolen, and cotton fabrics and crafts like paper-mache, woodwork, Tila work, Sozni, Crewel, etc. These products are famous the world over because of their unique craftsmanship. Handicrafts in Jammu and Kashmir present a fascinating spectrum of creative imagination and design that is intimately woven into the life patterns of its people. The agility of local artisans coupled with their artistic imagination reflected through a wide range of products has delighted people the world over for centuries. The J&K Handicrafts Department plays a vital role in promoting handicrafts products in rural as well as urban areas by providing financial and technical assistance to unemployed youth and artisans of the state for setting up micro and small units in industrial sectors under various schemes

The handicraft sector occupies an important position in the economic structure of J&K state. Being ecofriendly, this sector suits the state as it is more labour-intensive and less capital-intensive in nature, therefore, having scope for employment generation at a large scale. J&K handicraft products are worldwide famous for their attractive designs, functional utility, and high-quality craftsmanship. In the absence of largescale industries in the UT, handicrafts remained a key economic activity from times immemorial. Crafts like shawls, crewels, namdha, chain stitch,

wood carving, costume jewelry, kani shawls, paper machines, and carpets hold a significant share in the overall production and export of the state. Silken carpets in particular constitute a specialty having no parallel in quality and design at the national level and therefore, it occupies an important position in the international market.

Handicrafts refer to remarkable, skillbased creations that are made primarily by hand, reflecting the artistic traditions, cultural heritage, and craftsmanship of a particular region or community. These creations can include textiles, pottery, jewelry, woodwork, metalwork, and various other art forms.

### The reasons why the handicraft industry faced challenges leading up to the G20:

Industrialization and mass production: With the rise of

industrialization, the economy shifted towards mass production, which affected the demand for handicrafts. Factories and machines were capable of producing goods on a larger scale, often leading to lower costs and increased convenience for consumers. This shift, in turn, affected the market for handmade crafts.

**Globalization and changing consumer preferences:** The advent of globalization led to increased exposure to different cultures and products from around the world. As a result, consumer preferences started to favor massproduced, machine-made items, rather than unique handicrafts. The shift in consumer behaviour played a significant role in the decline of the handicraft industry.

Lack of infrastructure and resources: Many artisans and craftsmen lacked access to modern infrastructure, including reliable supply chains, efficient transportation, and proper marketing channels. Without these essential resources, it became challenging for handicraft producers to compete in a rapidly changing marketplace.

Economic challenges and poverty: Handicrafts are often produced in developing countries or regions with economic challenges. As poverty rates increased, people prioritized basic needs over purchasing luxury or non-essential items such as handicrafts. This resulted in decreased demand and sales for artisans

Inadequate financial support and limited access to credit: Artisans, especially in less developed areas, often faced difficulties in accessing financial support or credit to expand their businesses or invest in equipment and materials. The lack of funds hindered their ability to improve the quality of their crafts or reach out to broader markets. Limited exposure and marketing

**opportunities:** Artisans and craftsmen often struggled to reach potential buyers due to limited exposure and marketing opportunities. Without proper platforms, it became challenging to showcase their unique products to a larger audience, further contributing to the decline of the industry.

Lack of government support: In certain cases, the handicraft sector suffered from inadequate government support. Insufficient policies, lack of training programs, limited investment, and a lack of protection against cheap imitations or plagiarism negatively impacted artisans' livelihoods and the overall growth of the handicraft industry.

It is worth noting that these challenges vary in their magnitude and significance across different regions and countries. Additionally, some regions have successfully revived and revitalized their handicraft industries through proactive measures such as skill development programs, improved marketing strategies, and increased collaboration with designers and the tourism sector.

The decline of the handicraft industry before the G20 can be attributed to various factors including industrialization, globalization, changing consumer preferences, lack of infrastructure and resources, economic challenges, limited financial support, inadequate exposure and marketing, and insufficient government support. Understanding these challenges is crucial for formulating effective strategies to uplift and sustain the handicraft sector in the future.
