Mumbai land scams are under political patronage

CIDCO land scams are rampant but so far no concrete actions are taken against authorities because these scams are done under political patronage. When Devendra Fadnavis was Maharashtra's chief minister there was the biggest 'land scam' in Navi Mumbai. Cidco land, which was given to project-affected people for agricultural purposes, got denotified for development purposes by the revenue department. The formerly reserved 24 acres was allotted to eight farmers, and was bought by private developers for peanuts. However, due to the denotification, the land's rates went up, to the sole advantage of the developer. This episode hit the headlines and Congress in opposition raked up this matter but Devendra Fadnavis just cornered them in counter allegations but never answered to the accusations made against him. City and Industrial Development Corporation (Cidco) has registered a cheating case against 11 people, including a developer and five of its employees, for causing a loss of $\gtrless17$ crore by illegally selling a plot originally used for building houses for Cidco employees. The plot at Nerul was acquired by a housing society in 2002. Sneha Pushpa Housing society was formed in 1993 and was supposed to house only Cidco employees. In 2002, the plot was given to the housing society on a 60-year rent agreement against a deposit of $\gtrless73.79$ lakh, as per the complaint of a Cidco officer.

Mumbai land scams are under political patronage

Recently, the Navi Mumbai Anti-Corruption Bureau (ACB) arrested a CIDCO officer and an agent for accepting a bribe of ₹50,000.

On several occasions, the City and Industrial Development Corporation of Maharashtra Limited (CIDCO) had staked its claim over the 24-acre plot of land at Kharghar in Navi Mumbai.

Mumbai is not new to land scams and the politicians are guards of land sharks and mafias. Mumbai slums, CIDCO and MIDC are subjected to land scams and in each scam directly or indirectly there is political approval. The then chairman of the 30-member society inducted a developer, Haresh Nagji Chheda, as a member. Eventually, all members were replaced with non-Cidco people. As per the Cidco rules and regulations for the lease of land, only Cidco employees can be members of the housing society.

Recently, the Navi Mumbai Anti-Corruption Bureau (ACB) arrested a CIDCO officer and an agent for accepting a bribe of ₹50,000. The accused have been identified as Sagar Madanlalji Tapdiya (47), an assistant estate officer from CIDCO, and private agent Ravindra Hukmichand Chajed (54). While Tapdiya is a resident of sector 16 in Kharghar, Chajed resides at Khanda Colony in Panvel. The complainant had approached CIDCO to transfer a property to his name. He met Chajed who said ₹50,000 will be needed for the procedure. Actions are being initiated and if you have more proof go to appropriate authorities for action please.

On several occasions, the City and Industrial Development Corporation of Maharashtra Limited (CIDCO) had staked its claim over the 24-acre plot of land at Kharghar in Navi Mumbai. The Anti-Corruption Bureau (ACB) has filed a chargesheet against 24 people, including a former chief of state planning agency CIDCO, in a land scam in the district which dates back to 1984. The charge sheet was filed by ACB in the court of Thane Additional Sessions Judge M C Khadke. The accused include officials of Revenue Department, Cooperation Department, CIDCO and real estate developers, who according to the document, conspired to cause monetary losses to the exchequer. They were charged under the Prevention of Corruption Act and relevant sections of the Indian Penal Code (IPC). Because of government affiliation and influences many publication houses have wrongfully acquired CIDCO lands. The lands are allotted too many businesses at a very nominal rate.

Mumbai is not new to land scams and the politicians are guards of land sharks and mafias. Mumbai slums, CIDCO and MIDC are subjected to land scams and in each scam directly or indirectly there is political approval. Many politicians also have acquired benami properties and there is no action or accountability. Mumbai real estate scams have been rampant in the past ten years. Many builders in the Mira-Bhayander area were found to have used bogus paperwork to show that

a particular plot of land in Bhayander was developed under a "green zone". If we go to Kalyan west side, all green zone properties are converted into chawls and row houses. Corrupt KDMC approves these projects in the greed of bribes. Builders have no fear as the administration is on their laps for money. Local netas have a stake in every construction project.

The Metro 3 car shed site at Aarey Colony was always a forest, contrary to what the government claims, said the Aarey Conservation Group (ACG) on Friday, producing documents alleging a Rs 60,000-crore land scam. Till 2016, the colony was part of an eco-sensitive zone (ESZ), which was denotified to allow construction activity, and almost 250 acres more land than required for the Metro project were claimed at both Aarey and Kanjurmarg to benefit builders. The Kanjurmarg plot activists suggested for the Metro car shed is Maharashtra government-owned and not under litigation - contrary to what the state claims.

Till 2015, the forest department held that all of Aarey was required to be included in the ESZ of Sanjay Gandhi National Park. But in early 2016, it was the then chief minister Devendra Fadnavis who, was in his CM's war room, directed the department to denotify parts of Aarey for the Metro. Eventually, almost 408 acres of Aarey was denotified by the forest department for the Metro, in compliance with the CM's war room directives. The war room minutes revealed that Fadnavis had directed that the areas for Metro depot be termed as 'depot & allied activities', with 'allied activities' to mean commercial development, but this was not to be revealed till necessary later.

SC on saying no to same-sex marriages

Rahul Gandhi says, "Sharad Pawar is not the prime minister of India" over recent meetings of Sharad Pawar and Gautam Adani

ongress leader Rahul Gandhi on Wednesday said he has not asked NCP supremo Sharad Pawar about his recent meetings with Gautam Adani, asserting that the Maratha strongman was neither the prime minister and nor was he protecting the billionaire businessman. Pawar's meetings with Adani amidst demands by several INDIA bloc parties for a Joint Parliamentary Committee (JPC) probe into allegations levelled by US-based short seller Hindenburg has raised eyebrows in the opposition ranks.

Asked whether he had questioned Pawar about his meetings with Adani that seemed at odds with the stand taken by many



opposition parties, Gandhi said, "No, I have not asked this. Sharad Pawar is not the prime minister of India. Sharad Pawar is not protecting Mr Adani, Mr Modi is and that is why, I ask Mr Modi this question and not Mr Sharad Pawar." "If Mr Sharad Pawar was sitting as the prime minister of India, and if he was protecting Mr Adani, then I would be asking Mr Sharad Pawar that question," the former Congress chief said at a press conference at the AICC headquarters here. Pawar had visited Adani's office and residence in Ahmedabad in September. In April this year, Adani had visited Pawar's Silver Oak residence in south Mumbai.

This meeting, which lasted for almost two hours, came with-

in days of Pawar coming out in support of Adani and criticising the narrative being built around the Hindenburg report. His position was seen at variance with his allies such as the Congress, which has been seeking a JPC probe into the allegations of fraud and stock market manipulations against the Adani Group. Pawar had at that time stated that he favoured a Supreme Court committee probing allegations against the Adani Group. Adani had also visited Pawar's residence in June.



The relationship between Pawar and Adani goes back nearly two decades. In his Marathi autobiography 'Lok Maze Saangati', published in 2015, Pawar heaped praises on Adani who at the time was venturing into the coal sector.

The Congress has also been questioning the financial dealings of the Adani Group after Hindenburg alleged "irregularities" and charged it with stock price manipulation. The Adani Group has denied all the allegations made in the Hindenburg report and claimed there has been no wrongdoing on its part. **PTI**

Dy CM Devendra Fadnavis said, "Lalit Patil's arrest will soon give a 'major revelation' over drugs nexus



he arrest of Lalit Patil, an accused in the seizure of mephedrone worth nearly Rs 300 crore, will soon be followed by a "major revelation" over his drug nexus in Maharashtra, Deputy Chief Minister Devendra Fadnavis said on Wednesday. The senior BJP leader was speaking to reporters in Pune after the Mumbai police said they had arrested Patil near Bengaluru. With his arrest, a huge drug nexus will be unearthed, he claimed. "A major revelation will soon come out in connection with Lalit Patil and his drug nexus in the state. Those

who are currently loosely talking about the state's affairs will be shut completely," he said. Patil, an inmate of the Yerawada Jail in Pune, was apprehended on Tuesday night by a team of Mumbai's Sakinaka police, an official said earlier. "A Mumbai police team nabbed Lalit Patil from a hotel between Bengaluru and Chennai," he said.

Patil escaped from the government-run Sassoon General Hospital in Pune on October 2 when he was taken for an X-ray. Asked about his escape from the hospital, Fadnavis, who is also the state's home minister, said, "No one will be spared. The inquiry into this matter is going on. All those who made a mistake will face action." Nine policemen were suspended after Patil's escape from the hospital. Patil was wanted in a multi-crore mephedrone seizure case, busted by the Sakinaka police after raiding a factory in Nashik, the official said. He is the 15th accused arrested in this case, he said.

The Mumbai police on October 6 said they had seized 151 kg of mephedrone worth Rs 300 crore and arrested various persons from different cities in an operation that the last two months, including the raid at a drug manufacturing unit in Nashik. Following arrest, Patil was on Wednesday produced before a magistrate court in Andheri which remanded him in police custody till October 23. The police sought Patil's custody saying the accused arrested earlier in the case had revealed his name. Patil was arrested based on suspicious call data records that the police recovered and further probe was required into it, they said. PTI

MNS chief Raj Thackeray says, "I have never seen such an absurd and ugly political situation" over state politics

aharashtra Navnirman Sena chief Raj Thac-Lkeray on Wednesday deplored the "ugly" politics in the state, saying factions of the Shiv Sena and NCP are in power and also in opposition. "In Maharashtra, the parties which are in power are also in the opposition. Such a scenario exists only in our state. and nowhere else in the world. I have never seen such an absurd and ugly political situation. Factions of the Shiv Sena and Nationalist Congress Party are in power and the remnants are in the opposition," he said.

Thackeray was addressing a meeting ahead of the registration of voters for the graduates and teachers constituencies' elections. The Shiv Sena split last year when senior leader Eknath Shinde and the bulk of MLAs rebelled against the leadership of Uddhav Thackeray. Shinde later joined hands with the BJP to become chief minister.

In July this year, senior NCP leader Ajit Pawar and eight MLAs joined the Shiv Sena-BJP government after rebelling against NCP founder Sharad Pawar. Ajit Pawar had told the Election Commission that a majority of MLAs support him.



Thackeray also condemned the collapse of a girder of an overbridge which was being constructed on a section of the Mumbai-Goa highway in Chiplun city on Monday. "The flyover (overbridge) worth Rs 140 crore was damaged even before its construction was completed. Crores of rupees are wasted but nobody is bothered. Still, votes are sought and people too exercise the franchise," he added.

The MNS chief, who had threatened to burn down the toll booths if the state government's purported order to exempt small vehicles from paying the toll was not implemented, cited a lack of data on the number of vehicles passing through toll plazas. "90 cameras are installed at every toll booth but still there is no account of how many vehicles pass through it. Mumbai and Thane register hundreds of vehicles every day. However, the number of vehicles passing through these toll booths does not change. How is this possible?" he wondered. PTI

Pakistan: PIA faces turbulences, cancels its flight operation after non-payment of dues



Pakistan International Airlines (PIA) faced fresh turbulence as its domestic flight operations were disrupted on account of non-payment of dues, leading to a complete halt in the supply of aviation turbine fuel to the carrier, the Dawn reported. The Pakistan-based daily reported further, citing official sources, that Pakistan State Oil (PSO) halted the supply of aviation fuel to the national carrier on Tuesday.

In a direct fallout of the same, the airline cancelled 14 domestic flights while four others were delayed by several hours, the report added. The cancelled flights included two from Islamabad to Gilgit, one from Islamabad to Quetta, one from Karachi to Sukkur, one from Islamabad to Multan and another from Karachi to Faisalabad, Dawn reported. Likewise, PIA flight PK304 from Karachi to Lahore was also delayed by about three hours due to the suspension of fuel supply to Karachi airport. The flight was scheduled to depart at 2 pm (local time) but took off eventually after a 3-hour delay. PIA flight PK305 from Lahore to Karachi also arrived late in Lahore. Another PIA flight -- PK308 -- from Karachi to Islamabad was also delayed due to the suspension of aviation fuel while another flight, PK309, from Islamabad to Karachi was delayed as well.

Due to the cancellation and delays of PIA flights, hundreds of passengers have been facing serious inconveniences over the past several days, said the report, adding that not only fliers but also the crew are bearing the brunt of the current crisis. The PIA had requested an emergency bailout of Pakistani Rupees (PKR) 22.9 billion, which was rejected by the Economic Coordination Committee (ECC).

The ECC also turned down a request by the PIA for deferment of the payment of Rs 1.3 billion per month, which the national carrier pays to FBR against FED and Rs 0.7 billion per month which it pays against the rising charges, Geo News reported. The PIA also warned that Boeing and Airbus might suspend the supply of spare parts for its fleet by mid-September. In July, the Federal Board of Revenue (FBR) froze the national carrier's account on the basis of non-payment of more than Rs 2 billion in taxes, according to ARY News. ANI

Media Reports: Amid ongoing conflict between Israel- Hamas, People staged protests in Jordan over explosion at hospital

mid the explosion at a hospital in the Gaza Strip that killed hundreds of people, protests and skirmishes broke out in the West Bank, Lebanon and Jordan, The Times of Israel reported on Wednesday. According to The Times of Israel, hundreds of protesters took to the streets to protest the explosion all across the West Bank. To control the crowd, the Palestinian forces in Ramallah fired tear gas at demonstrators who were calling for the Palestinian Authority President Mahmoud Abbas to step down.

The protesters are seeking the resignation of President Mahmoud Abbas, the head of the Palestinian Authority, over his conciliatory tone since the war between Israel and Hamas in Gaza began earlier this month, The Times of Israel reported. In videos, the protesters in Ramallah were seen chanting "The people want the fall of the President." In Jordan, protesters tried to storm the Israeli embassy with videos circulating on X (Twitter) showing an angry crowd surrounding the building and attempting to force their way inside. In Lebanon, Lebanese terror group and Iranian proxy Hezbollah called for a "day of rage" to condemn the hospital blast, as hundreds of demonstrators also gathered at the French and US embassies in protest.

According to The Times of Israel, Hezbollah, blamed the hospital blast on Israel, calling it a "massacre" and a "brutal crime." Additionally, Jordan King Abdullah II has marked the Israel attack on Gaza as "brutal" and asked Israel to end it. Taking to X, the Royal Hashemite Court (RHC) posted, "His Majesty King Abdullah II says Israel must end its brutal aggression on #Gaza"It added, "His Majesty King Abdullah II says Baptist Hospital massacre in #Gaza is a heinous war crime that cannot be ignored." ANI

Israel- Hamas conflict: US President Joe Biden mentioned that "It will give full support to defend itself from terror group"

Difficult visit to Tel Aviv backed Israel's claim that the strike on a hospital in Gaza hospital seemed to have been carried out by the "other team" in reference to Palestine terror group Hamas. He also asserted that the US will make sure that Israel would get what it requires to defend itself from Hamas attacks.

"Americans are worried because we know there's this is not an easy field to navigate what you have to do, but the fact is that Israel as they respond to these attacks, it seems to me that have to continue to ensure that you have what you need to defend yourselves. And we're going to make sure that occurs as you know," Biden said. Addressing a joint media briefing with Israel Prime Minister Benjamin Netanyahu, Biden said, "We have to also bear in mind that Hamas does not represent all the Palestinian people and it has brought them only suffering." On Tuesday's attack on the Al-Ahli hospital, Biden said he was "deeply saddened" and "outraged" and emphasised that the preliminary data says that the explosion was done by Hamas.

It's beyond my comprehension to imagine what they were thinking." "They have committed evils and atrocities that make ISIS look somewhat more rational," Biden said. **ANI**

Israel Defence Force released report claiming "Technical evidence to prove that the explosion at the AI-Ahli Baptist Hospital was due to a rocket misfired"

The Israel Defence force today released what they claimed was technical evidence to prove that the explosion at the Al-Ahli Baptist Hospital was due to a rocket misfired by the Islamic Jihad terror group. Spokesperson of Israel Defence Forces (IDF), RAdm. Daniel Hagari released an audio that claimed to be a conversation between two terrorists who admitted that the rocket fired on the Hospital belonged to their group.

In a press conference, Israel military spokesperson asserted that the preliminary investigation suggested that the rocket fired at the Hospital was from the barrage of rockets fired towards Israel which was launched nearer to the Hospital. "Trajectory analysis from the Barrage of Rockets con-

firms that the rockets were fired close proximity to the hospital. In addition, there are two independent videos which show the failure of the rocket launch and the continuation of rocket flight towards the ground within the Gaza stream falling in the hospital compound," he said. He added, "Third, we have intelligence that will be shared here of communication between terrorists talking about rockets misfiring. The terrorists realised that the rocket had misfired and made specific reference to the Al-Ahli Baptist Hospital. I would want to let everybody hear the conversation, I will do the translation in English."

Further, he translated the conversation of two terrorists while the audio was played in the background. The members of the terror group, 1st person is quoted as saying, "I'm telling you this is the first time that we see sound like this falling and so that's why we are saying it belongs to the Palestinian Islamic Jihad. They are saying it's from us (Hamas)" 2nd questioned, "What they are saying, it's from us?" Then the first person says, "They are saying the shrapnel from the missile is local shrapnel and not like Israeli shrapnel. But God bless, it couldn't have been found another place to explode."

Later the IDF spokesperson said, "These rockets fell short of Israel and have caused Palestinian casualties. During this war, we have counted approximately 450 rockets that misfired and fell inside Gaza. Palestinian civilians pay the price of that." **ANI**

II Do you have more of stress or more of happiness of giving care to your 99-year-old mother-in-law?" Bank officer Jayashree Parimal, who consciously attends the impending centurion, replied: "...It's natural in me to take care of her. I've seen my own mother struggling in her sunset years. Obviously, the happiness..., which cannot be measured...".

Also qualified in Attention Deficit/Hyperactivity Disorder (ADHD) discipline, Jayashree was modest when she downplayed the stress factor. For her, caregiving is a blessing. The dialogue triggered interesting insights about caregiving.

Family caregiving is unseen, make it visible

The rising life-expectancy imparts that we all may one day enter our elongated terminal moments. The aged, more rely on family to get through the day. In Indian homes, it is not unusual to see adult children sandwiched between parenting and caregiving. How to navigate the murky waters of eldercare, spread the care among families? The informal chat reminded the forgotten segment: the caregivers.

Young or old, caregiving can happen overnight due to loved one's sudden health change, or it might move on you slowly. It could be Alzheimer, renal failure, cardiac care.... The physical decline also comes with aging, or memory loss issues, or both. A caregiver usually provides care to another person who's in need of daily living support. However, family members who actively care for an older adult often don't self-identify as a "caregiver". By nature, they're content to stay in the shadow of their loved ones, focused on the ailing/aging needs. Keeping aside their own feelings, hurts, and wants, they make the sinking days as placid as possible.

Family caregivers wear many hats. A cook, driver, nurse, companion, physical therapist, housekeeper, banker, financial planner, personal assistant (bathing, grooming, toileting), and so on. You also help your loved one cope with feelings, like when he or she feels sad or angry, and engaging in conversations.

Trying moments

Brittle bones, frail muscles, poor reflexes, the mental slow down - the whole system gets fragile, and the caregiving needs get imminent. And, how does it impact the caregiver?

A family (unpaid) caregiver can be susceptible to mental and physical health risks, can be vulnerable to accumulated stress, depression and anxiety. Other risks like financial issues, constant worrying, feeling frequently tired, hypertension, sleep deprivation, headaches, body pain, ultimate risk of burnout - all can strain even the most resilient person. Anyone who provided chronic care can relate to at least one of these risks. Some caregivers feel that taking care of their own needs is a luxury they can't afford.

Take care

Remember, your own needs are critical, too. Caregiving upgrades when you care enough about yourself.

Take just 15 minutes a day, create your space. Don't confuse self-care with "selfish". You may want to watch TV, call a friend, work on a hobby... . Playing with kids, pets, gardening are helpful, too. If you had health problems before, it even more matters now. Don't miss your checkups, medicines, exercise, diet...

Be attentive listener to the loved



one. Use open-ended questions. By listening, they feel loved, valued and esteemed, and you're fully present.

Express your feelings. Talk to a counsellor, if need be. Don't pretend to be cheerful. Focus on things that you're worth your time and energy. Don't take your loved one's anger personally. Be hopeful.

Believe that you're doing your best. Say no to requests that are draining, such as, hosting and entertaining guests, unless it energises you. Don't carry around any guilt, as it adds to the stress. Your caregiving role may not last forever, which is both positive and negative.

Ask for help, support is key. It could be cooking, cleaning, childcare, shopping, driving for doctor visits, get information you may need... Your loved one may feel less guilty; others may offer time and skills that you may lack. It's not always easy. When tough things happen, many tend to flee.

Noble and beautiful

Most of us come into this world watching our parents as healthy and strong. As we grow, and as they age, the childlike feeling that they're a continual part of our lives wither. For adult children the experience presents subtle grief. It's a stressful transition when you see your parents less as capable caregivers and more as those needing care themselves. The caregiving role is even more significant when some elderlies are victims of their own children, which is, of late, becoming common. Be mindful. You probably learnt more about yourself along the way.

Also, teach children in school about caregiving, bring it in to the curriculum. It's a way of normalising caregiving towards a compassionate community. Elders need help, or more help. Are you ready to step up?

When your days as caregiver ends, you'll want to recall the dear and satisfying moments to cherish, and you're surrounded by a beautiful world to acknowledge. Just as critical, you'll always want to have a life to return to, filled with people you love, activities that interest you, and the good health to enjoy them. So, Jayashree, your message is well taken!
