## Sanjay Raut and BJP Bawankule locked horn over casino controversy

Few days ago, state BJP chief Chandrashekhar Bawankule was seen in a casino in Macau, sharing the photograph Shiv Sena (UTB) leader Sanjay Raut had posted a photograph on X purportedly showing Bawankule in a casino in Macau. He wrote in his post "I do not know whose photo it is. Someone told me he was a prominent personality from Maharashtra. Within a span of two-four hours, he spent ₹3.5 crore. It means there

is suddenly 'acche din' in Maharashtra," he had told reporters two days ago.

While clarifying the allegation Maharashtra BJP chief Chandrashekhar Bawankule said it was a deliberate attempt to defame him and hurt his family. He denied allegations made by Raut that he was seen in a casino in Macau. Bawankule claims the photo was taken to defame him and says it is impossible to take such a large amount of money to a foreign country. Raut has defended his actions, saying he tweeted the photo out of humanity.

"I have reached this stature by hard work and a struggle. I am so busy with the party work that I manage to spend only one day in a month with my family. They (the family) insisted that I stay with them for three days, and hence we planned a trip to Macau. Every hotel there has a casino, and you cannot reach your room without going past the casino. The picture was clicked during that period just to defame me," he said.

Bawankule further explained how anyone could take ₹3.5 crore to a foreign

country. "Even if you carry ₹1 lakh you are made to go through several rounds of checks. Neither do I have any friends there. Therefore, the question of spending such a huge amount does not arise at all."

To counter Bawankule, Raut tweeted only one photograph out of humanity. "Bawankule should teach leaders from his own party about the pain the families of opposition leaders go through after the attack from those in the ruling alliance. What the leaders from his party do is part of their culture."

Most of the Bangladeshi Muslims are all converted Muslims from Hinduism. As a result, the Muslims of Bangladesh are not as strict Muslims as people from the Middle east or even Pakistan. Although present day Bangladeshi's ancestors were Pakistanis at one time in history, the people couldn't remain as Pakistani because of political and cultural clashes with the rest of Pakistanis. A typical Bangladeshi Muslim doesn't know how to read Arabic. For a Bangladeshi Muslim culture of India or Hindu centric culture is more familiar and attracts him more than Arab culture.

It's a secular country with Muslim majority of 90.3% of the country population. Minorities are 8.2% of Bangladesh population.

Bangladesh is a Democratic country as per their constitution. The constitution of Bangladesh recognized secularism as a fundamental right for welfare of the country's citizens. But Bangladesh has declared Islam as official religion of the nation.

Bangladesh is functionally a Muslim country, even if its Constitution pays lip service to secularism. The original Constitution of Bangladesh, written in 1972, enshrined secularism as one of the four pillars of the newly-formed People's Republic of Bangladesh, and defined the word "Bengali" as a demonym for its citizens.

However, beginning in the mid-1970s, a wave of Islamization swept over the country. The political forces which had been opposed to the Liberation from Pakistan regrouped under the banner of the Bangladesh Jamaat-e-Islami, Jamaat Shibir and other groups.

Weak governance under Prime Minister Sheikh Mujibur Rahman and the consequent civil unrest propelled General Ziaur Rahman to power in a military coup in 1975. By 1977, after a series of additional coups and counter-coups, he became head of the armed forces, and eventually became President. In 1978, Rahman and others founded the Bangladesh Nationalist Party, which espoused an ideology of Islamism and Bangladeshi nationalism

In 1977, the principle of secularism was removed from the Constitution through the 5th Amendment, as were references to freedom of religion for minorities, and was replaced with the statement: "absolute trust and faith in Almighty Allah". In 1988, the government of Muhammad Ershad passed the National Religion Bill in the Jatiyo Sangsad Bhaban (Parliament of Bangladesh), declaring Islam as the state religion.

By 1991, the hardline Muslim conservatives had already amassed enough power and influence to come to power and form a government (thanks, in part, to generous foreign funding from the Gulf, as well as a widespread system of madrassahs which were constructed starting in the 1970s, creating a pronounced religious-nationalist zeal in the public).

In 1997, the opening words 'bismillah-ar-rahman-ar rahim' (In the name of Allah, the Beneficent, the Merciful) were added to the Constitution. In 2005, the High Court of Bangladesh ruled that the 5th Amendment (1977) was illegal and unconstitutional, and restored a constitution "in the spirit of the constitution of 1972", which restored secularism as a key principle, but which retained some of the language introduced in 1977 and 1997, namely "absolute trust and faith in Almighty Allah" (1977) and 'bismillah-ar-rahman-ar rahim' (1997).

In 2010, the Supreme Court of Bangladesh upheld the 2005 decision of the High Court, but some of the changes from 1977, as well as the 1997 insertion, still remain. The Court also decided to let Islam remain as the state religion. In August 2015, a petition was filed in the High Court challenging the constitutional provision of Islam as the state religion in light of the constitution's commitment to secularism, but in March 2016 the High Court rejected the petition and retained Islam as the state religion.

Bangladeshis are by ancestry originally descendants of low caste Hindus and Buddhists who just some centuries ago converted to Islam. Due to Bangladeshis being relatively newly converted Muslims the culture is extremely different from mainstream Islamic culture which is seen in the Middle east or even Pakistan. Their culture is a mix of Islam and Hinduism where Hinduism has strong presence in traditional culture, attires, food habits etc. One side has Islam as religion and other side has Hindu-Buddhist culture. Bangladeshis love Islam but majority are not five times Namazi.

A Bangladeshi carries both Indian and Pakistani legacy. Every Bangladeshi was Indian before 1947 and Pakistani before 1971. India and Pakistan both gave birth to Bangladesh. So, there are people who carry Indian sentiments and there are people who carry Pakistani sentiment.

### Urgent Call for Protection of Hospitals and Civilians in Conflict Zones

The recent distressing reports from the Occupied Palestinian Territory and Ukraine paint a grim picture of the vulnerability of hospitals and healthcare facilities in conflict zones. The deliberate targeting of medical institutions and personnel, as well as the tragic loss of innocent lives, demands urgent attention and action from the global community. The assault on hospitals, such as the Indonesian Hospital in Beit Lahiya and incidents in Selydove, Donetsk Region, is a blatant violation of international humanitarian law. These attacks not only result in devastating casualties but also deprive civilians of critical medical assistance in times of dire need.

As outlined by the Humanitarian Coordinator for the Occupied Palestinian Territory, the protection of hospitals and medical staff is a fundamental principle of international law. All parties involved in conflicts must honor these protections, ensuring that hospitals are not used as

## Fire broke out in a 24-storey residential building, Nine people suffered from suffocation



**N**ine people suffered from suffocation after a fire broke out in a 24-storey residential building in the Byculla area of Mumbai on Thursday, officials said. The nine people, including five senior citizens, have been admitted to a hospital and kept under observation, they said. The blaze erupted at 3.40 am on the third floor of the building located in New Hind Mill Compound at MHADA colony

in the Ghodapdeo area of Byculla where the government has given flats to people, mainly mill workers, they said. The fire was confined to the electric meter cabin, wiring, cable, scrap material in the electric duct, garbage and material in the garbage duct from the 1st to 24th floor of the building, a civic official said.

He said at least 135 people were rescued from different floors of the building. Out of

them, 25 were evacuated from the terrace, 30 from a refuge area on the 15th floor, and 80 people from a refuge area on the 22nd floor of the building, he said.

Those who got suffocated after the blaze have been identified as Lakshmi Raut (70), Archana More (75), Parvatibai Tambole (85), Lata Tambole (67), Pranay Tambole (28), Archana Nilesh More, Mumtaz (60), Abhish (36) and Vishal Vijay More (34), a civic official said. Five fire engines and three water tankers along with other fire brigade vehicles were rushed to the spot after receiving the call and the blaze was doused by 7.20 am, a fire brigade official said.

The cause of the fire is not yet known, but a short-circuit is suspected to have triggered it, a civic official said.

## BMC to inaugurate Delisle Bridge in Mumbai today



**D**ays after the civic body filed an FIR against MLA Aaditya Thackeray and other Shiv Sena (UBT) leaders for “illegally inaugurating” the second carriageway of Lower Parel’s Delisle Bridge, the Brihanmumbai Municipal Corporation (BMC) is slated to officially inaugurate the bridge on Thursday. While the bridge will be inaugurated by City Guardian Minister Deepak Kesarkar, civic officials said Aaditya has also been invited to the event among other leaders.

Situated in Lower Parel, the newly constructed Delisle Bridge comprises three lanes in each direction on Joshi Marg and two lanes in the direction of the Ganpatrao Kadam Marg. According to BMC, the reconstructed bridge has been widened and will now consist of four new staircases as well as two new escalators. “Due to the increase in the width of the service roads and the free space under the bridge, the movement of pedestrians will be smoother than before,” said a statement by the civic body.

## 4,000 crore expenditure details are not available with the BMC during the Covid Period

All the 4 dept transferred the application to each other



**I**n an event in Mumbai, Municipal Commissioner Iqbal Singh Chahal claimed that 4 thousand crores were spent during the Covid period, but the shocking fact that the details of the expenditure of 4 thousand crores during the Covid period is not available with the BMC has come out from the reply given to RTI Activist Anil Galgali by BMC himself.

RTI Activist Anil Galgali applied to the Municipal Commissioner's office and asked for a copy of the report submitted regarding the expenditure of 4 thousand crores incurred during the Covid period. The commissioner's office transferred Galgali's application to the Deputy Chief Accountant (Health). Deputy Chief Accountant (Health) Lalchand Mane transferred the application to the Deputy Com-

missioner (Public Health) stating that a copy of the report was not available. Administrative Officer C. Adhari transferred the application to the Principal Accountant (Finance). Accounts Officer Rajendra Kakde said the information was not available and transferred the application again to the Deputy Chief Accountant (Health).

On one hand there are allegations of corruption and irregularities during the Covid period and the central team and the Mumbai police are investigating by filing a case and on the other hand the Municipal Commissioner himself is not giving an account of 4 thousand crores. Saying that this is a serious matter, Anil Galgali demanded that the information about the expenses during the Covid period should be published on the website.

## BMC has decided not to increase water charges for Mumbai

**T**he Brihanmumbai Municipal Corporation (BMC) has decided not to increase water charges for Mumbai, following directions issued by chief minister Eknath Shinde to municipal commissioner I S Chahal. The civic body had proposed to increase water charges by 8% per year by passing a resolution in 2012, and the general body was given full rights. The hydraulic engineer had also sent a proposal to increase charges for 2023-24, which was sent to Chahal. BMC gets its water supply from Tansa, Upper Vaitarna, Middle Vaitarna, Modak Sagar, Bhatsa, Vehar and Tulsi lakes, and around 3950 million litres of water is purified at Pise, Yewai and Bhandup complexes. The proposed hike in water charges would cover increased costs of purification, maintenance of dams, electric charges and establishment charges. But the hike in charges was opposed by the Congress and the Samajwadi Party.

“They have already been ruling by appointing administrators



and are now set to increase the water tariff by 8%. This increase is proposed from 25 paise to 6 rupees per thousand litres. We strongly oppose it,” Varsha Gaikwad, president, Mumbai Regional Congress Committee, had said. Samajwadi Party MLA Rais Shaikh had written to Chahal, urging that the proposal for hiking water tariff be sent back. He had said that since the BMC did not have any general body, it was not appropriate to sanction the proposal. Eventually, the chief minister

asked the commissioner not to raise charges as it affected all.

Soon after the decision to not hike water charges announced, Gaikwad welcomed the move. “Mumbai Congress will continue to oppose such unjust price hike for the betterment of Mumbaikars. It is expected that the corporation should not take any policy decisions on issues related to common Mumbaikars without consulting people’s representatives or taking them into confidence,” she said.

# Uttarakhand's Silkyara tunnel incident: Rescue operation continues to evacuate 41 workers trapped, 12 to 14 hours more needed

Rescue operations to evacuate 41 workers trapped in Uttarakhand's Silkyara tunnel resumed on Thursday morning after an overnight hurdle delayed the drilling by several hours. Former advisor to the prime minister's office Bhaskar Khulbe said an iron mesh had come in the path of the drilling machine creating an escape passage for the workers was removed in the morning but has delayed the rescue operation by 12 to 14 hours.

Removing the mesh in a claustrophobic environment inside the pipe was difficult and the problem was compounded by the lack of oxygen, Khulbe told reporters. "It took us six hours to remove it. But the good news is that we have cleared the hurdle which came yesterday after drilling up to 45 metres had been done," he said. Now the process of assembling to go beyond 45 metres which requires welding the pipes has been restarted. The drilling will also resume soon, he



said. It will take around 12 to 14 hours more to complete the whole operation of reaching the workers.

After that, it will take three hours to take out the workers one by one. That will be done with the help of NDRF, Khulbe said. Union Minister of State for Road Transport and Highways Gen V K Singh and National Disaster

Response Force (NDRF) Director General Atul Karwal have arrived in Silkyara for an on-the-spot review of the rescue efforts. Chief Minister Pushkar Singh Dhami is also likely to arrive soon. The drilling of 800 mm diameter steel pipes was halted on Wednesday night after the mesh came in the way of the auger ma-

chine, officials said. Till 6 pm on Wednesday, up to 44 metres of the escape pipe had been inserted into the debris, an official update said in Delhi.

Earlier, officials said the American-made auger machine had to drill through a 57-metre stretch of debris to reach the 41 workers, who were trapped

when a portion of the under-construction tunnel collapsed 11 days ago. The drilling from the Silkyara end was put on hold on Friday afternoon when the auger machine encountered a hard obstacle around the 22-metre mark, creating vibrations in the tunnel that caused safety concerns.

The drilling resumed around midnight Tuesday. As the machine drills through, six-metre sections of steel pipes, just under a metre wide, are pushed into the escape passage. Once the pipe-way reaches the other end, the trapped workers are expected to crawl out. Meanwhile, all arrangements have been made to provide immediate medical care to the 41 trapped workers after they are evacuated, officials said. A 41-bed separate ward has been readied at the Community Health Centre in Chinyalisaur for Silkyara tunnel evacuees and 41 ambulances wait outside the tunnel to rush them there as soon as they crawl out. **PTI**

## Andhra Pradesh: Around 15 students from a government school have fallen ill after mid-day meal

More than 15 students from a government primary school at Tekulapalem village in Andhra's Annamayya district were admitted to a hospital after falling ill due to the mid-day meal consumed on school premises. The students alleged that the cause of their illness was a lizard falling into the meal during the rice cooking process.

Authorities, upon receiving information about the incident, shifted the affected children to the hospital. Revenue Division Officer (RDO) Murali, upon reaching the hospital, reassured that the situation wasn't severe, with no reports of vomiting among the students. He affirmed that all children are recovering and will be discharged to their homes once fully recuperated. The Headmaster of the school claimed that no evidence of a liz-

ard was found in the vessels used for cooking and despite thorough inspections, neither the school nor authorities discovered any signs of contamination.

He further said that everyone is safe and vaccinated so there is nothing to worry about. This is not the first instance of students being reported of falling sick after consuming a mid-day meal.

Earlier in the month of October, sixteen students of a Brihanmumbai Municipal Corporation (BMC) run school allegedly fell ill after consuming a mid-day meal in Mumbai's Anik village. "The 16 students were brought to the hospital after they complained of vomiting and abdominal pain following the mid-day meal at school. They have been admitted to the paediatric ward," said Sunil Phakle, Dean of Jan Shatabdi Hospital, Chembur. **ANI**

## Jammu and Kashmir: One terrorist killed in the ongoing encounter at Rajouri district

One terrorist killed in the ongoing encounter between terrorists and joint forces of the Army and J-K Police in the Bajimaal area of Dharmsal in the Rajouri district entered its second day on Thursday. The killed terrorists have been identified as Quari, a Pakistani national and a hardcore terrorist. He has been trained on the Pakistani and Afghan fronts, as per the PRO Defence Jammu.

According to the PRO Defence Jammu, the killed terrorist is a highly-ranked terrorist leader of Lashkar-e-Taiba. He has been ac-



tive in Rajouri-Poonch along with his group for the past year. He is also believed to be the mastermind of the Dangri and Kandi attacks. He was sent to revive terrorism in the region. He is an expert in IEDs, operating and hiding from

caves, and a trained sniper, the RO Defence Jammu added. This is the second day of the encounter between terrorists and joint forces of the Army and J-K Police in the Bajimaal area of Dharmsal in the Rajouri district. **ANI**

## Plea for review of same-sex marriages verdict mentioned in SC

A petition seeking review of the October 17 verdict refusing to accord legal recognition to same-sex marriages was on Thursday mentioned before the Supreme Court for an open court hearing. A bench led by Chief Jus-

tice D Y Chandrachud took note of the submissions of senior advocate Mukul Rohatgi, appearing for one of the petitioners, that the review plea needed to be heard in open court to redress the grievances of those seeking validation

of same-sex marriages. The bench also comprised Justices J B Pardiwala and Manoj Misra. "I have not examined the (review) petition. Let me circulate it (among judges of that constitution bench)," the CJI said. **PTI**

# Turkish journalist Uze Bulut said, "Jamaat-e-Islami is responsible for militancy and genocide, it not just a threat to Bangladesh but countries aswell"

Jamaat-e-Islami, the Bangladesh-based political party with radical religious ideology and responsible for militancy and genocide, is not just a threat to Bangladesh but also to other countries including in the West, Turkish journalist Uze Bulut has said in his research article for think tank Gatestone Institute. This comes while the Appellate Division of the Supreme Court of Bangladesh is upholding the order to cancel the registration of Jamaat-e-Islami as a political party.

Notably, Turkey has been a staunch supporter for Jamaat-e-Islami of Bangladesh. When top Jamaat leaders were being sentenced to death one after another in Bangladesh in the trial of war crimes committed in 1971, the Turkish government not only protested strongly, but at one point



also withdrew their ambassador from Dhaka, Bangladesh-based Bangla Tribune reported. However, despite being a journalist from that Turkey, Uze Bulut has taken a completely different po-

sition in the context of Jamaat-e-Islami in Bangladesh.

Firstly, Bulut said that the the 1972 constitution of Bangladesh provided the legal basis for a "secular government" in

the country. This secularism is a fundamental principle of the governance of the state of Bangladesh and that is why the use of religion in politics is prohibited there. But, the author alleges that

Jamaat-e-Islami in Bangladesh is doing exactly that - "they are using Islam to do politics". Secondly, he also claimed that the ideology of Jamaat-e-Islami in Bangladesh and Muslim Brotherhood in Egypt is "exactly the same".

Both parties talk about establishing Islamic states in their respective countries, where strict Sharia law will be the supreme law of the land, not their own constitutions. The rights of religious minorities and women are also severely curtailed there. Thirdly, just like the Muslim Brotherhood, Jamaat-e-Islami of Bangladesh has its ideological origin from the thought and philosophy of Islamic theoretical leader Abul Ala Al Maududi whose views have always been deemed controversial. ANI

## UK: Foreign Secretary David Cameron welcomes temporary ceasefire, says "crucial step" over Gaza strip

British Foreign Secretary David Cameron has welcomed the hostage deal between Israel and Hamas -- which paves for the release of first group of 50 Israeli hostages -- and urged all parties to ensure that the agreement is delivered in full. Calling it a "crucial step", the former Prime Minister said that the pause provides an important opportunity to address the humanitarian crisis in Gaza by making greater volumes of food, fuel and other life-saving aid reach the conflict-hit region.

Cameron chaired a meeting of Arab and Islamic leaders in

London on the situation in Israel and Gaza. "This agreement is a crucial step towards providing relief to the families of the hostages and addressing the humanitarian crisis in Gaza," Cameron said in a statement. "I urge all parties to ensure the agreement is delivered in full. Of course, we want to see all hostages released immediately and families affected by the horrors of the October 7th terror attack reunited," he added.

He further said that UK has doubled its commitment to Palestinians and will continue to work to secure the release of all hostages, restoration of security

and reaching a "long-term political solution" to the conflict. "This pause provides an important opportunity to ensure much greater volumes of food, fuel and other life-saving aid can reach Gaza on a sustained basis. We have already doubled our aid commitment to Palestinians this year and will work closely with the UN to ensure it reaches those who need it," the statement read. It added, "The UK will continue to work with all partners in the region to secure the release of all hostages, restore security and reach a long-term political solution which enables both Israelis and Palestinians to live in peace." ANI

## Nepal goes through 4.5 magnitude of earthquake

An earthquake of magnitude 4.5 struck Nepal in the early hours of Thursday, according to the Nepal Seismological Centre With an epicentre at Chitlang of Makwanpur district in the Himalayan nation, the quake was



recorded at around 1:20 am (local time), however, no casualties were reported. Nepal is still trying to overcome the loss of lives and property that took place due to a 6.4 magnitude earthquake that jolted the Himalayan nation on November 3. ANI

## Nepal: Clashes erupted between police and pro-monarchy protestors to support businessman Durga Prasai



A clash erupted between Nepal police and pro-monarchy protestors on Thursday, after which the police had to use water cannons and teargas to disperse supporters of businessman Durga Prasai, Kathmandu Post reported. Dozens of rounds of tear gas was fired to control the situation.

The police said that the crowd attempted to cross the area fixed for the demonstration. Notably, Prasai is considered a 'controversial' businessman who is has been organising people under his 'Nation, Nationality, Religion-Culture and Citizen Rescue Campaign.' He has threatened to topple the current Nepal government

and "reinstate the monarchy and Hindu Kingdom," Kathmandu Post reported.

The Police have accused Prasai of inciting the crowd. Protesters allegedly pelted stones targeting security personnel as soon as Prasai left the scene today after addressing the protest at Balkhu. Earlier in the day, CPN-UML's youth wing members and Prasai's supporters clashed during a protest at Balkhu in Kathmandu.

Prasai's supporters pelted stones at UML cadres after the latter reached Balkhu during a motorcycle rally. Vehicles used by demonstrators and those parked on the roadside, were also damaged by Prasai supporters. ANI



Bringing opposition into an organized form they even made one 'Patriotic society' in Edinburgh in 1775, the mission of which was to boycott Indian goods through arousing swadeshi spirit among the local people.
